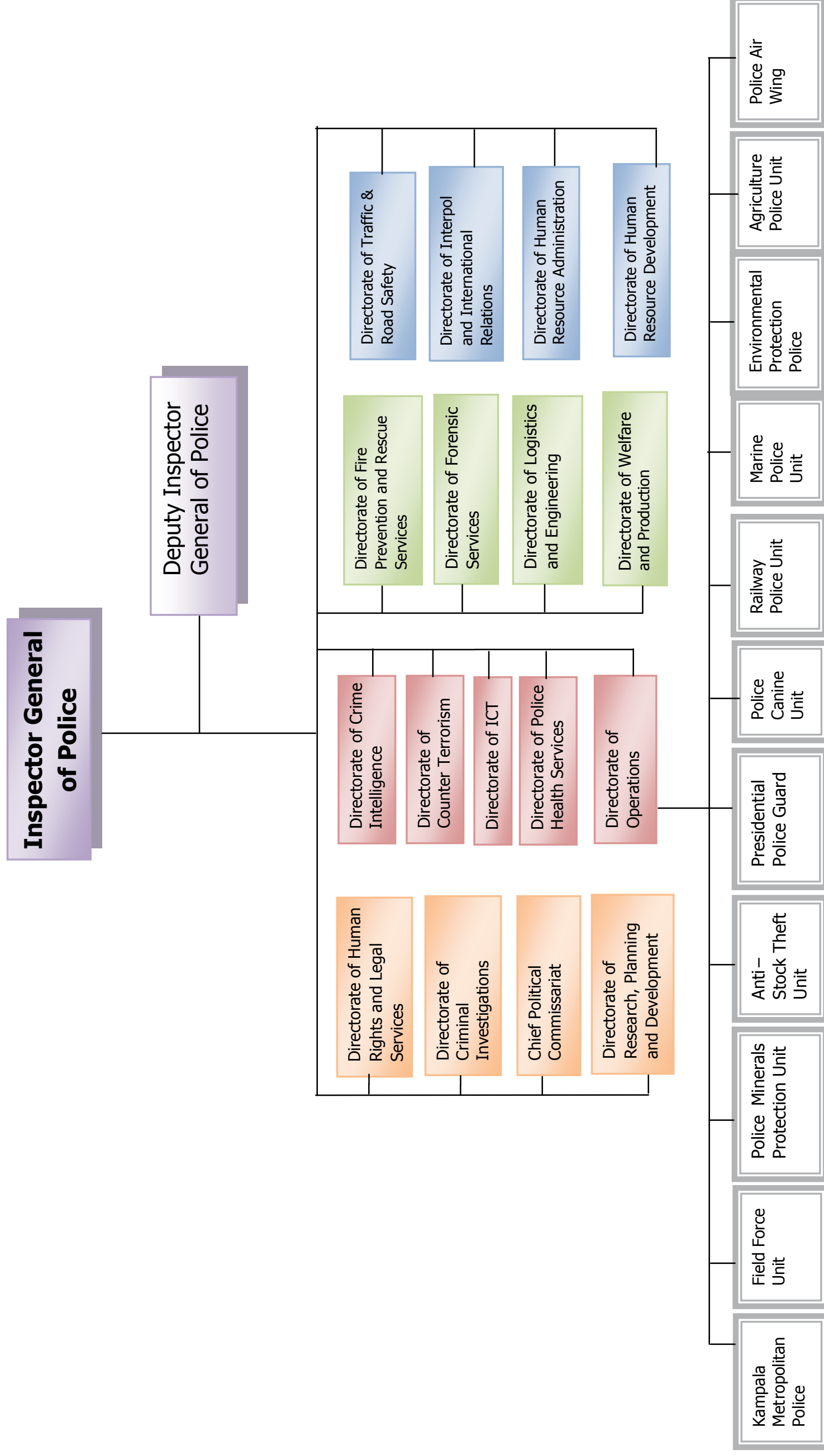

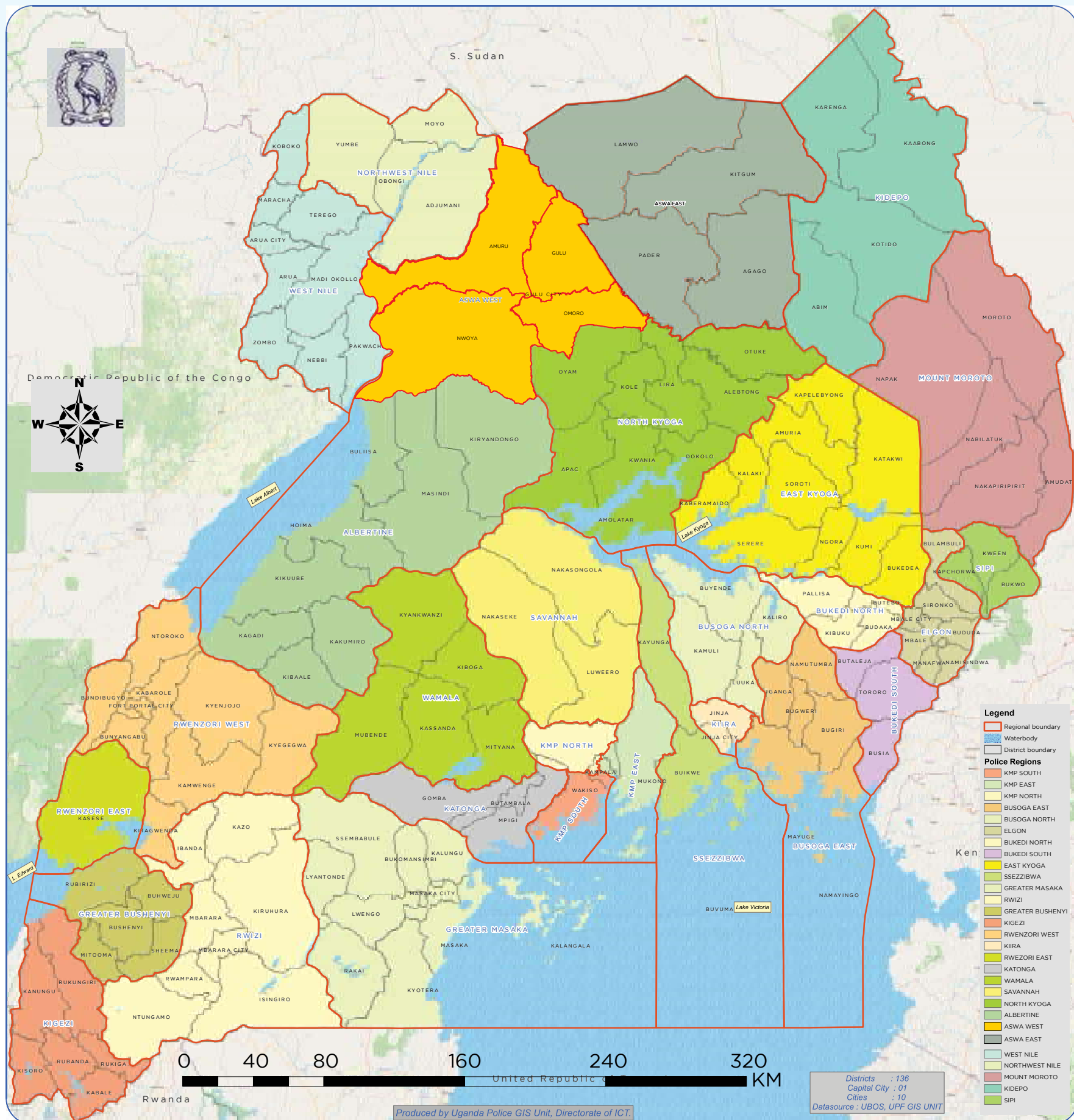

FOREWORD

This being my maiden Annual Crime Report as IGP, allow me to first extend my sincere gratitude to H.E. The President of the Republic of Uganda Gen. (Rtd) Yoweri Kaguta Museveni Tibuhabwe for entrusting me with the responsibility of commanding the Uganda Police Force.

We note that there was a **4.1%** decrease in the number of crimes reported to Police from **228,074** cases in 2023 to **218,715** cases in 2024. I take this opportunity to express my sincere gratitude to our people who were able to lodge in their complaints at various police stations in 2024. It is these reported complaints that enabled us to compile this Annual Crime Report and be able to assess progress in fulfilling our mandate as enshrined in the Constitution of the Republic of Uganda.

Apart from my overall role to give strategic guidance and direction to the Police Force to ensure law and order, one of my tasks as IGP has been to implement the pending directive by H.E. The President of the Republic of Uganda to reorganise the Force from being a City/Town based Force, to a Uganda Police Force as envisaged in the Constitution of the Republic of Uganda. In so doing, we have started implementing the Sub-county Policing Model where we shall have **18** Police officers at each sub-county. This is aimed at decentralising the Police services closer to our people, enhancing crime prevention in the communities and enabling quick response to crimes.

In the above reorganization of the force, the priority is on improving the mindset and operational readiness of the personnel to perform their duties including their welfare, housing, health and capacity building to ensure professionalism. This coupled with adequate anti-crime infrastructure, will position the force to ensure law and order which will enable strategic security, prosperity and socio-economic transformation in the Country.



I wish to commend the good coordination we have built with other stakeholders including the Office of the Director of Public Prosecutions, the Judiciary, JLOS, Local Councils, General public, sister security agencies like UPDF, Prisons, ISO, ESO and both local and international organizations. This coordination, cooperation and collaboration explains the achievements we continue to register in dealing with various forms of crime to ensure law and order is maintained.

It is therefore our resolve, that in 2025, my leadership will continue to focus on the above priorities including expanding on the existing anti-crime infrastructure to ensure a professional and people-centered Police for a Safe and Secure Society.

As I conclude, I wish to thank the political leadership led by H.E. The President, our line minister and his team in the Police Authority for the leadership and support that is enabling us to focus on the priorities we have embarked on as the Uganda Police Force.

Let me take this opportunity therefore to officially launch this Annual Crime Report 2024.

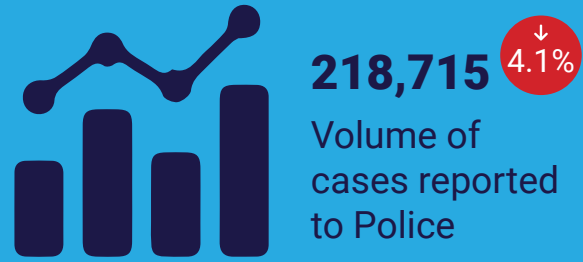

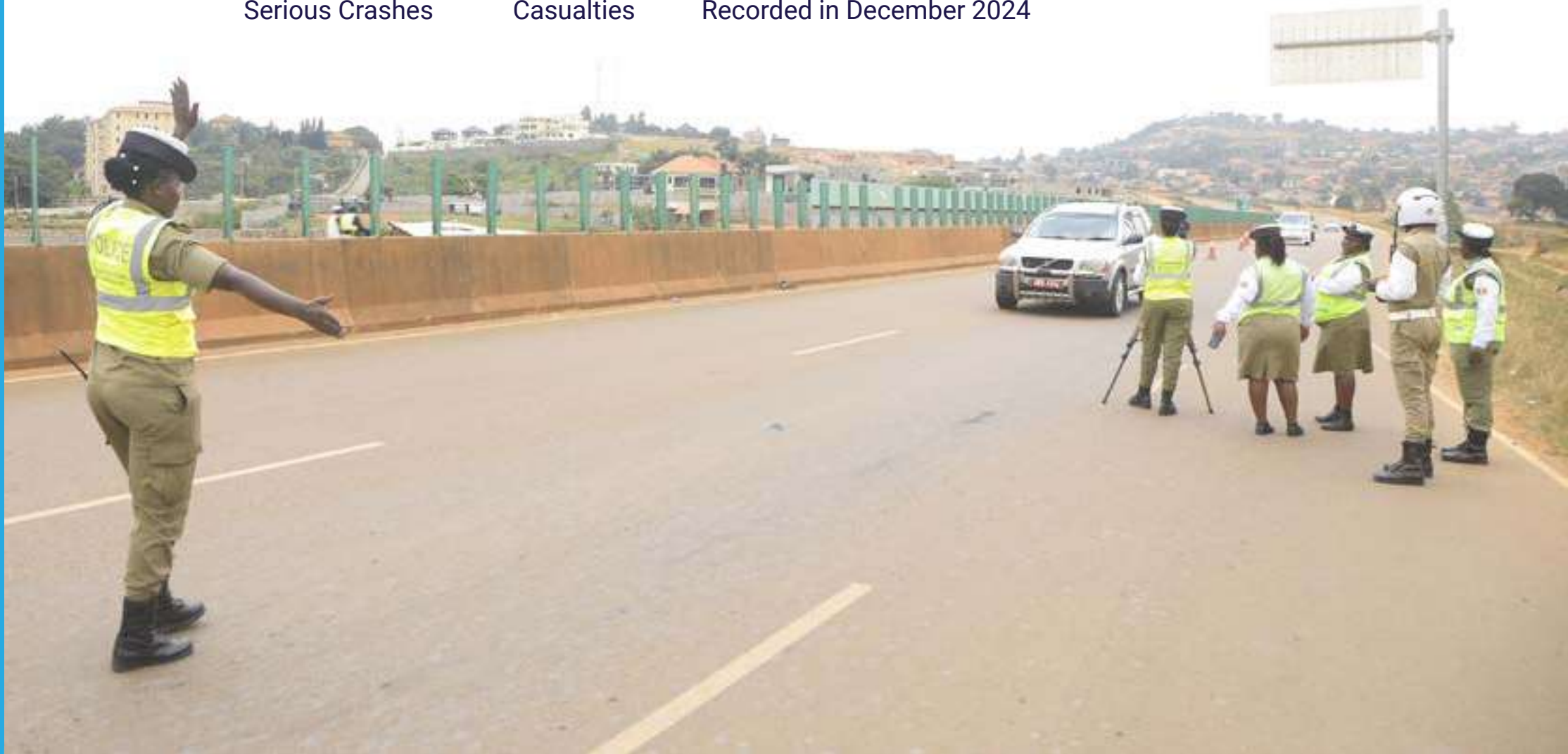

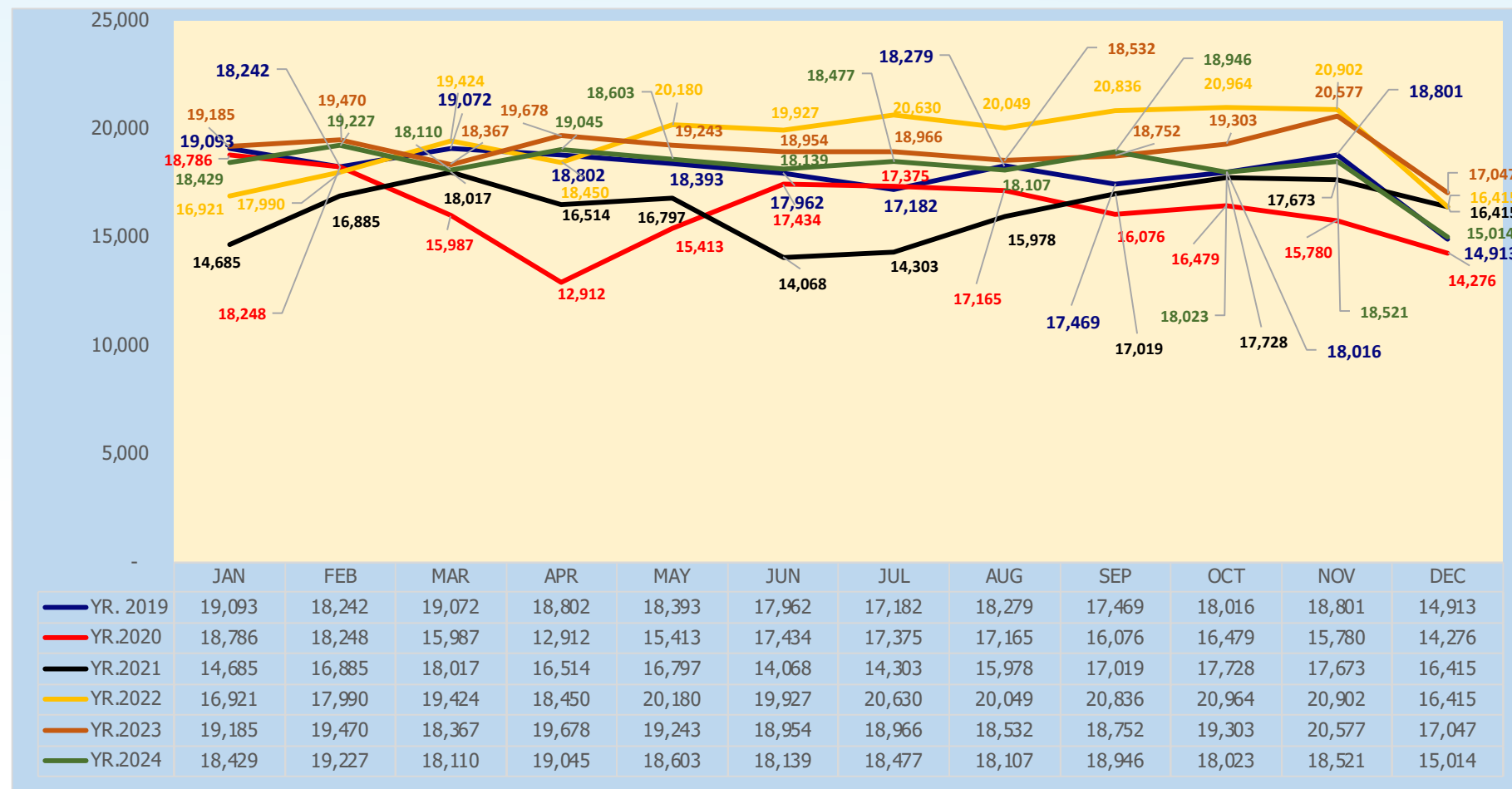

Out of the total cases reported to the Police countrywide, **81,750** cases were taken to Court, **46,302** cases were not proceeded with, while **90,663** cases are still under inquiry. Out of the cases taken to Court, **26,328** cases secured convictions, **1,510** cases were acquitted, **10,333** cases were dismissed while **43,579** cases are still pending in Court.

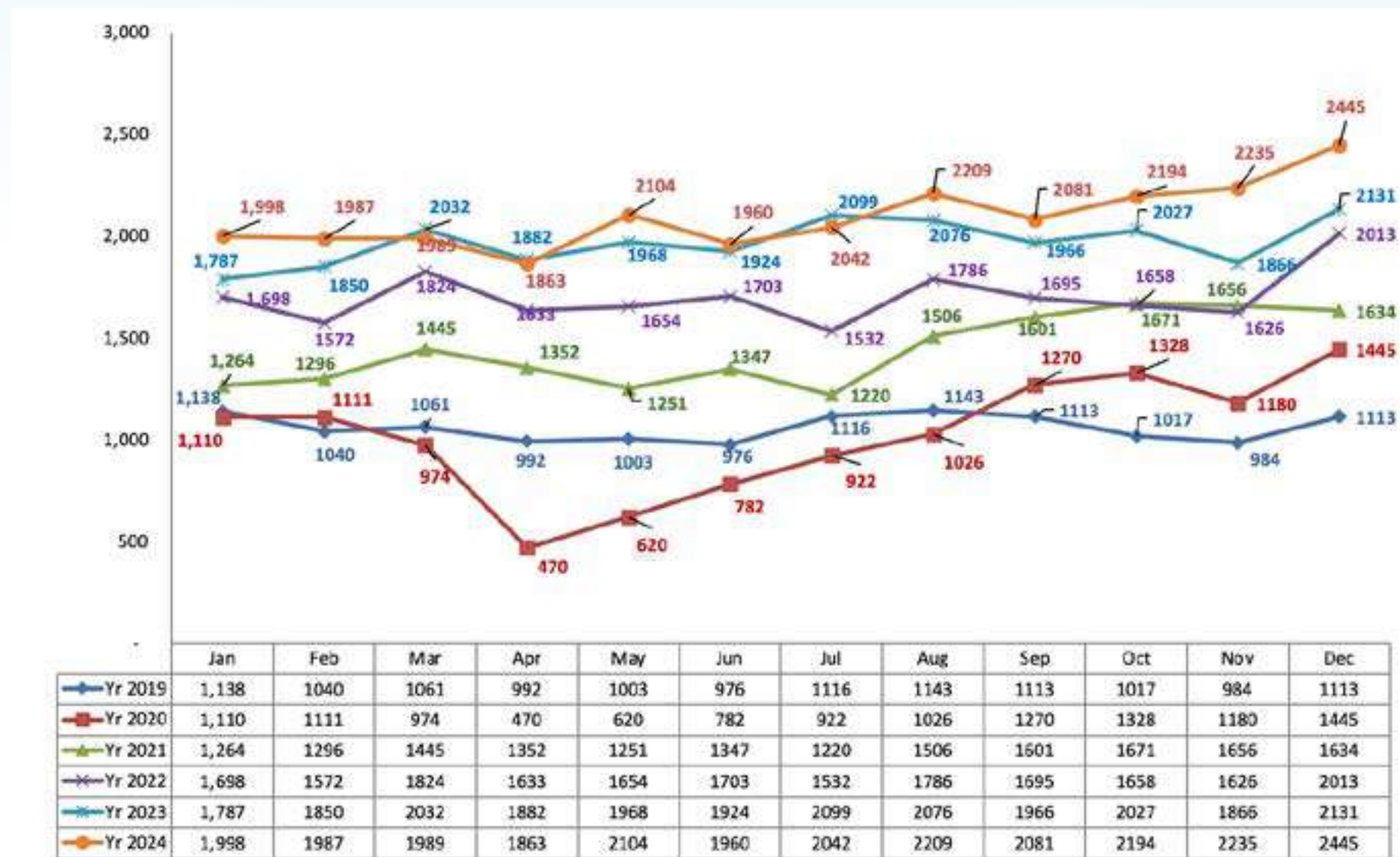

Traffic and Road Safety

There was a **19.2%** decrease in common offences registered by the Directorate of Traffic and Road Safety countrywide from **528,025** cases registered in 2023 to **426,432** cases in 2024.

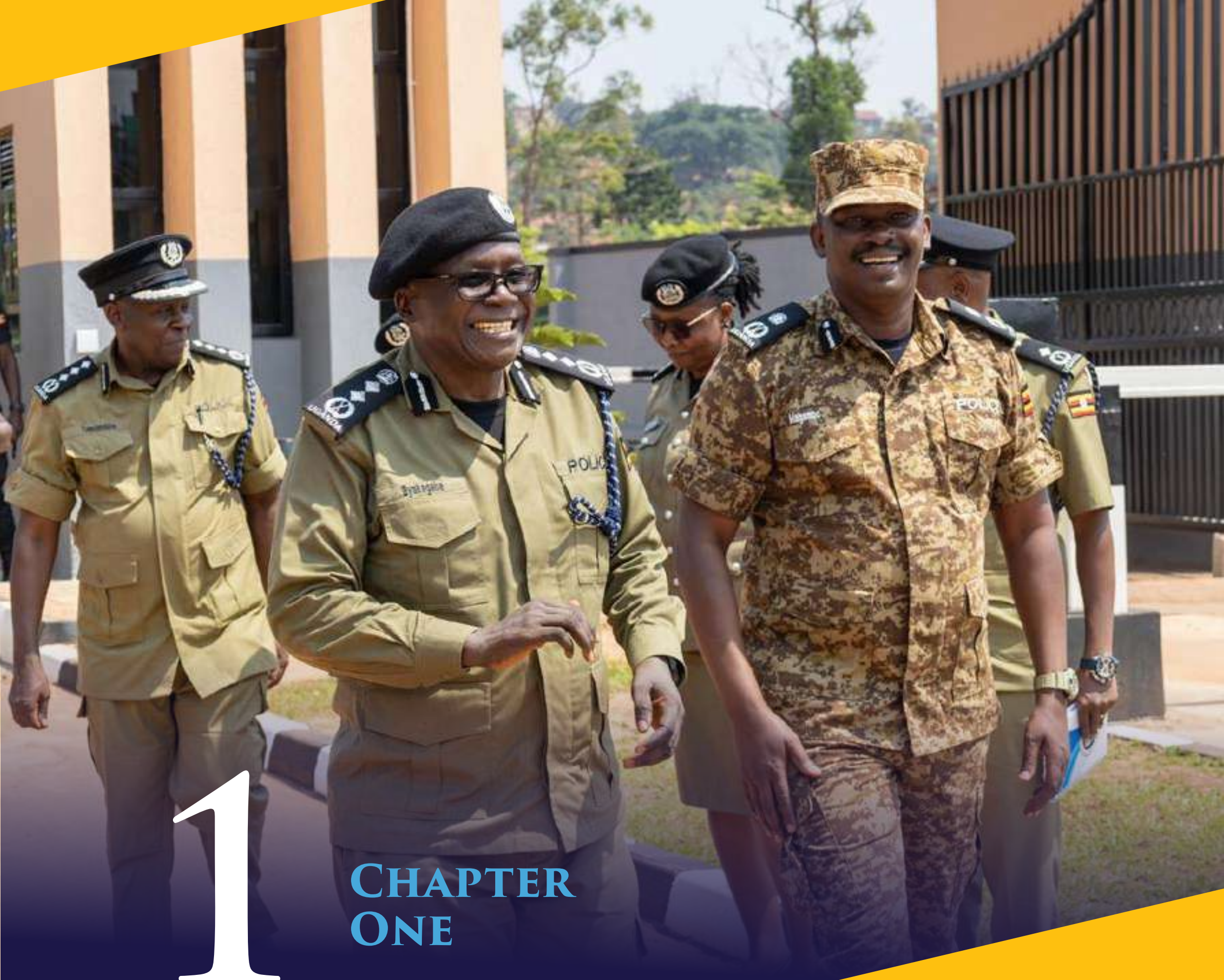
Road traffic crashes increased in 2024 as compared to 2023 by **6.4%** from, **23,608** in 2023 to **25,107** in 2024. Out of the total crashes reported to Police, **4,434** were fatal, **13,134** were serious and **7,539** were minor. The number of reported fatal crashes also increased by **6.1%**, from **4,179** in 2023 to **4,434** in 2024. The number of serious crashes increased by **5.2%**, from **12,487** in 2023 to **13,134** in 2024. The number of minor crashes increased by **8.6%** from **6,942** in 2023 to **7,539** in 2024.

Fire and Rescue Services

In 2024, there was a **13.8%** increase in the number of fires reported from **1,104** in 2023 to **1,280** in 2024. Out of the cases reported to the Directorate, **1,150** were handled, **120** were handled before arrival and **10** were false calls. **750** fires making **67%** were reported between 0600hrs and 1200hrs and **530** fires making **33%** were reported between 0001hrs to 0600hrs in the morning in 2024. Majority of fires were registered in residential buildings followed by Makeshift structures with a total number of **300** and **250** respectively. The Directorate registered a **9%** increase in school fires from **50** cases in 2023 to **55** cases in 2024.

CHAPTER ONE

1.0 CRIME ANALYSIS

1.1 Introduction

In 2024, there was a **4.1%** decrease in the volume of crimes reported to Police from **228,074** cases registered in 2023 to **218,715** cases. Out of the total cases reported to the Police countrywide, **81,750** cases were taken to Court, **46,302** cases were not proceeded with, while **90,663** cases are still under inquiry. Out of the cases taken to Court, **26,328** cases secured convictions, **1,510** cases were acquitted, **10,333** cases were dismissed while **43,579** cases are still pending in Court.

Arising out of the total cases reported to Police, **88,985** suspects (i.e., **81,878** Male Adults, **4,839** Female Adults, **2,073** Male Juveniles and **195** Female Juveniles) were arrested and charged to Court. Out of whom, **12,148** (**11,050** male Adult, **640** Female Adult, **404** Male Juveniles, **54** Female Juveniles) were convicted and sentenced to serve in various prisons countrywide for offences they committed, while **76,364** suspects were still awaiting trial by Courts of Law.

For 2024, a grand total of **220,594** persons (**132,714** Male Adults, **59,331** Female Adults, **7,969** Male Juveniles, **20,580** Female Juveniles) were victims of crimes.

1.3 Crime Distribution

1.3.1 Monthly Crime Distribution

On average, a total of **18,226** cases were reported to Police per month. The month of February 2024 registered the highest number of cases countrywide (**19,227** cases), followed by April with **19,045** cases and September with **18,946** cases as illustrated in the figure below.

1.3.2 Cases Submitted to RSA/DPP

Out of the cases reported to Police, **119,939** cases were submitted to RSA/DPP for perusal and legal advice. The month of September registered the highest number of cases submitted to RSA/DPP (**10,547** cases) followed by July with **10,340** cases and May with **10,318** cases as shown in the figure below.

1.4 Crime Trend

1.4.1 Annual Crime Trend

There was a general downward trend in the crimes registered in the country from 2017 to 2024. This was due to deliberate efforts to tackle the vice by the Uganda Police Force (UPF) in conjunction with other sister security agencies, as shown in the figure below.

2024 registered a decrease in crimes by **4.1%** compared to 2023. This is lower than crime reported in the pre-covid period (2018 and 2017) which depicted a reducing trend.

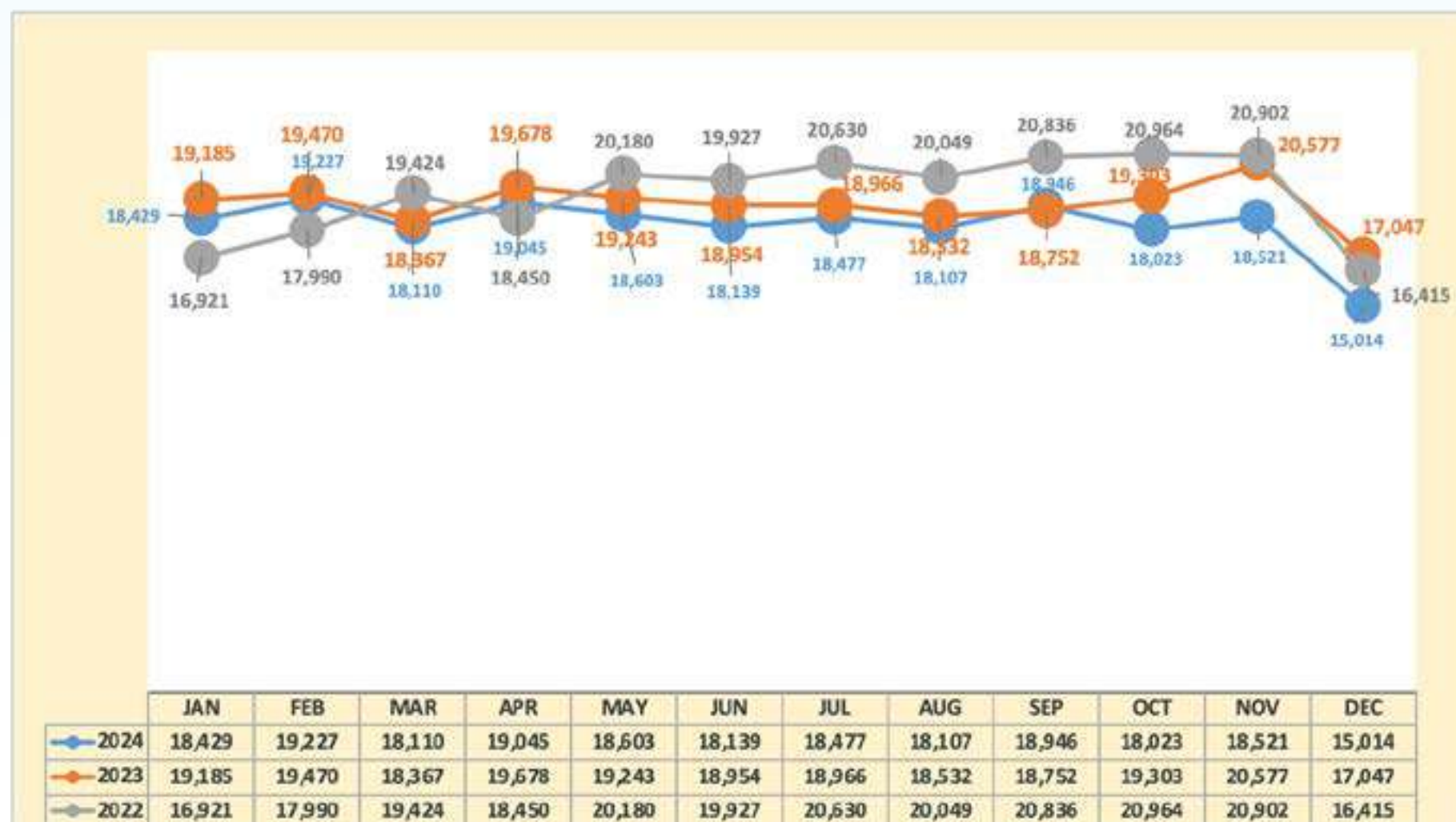

Figure 9: Monthly Crime Trend (2022 - 2024)



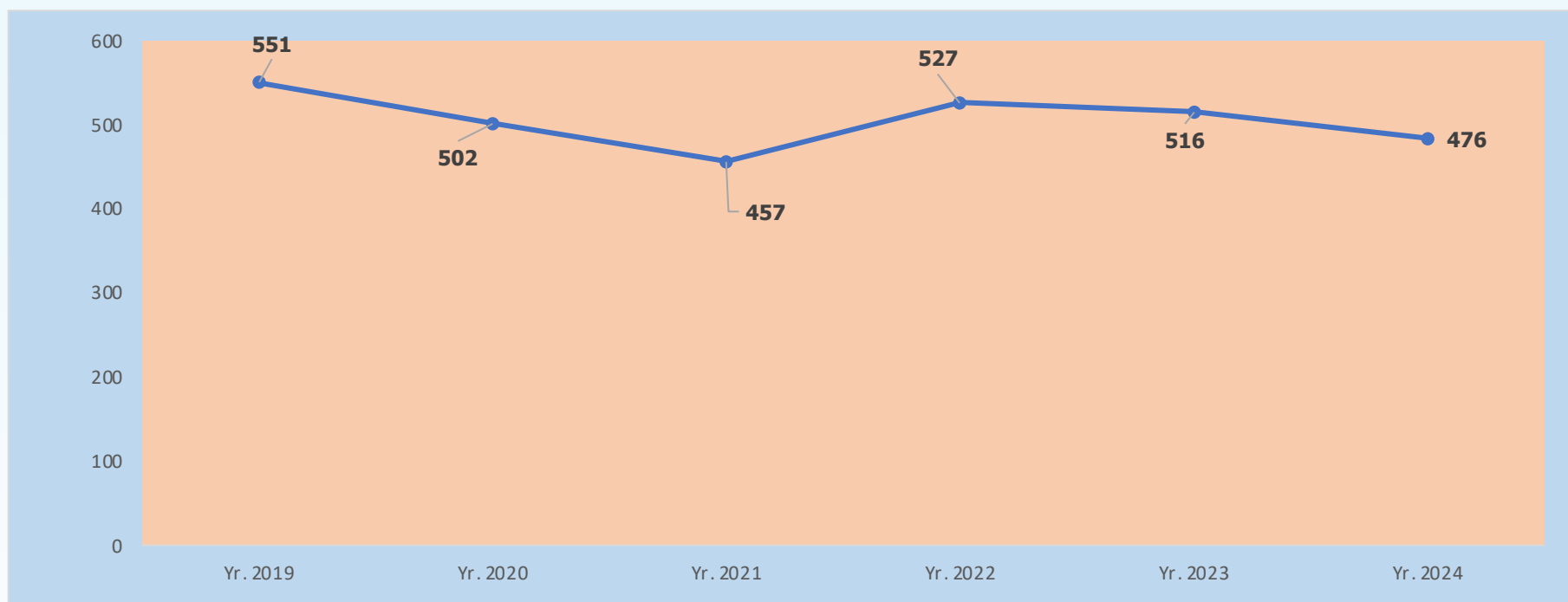
1.4.4 Crime Rate

1.5 Crime Analysis

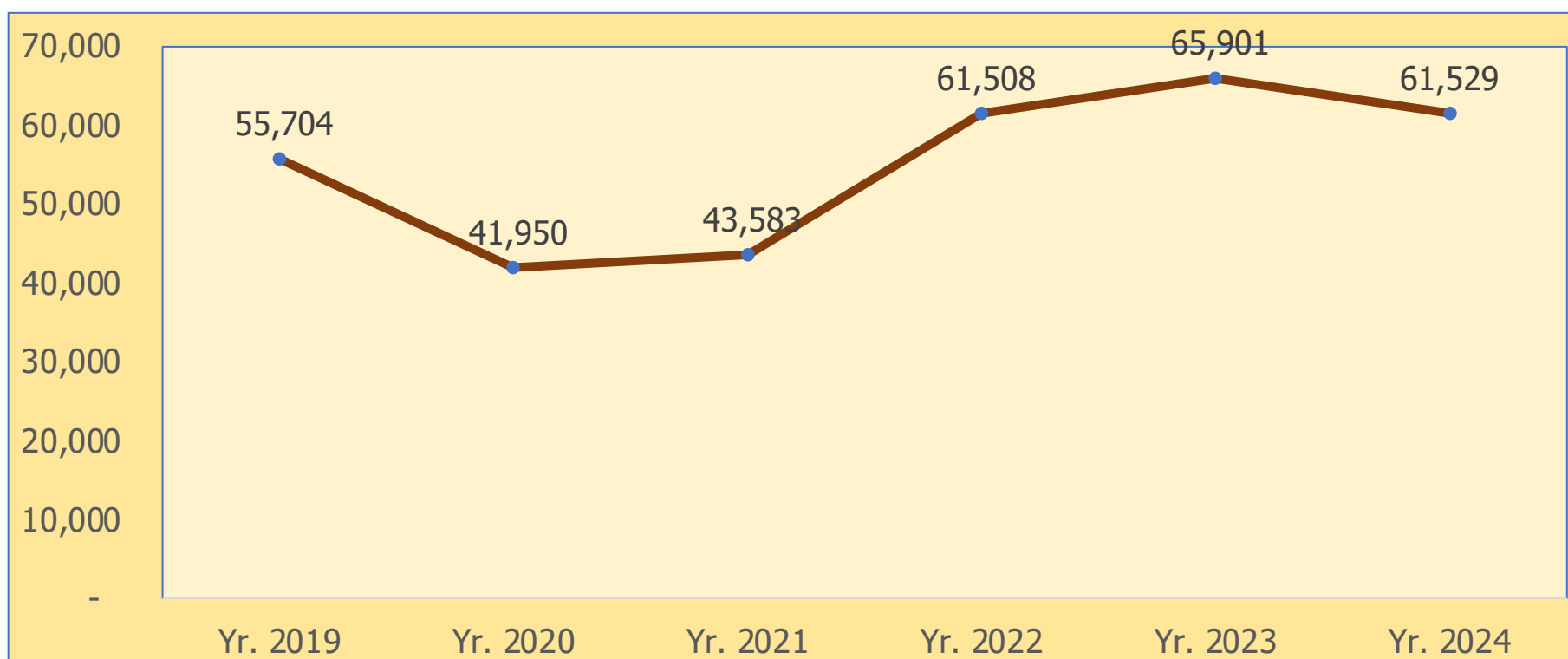
1.5.1 Thefts

By the end of 2024, **61,529** cases registered at Police (representing **28%** of the total reported cases) were due to Theft as compared to **65,901** cases reported in 2023, giving a decrease of **6.6%** Theft cases registered country wide. Theft cases were mainly motivated by economic gains.

Comparison of Theft Cases from 2019 to 2024

There was a general increase in cases of Theft from **55,704** cases reported to Police in 2019 to **62,252** cases registered in 2024 as shown in the figure below.

By the end of 2024, out of the total Theft cases reported to Police, **29,795** cases were taken to Court, **9,809** cases were not proceeded with, while **21,925** cases are still under inquiry. **39,820** cases were submitted to DPP/RSA for perusal and legal guidance. Out of the **29,795** cases taken to Court, **11,172** cases secured convictions, **456** cases were acquitted, **4,081** cases were dismissed while **14,086** cases are still pending in Court.

Resulting out of the total Theft cases reported to Police in the whole year, **29,032** suspects (i.e. **26,802** Male Adults, **1,462** Female Adults, **692** Male Juveniles and **76** Female Juveniles) were arrested and charged to Court. Out of whom, **4,270** (**3,928** Male Adults, **156** Female Adults, **173** Male Juveniles and **13** Female Juveniles) were convicted and sentenced to serve in different prisons countrywide for offences they committed while **24,465** suspects were still awaiting trial. 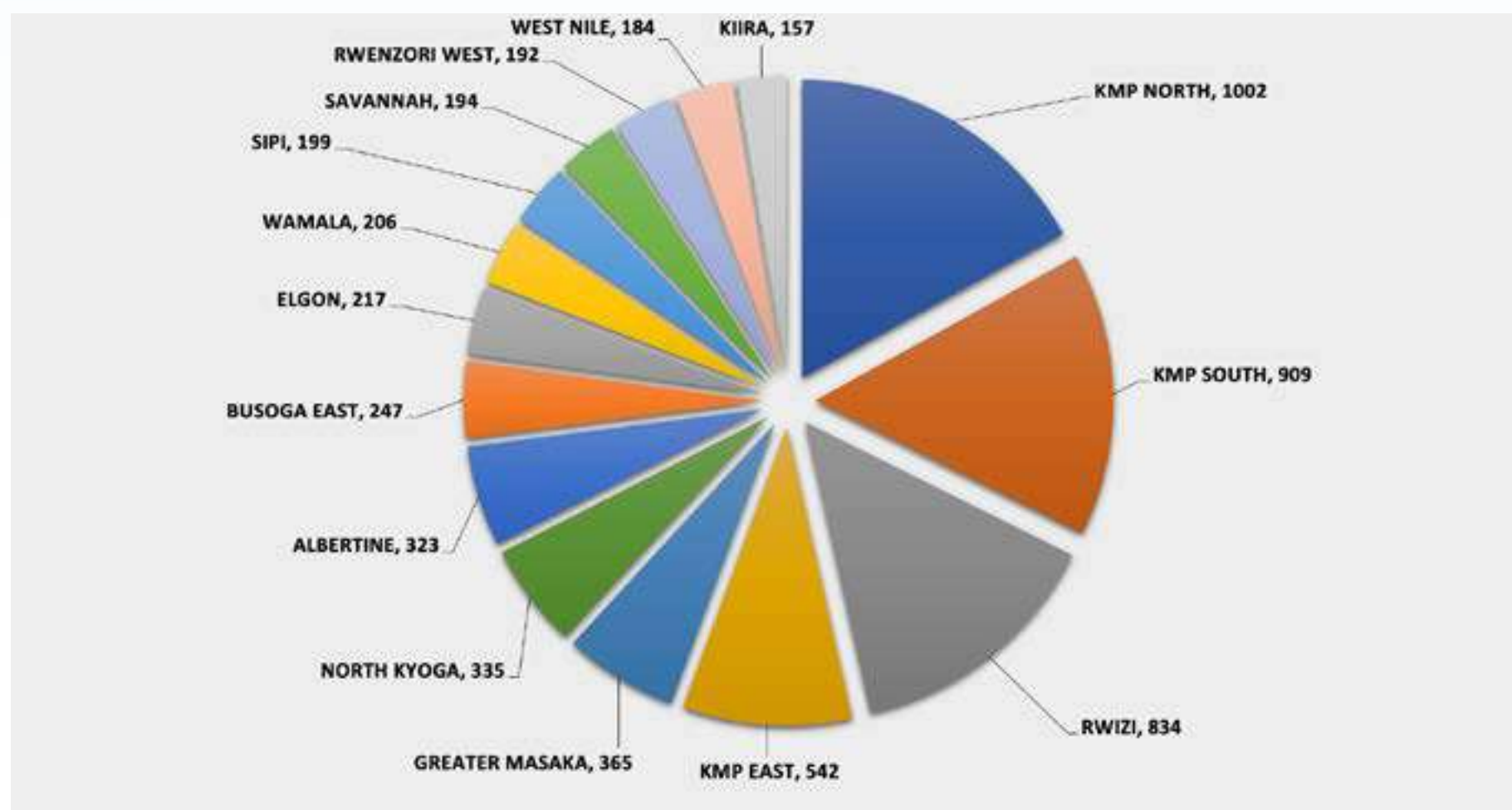
1.5.1.1 Theft of Mobile phones

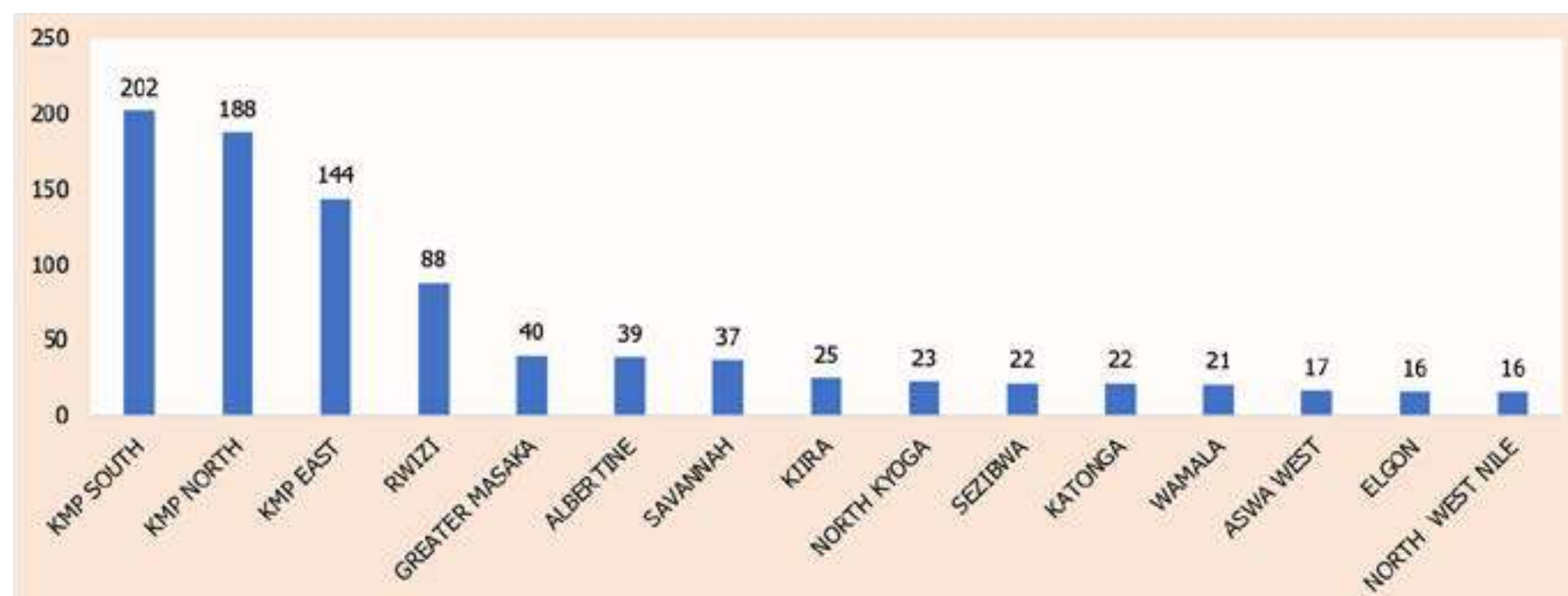
1.5.1.2 Theft of Motor Vehicles

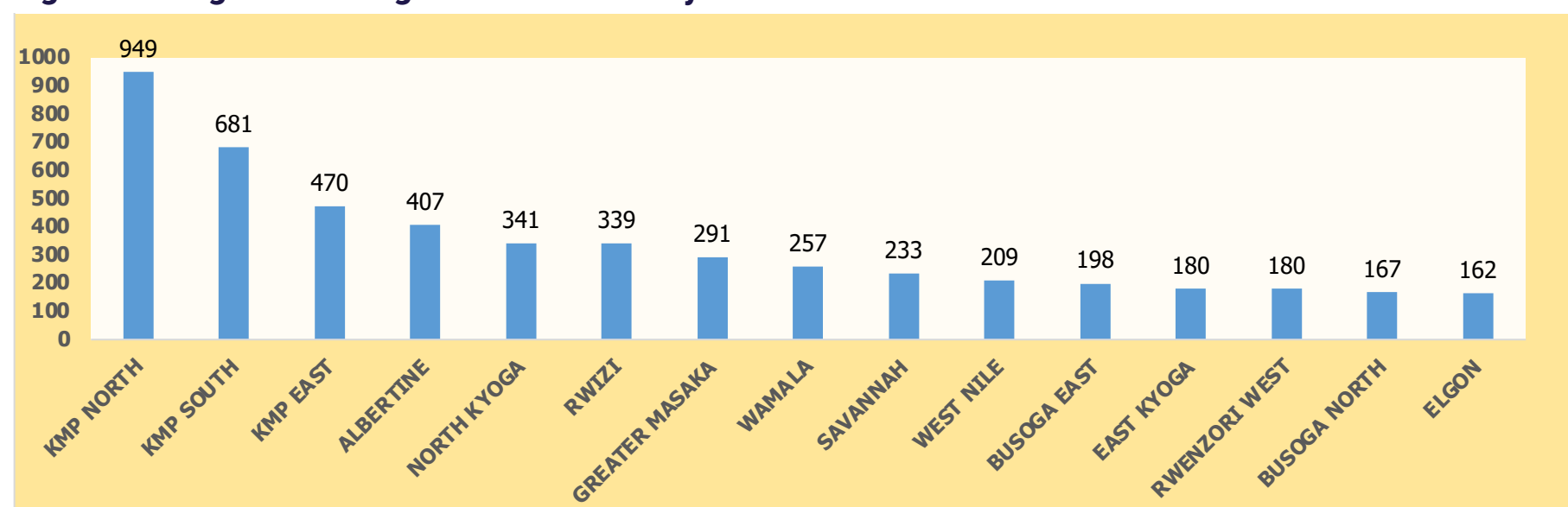

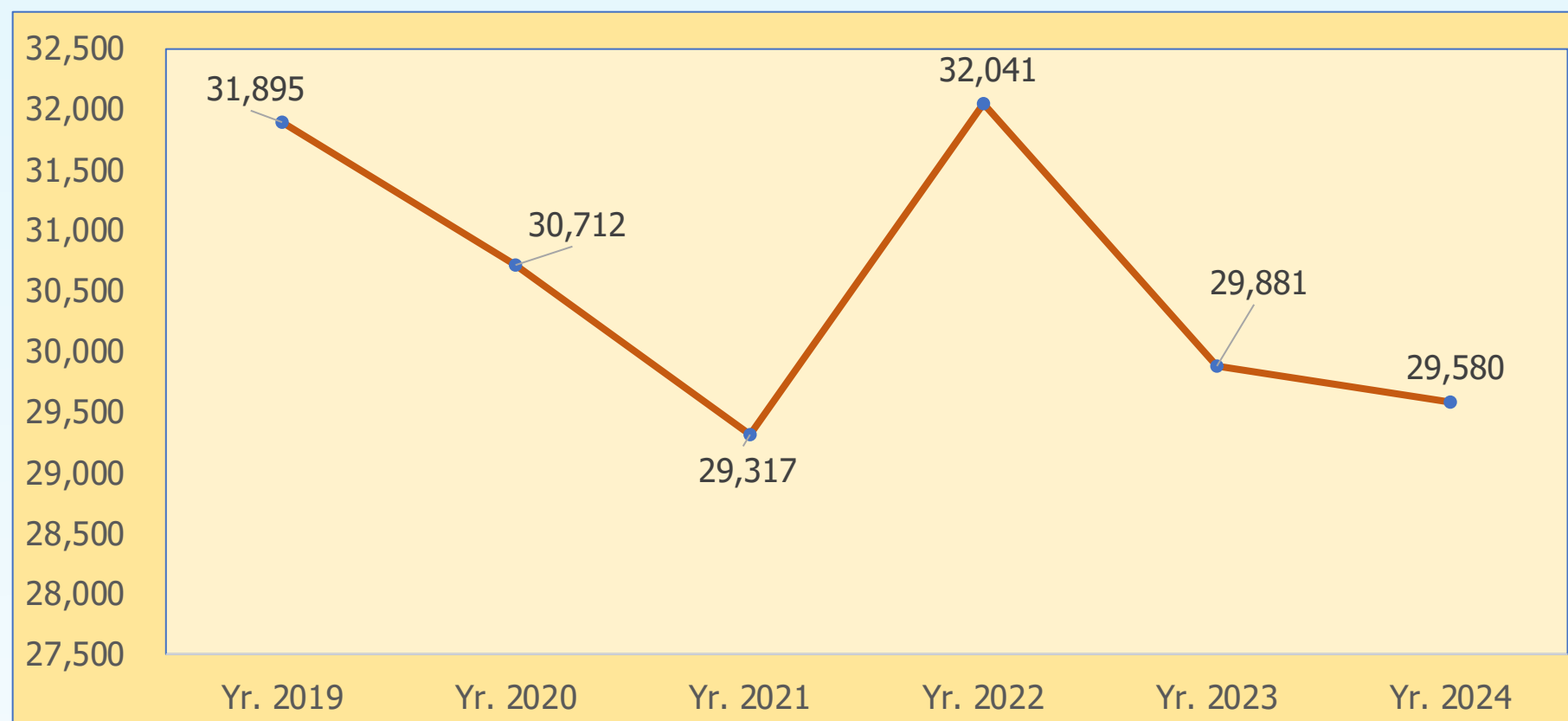

1.5.2 Assault

By the end of 2024 **29,580** cases (representing a **13.5%** of the total reported cases in the year) were due to Assault as compared to **29,881** cases reported in 2023 giving **1%** decrease of Assault cases registered countrywide.

There was a decrease in cases of Assault registered from **29,881** cases in 2023 to **29,580** cases in 2024 as shown in the figure below.

By the end of 2024, out of the total cases of Assault (**29,580** cases) reported to Police, **8,558** cases were taken to Court, **7,108** cases were not proceeded with, while **13,914** cases are still under inquiry. **13,238** cases were submitted to DPP/RSA for perusal and legal guidance. Out of the **8,558** cases taken to Court, **2,863** cases secured convictions, **219** cases were acquitted, **1,130** cases were dismissed while **4,346** cases are still pending in Court.

Resulting out of the total Assault cases reported to Police in the year, **7,861** suspects (i.e. **6,866** Male Adults, **862** Female Adults, **119** Male Juveniles and **14** Female Juveniles) were arrested and charged to Court. Out of whom **963** suspects (**817** Male Adults, **124** Female Adults, **19** Male Juveniles, **03** Female Juveniles) were convicted and sentenced to serve in various prisons countrywide for the offence they committed while **6,743** suspects were still awaiting trial.

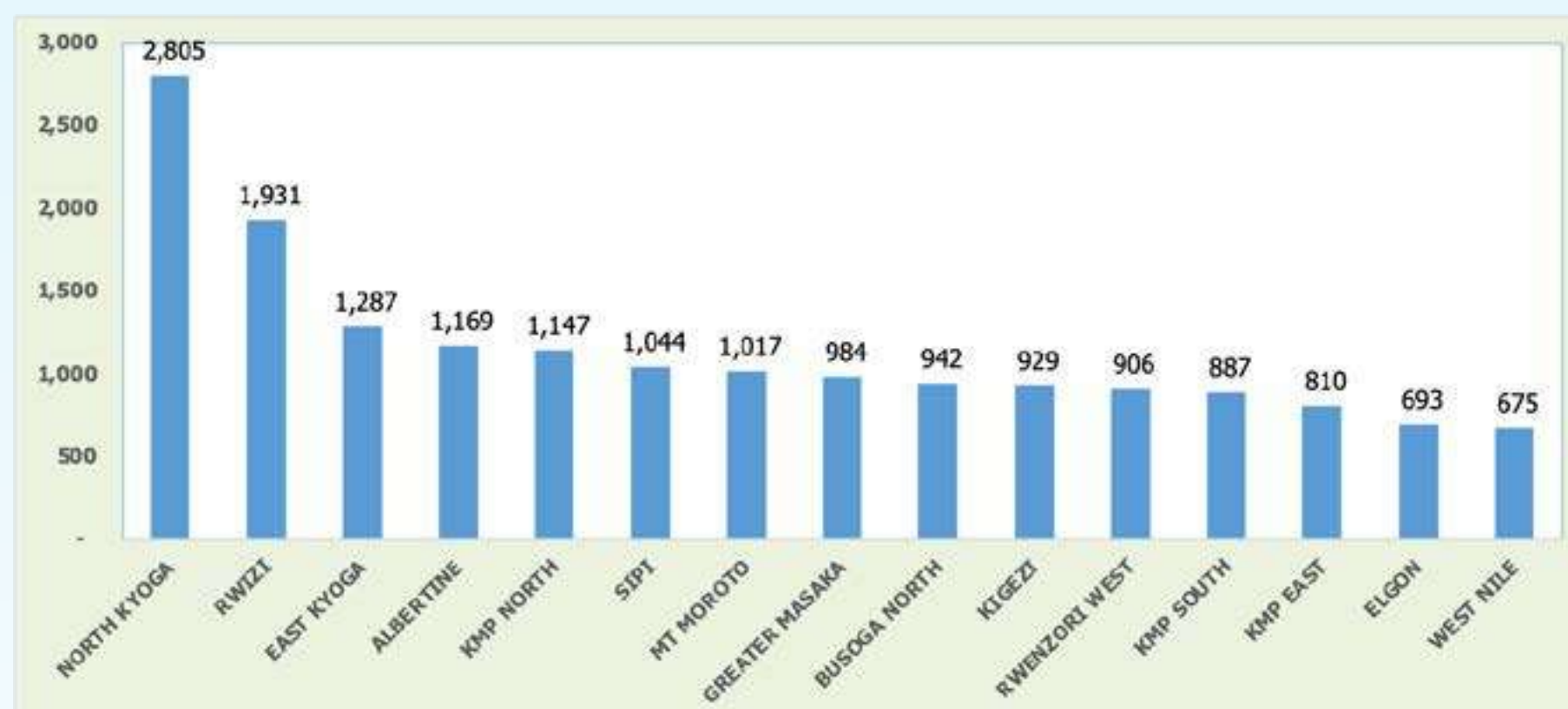

1.5.2.1 Common Assault

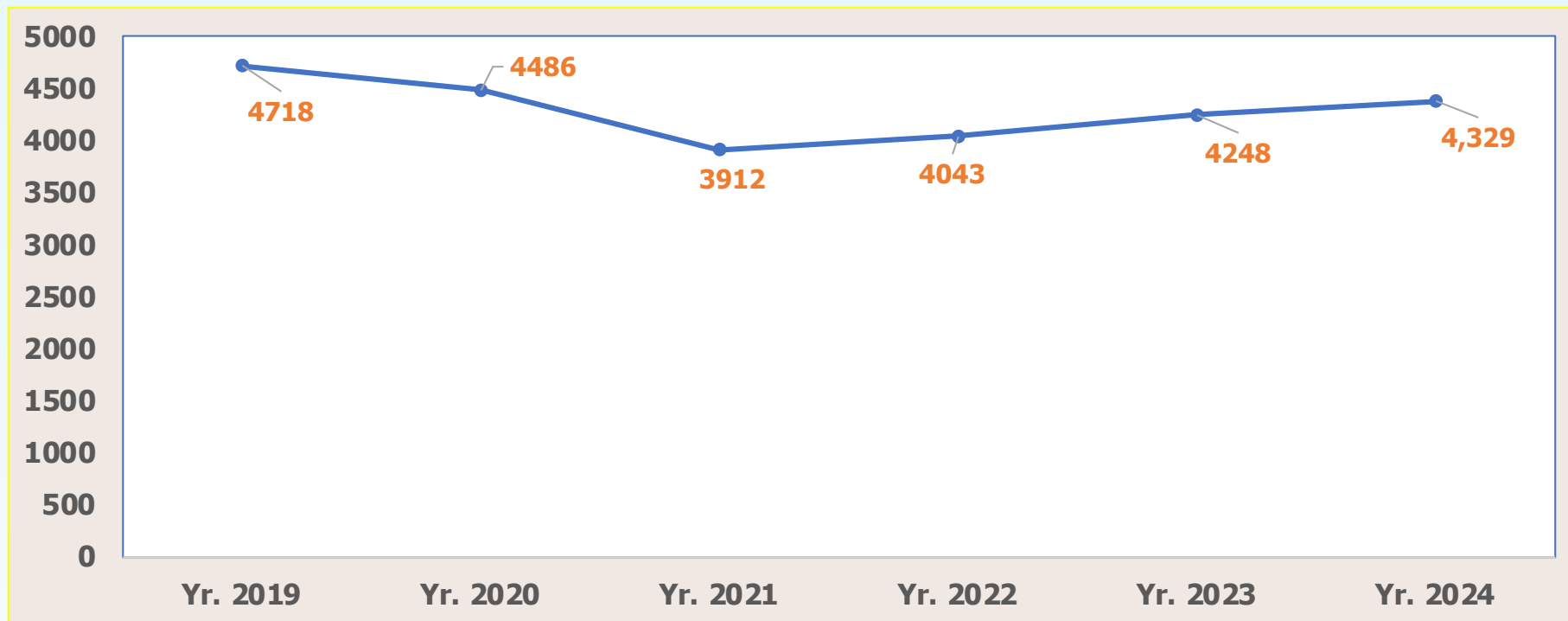
1.5.3 Homicides

A total of **4,329** cases (representing a **1.9%** of the total reported cases in the year) reported to Police by the end of 2024 were due to homicides, compared to **4,248** cases reported in 2023, giving a **1.9%** increase in Homicide cases registered countrywide. By the end of 2024, out of the total Homicides reported to Police **1,274** cases were taken to Court, **333** cases were not proceeded with while **2,722** cases are still under inquiry. A total of **4,411** persons were victims of Homicide, out of whom, **3,494** were Male Adults, **594** were Female Adults, **209** were Male Juveniles while **114** were Female Juveniles.

Figure 19: Trend of Homicides: 2019 – 2024

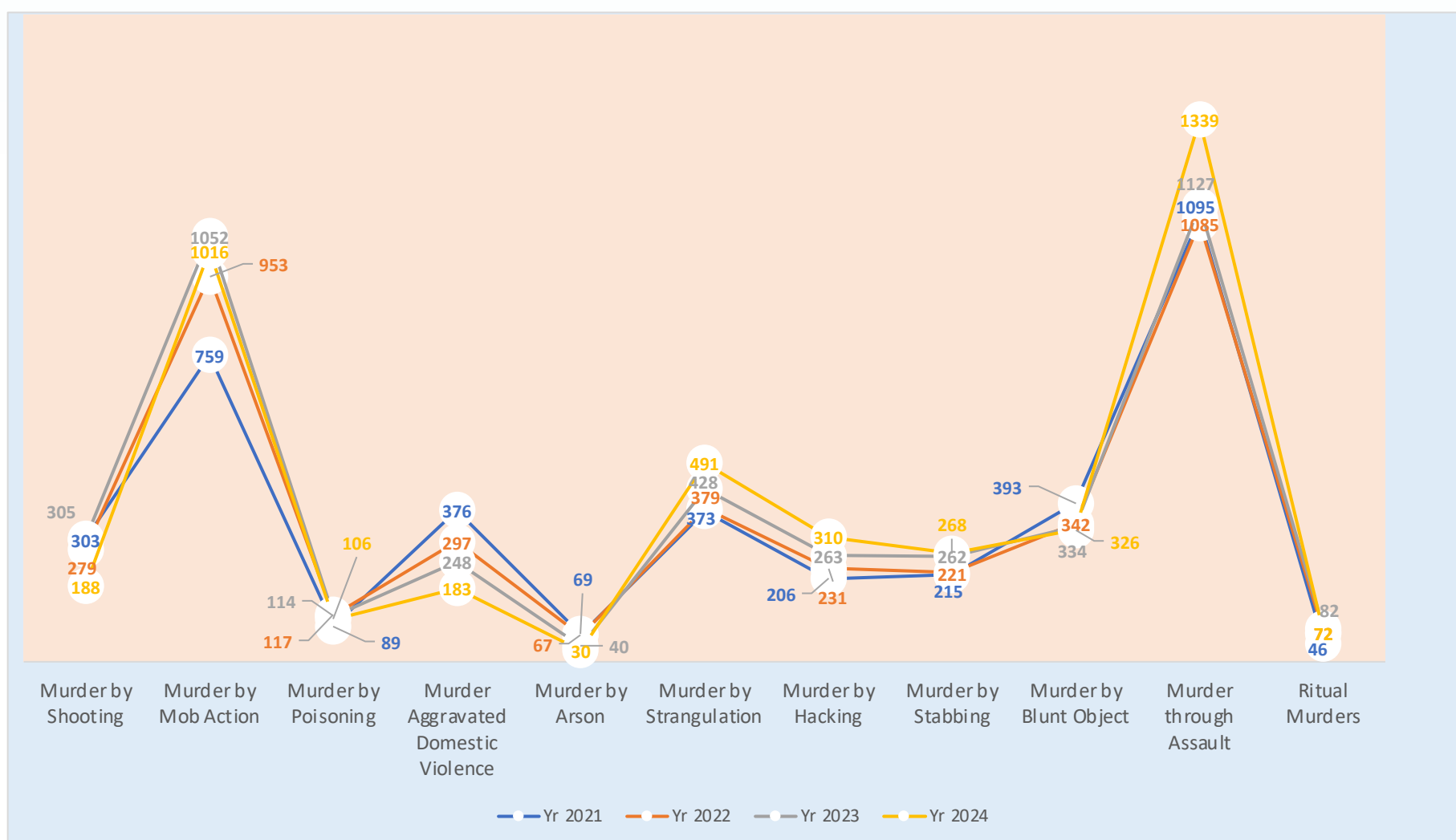


The motive behind such killings includes land wrangles, infidelity, people taking the law into their hands, family misunderstandings, crimes of passion and business rivalry.

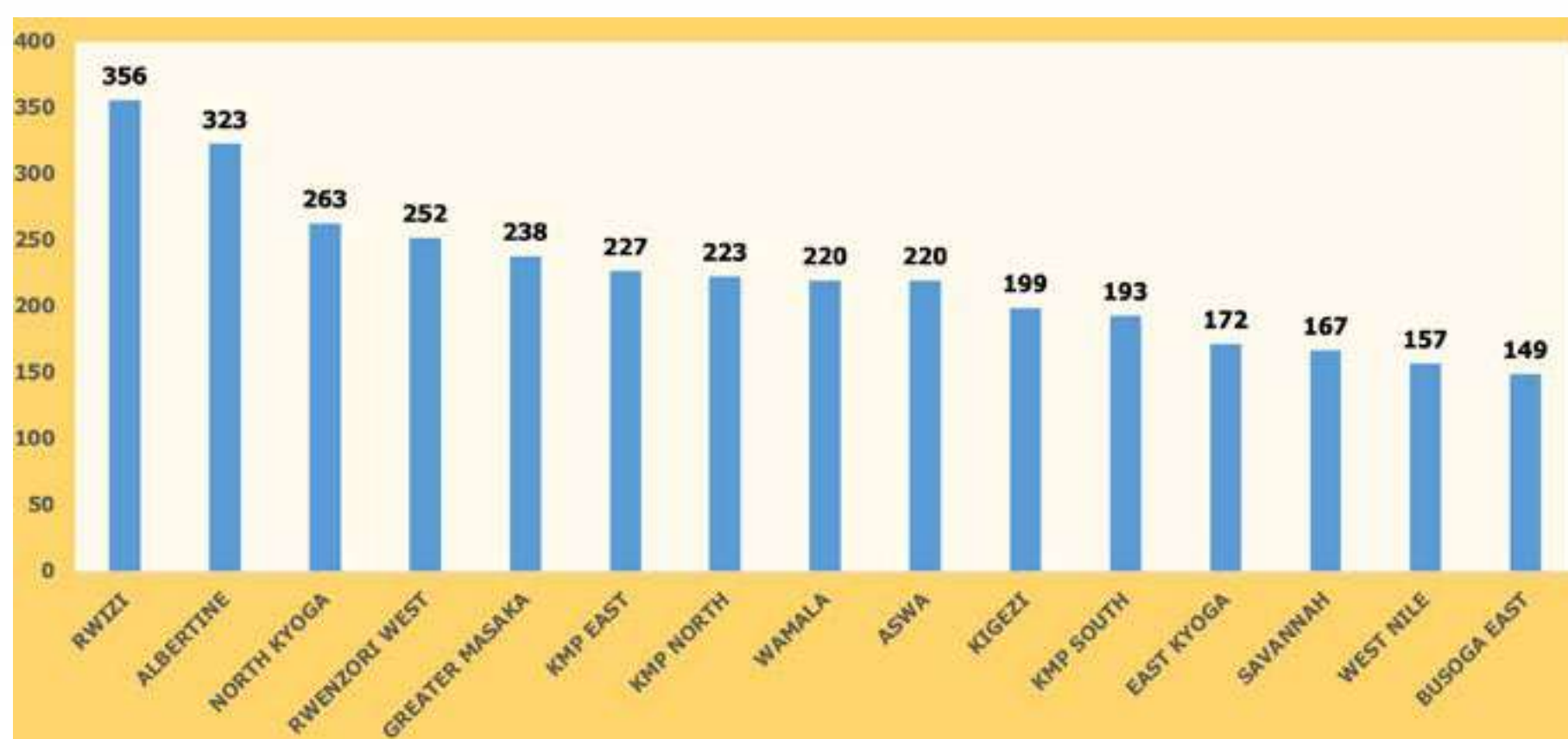

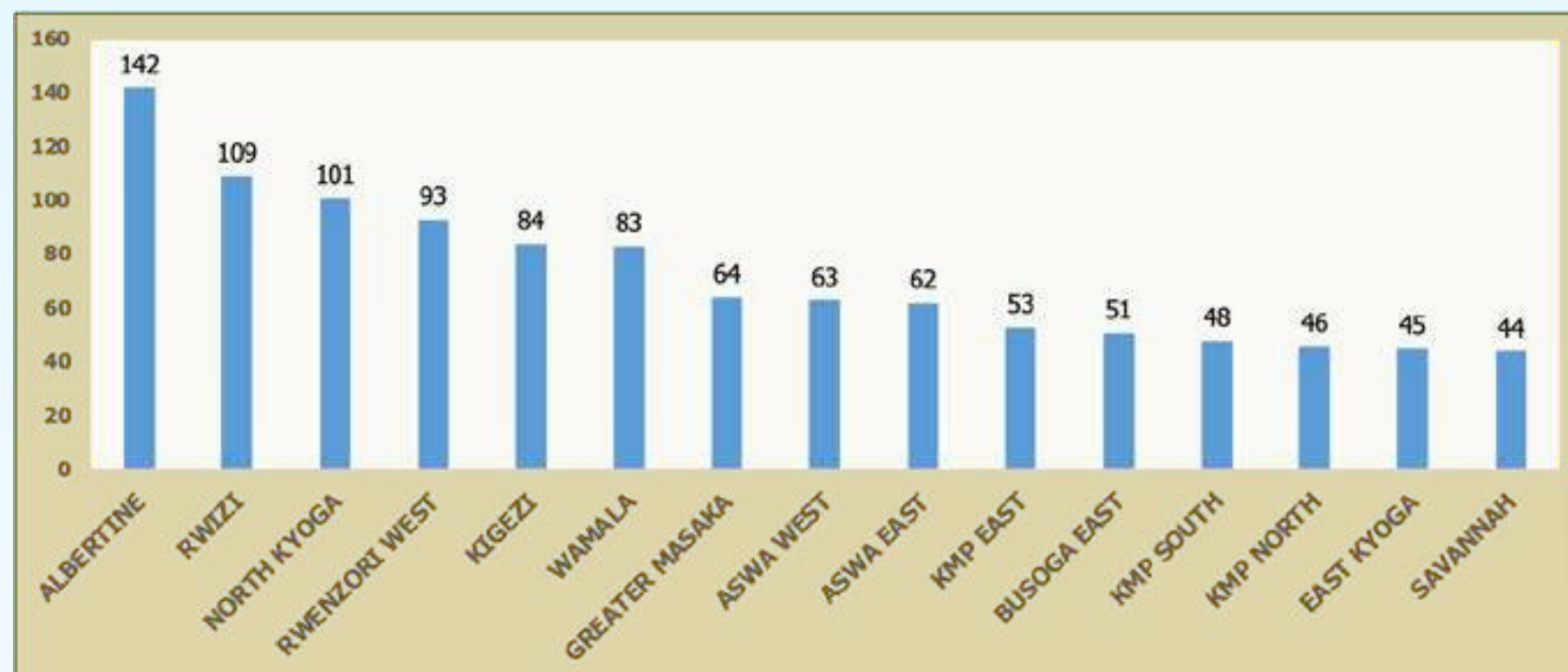

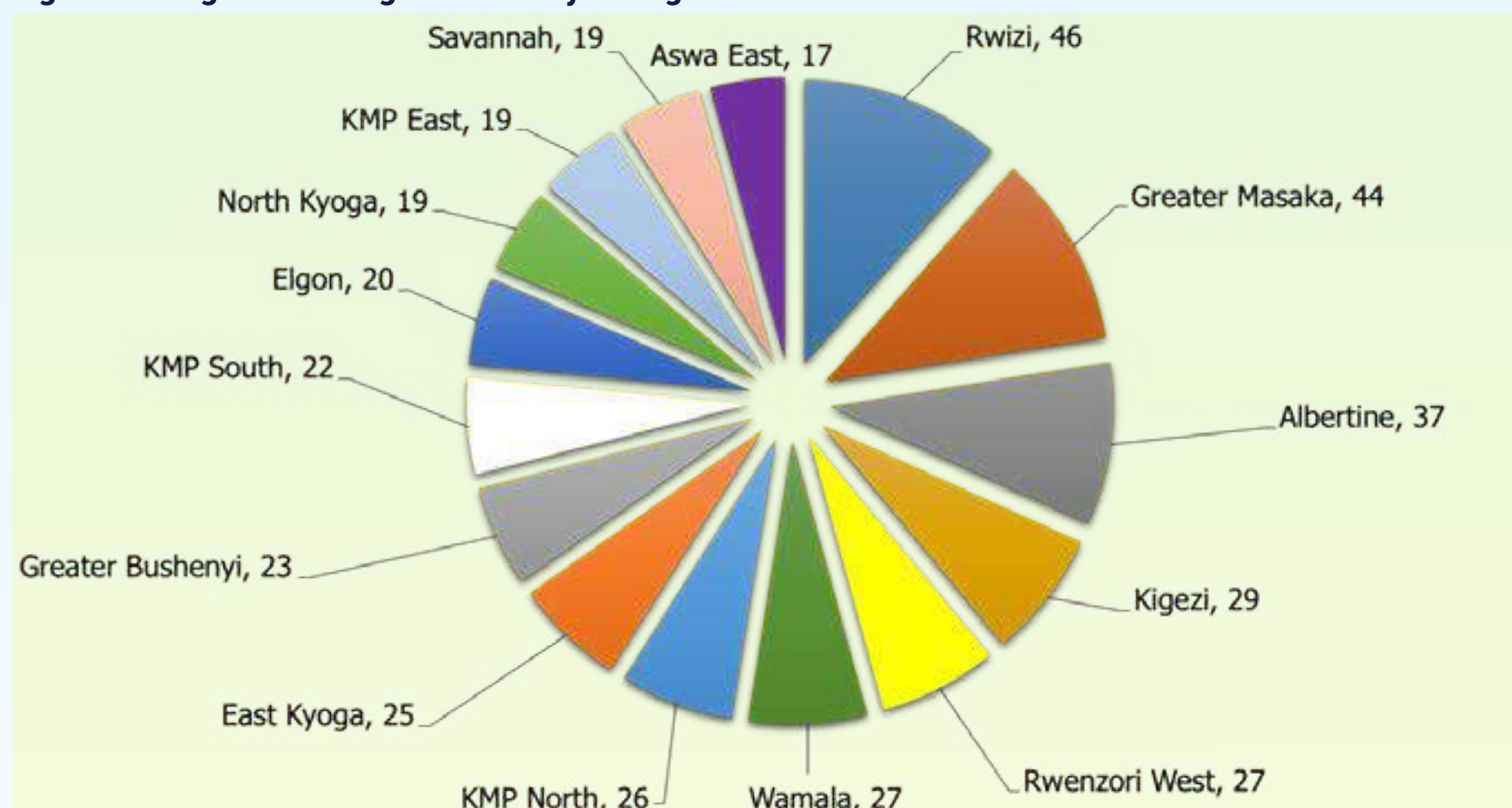

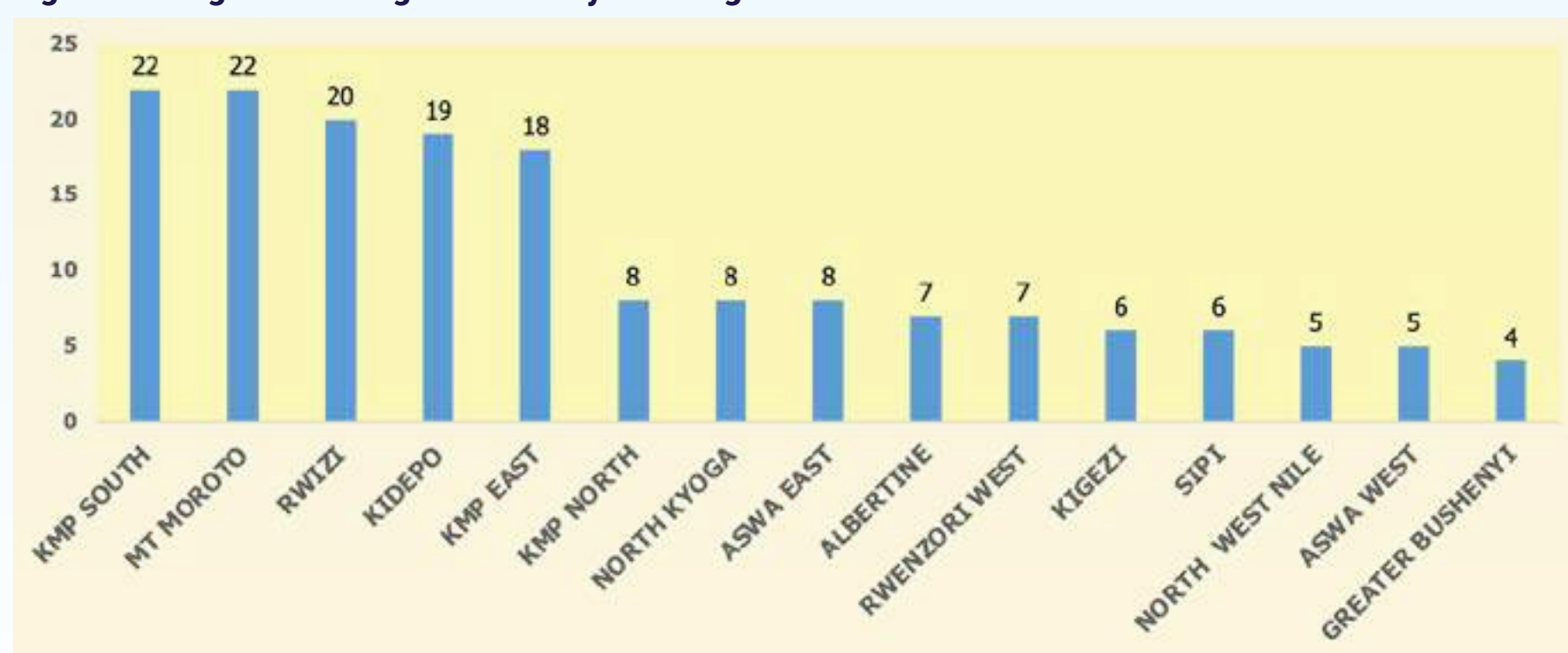

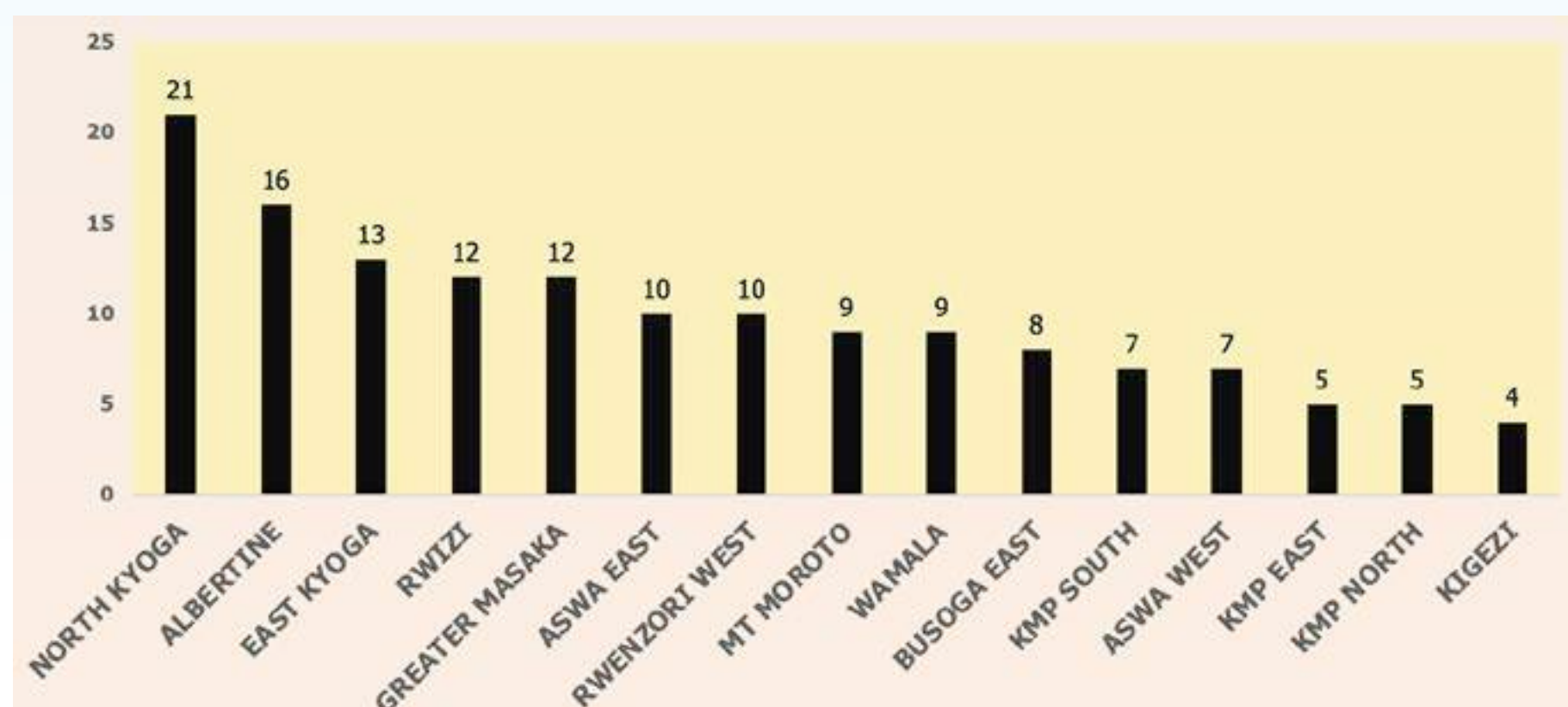

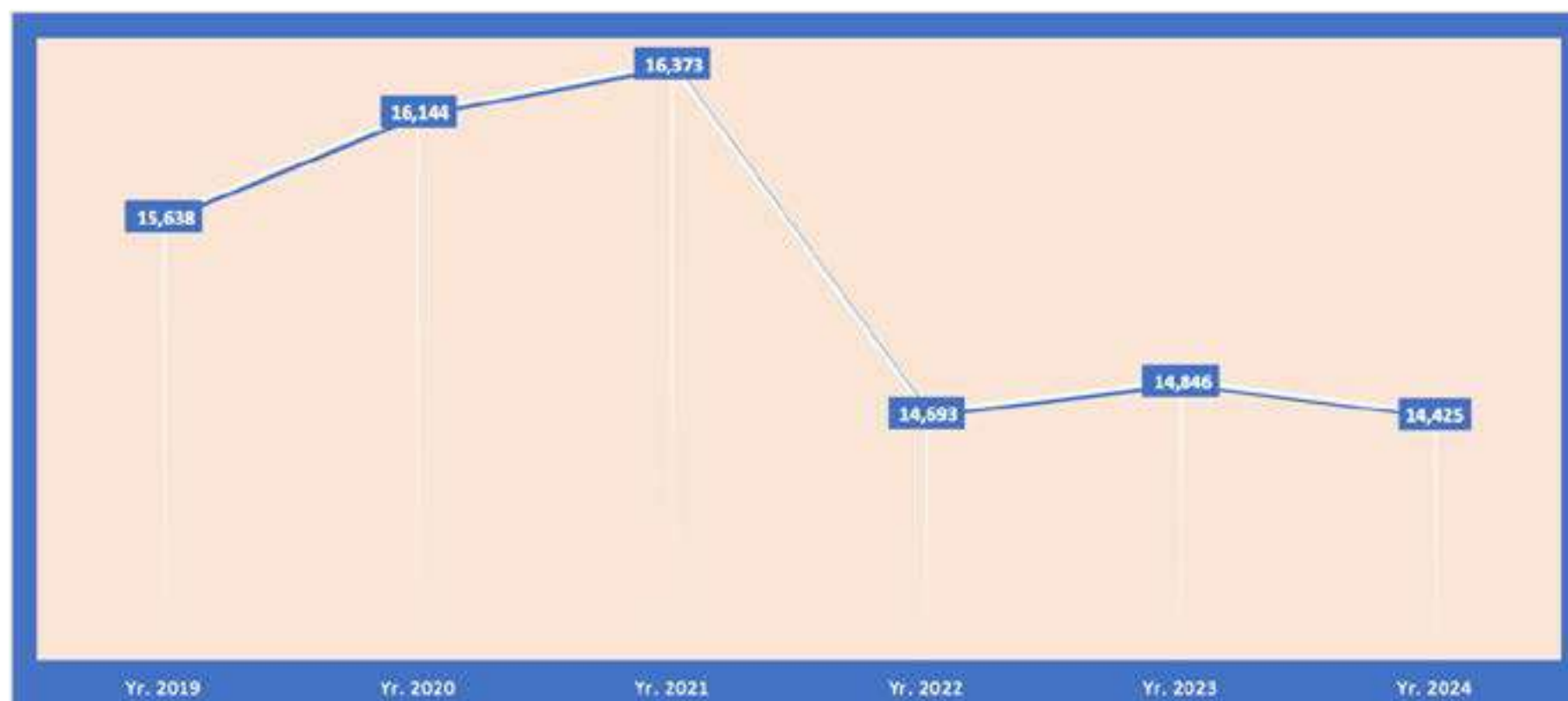
A total of **14,425** Sex-related cases representing **6.6%** of the overall registered crimes in this category countrywide were reported to the Police in 2024 compared to **14,846** cases reported in 2023 giving a decrease by **2.8%**.

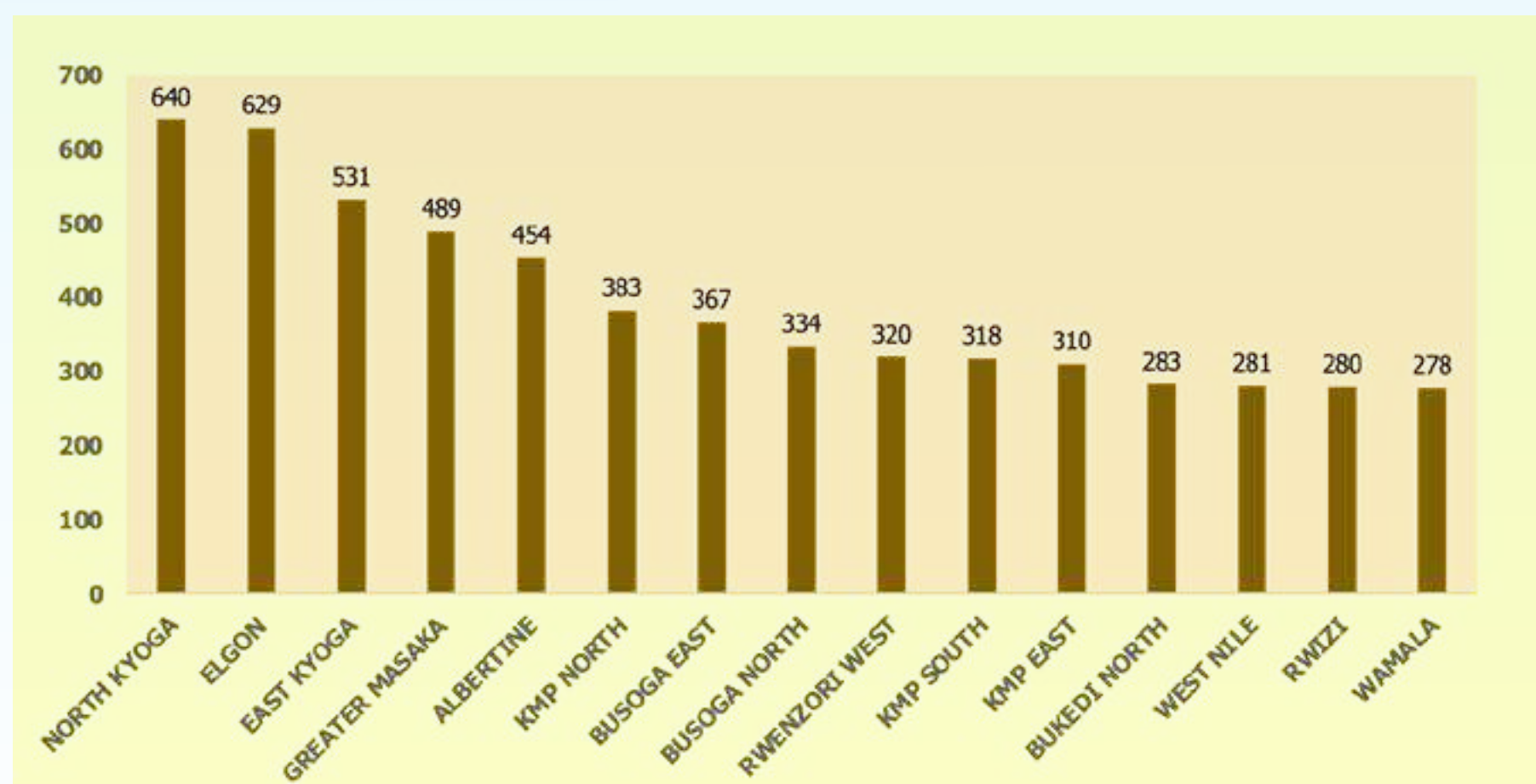

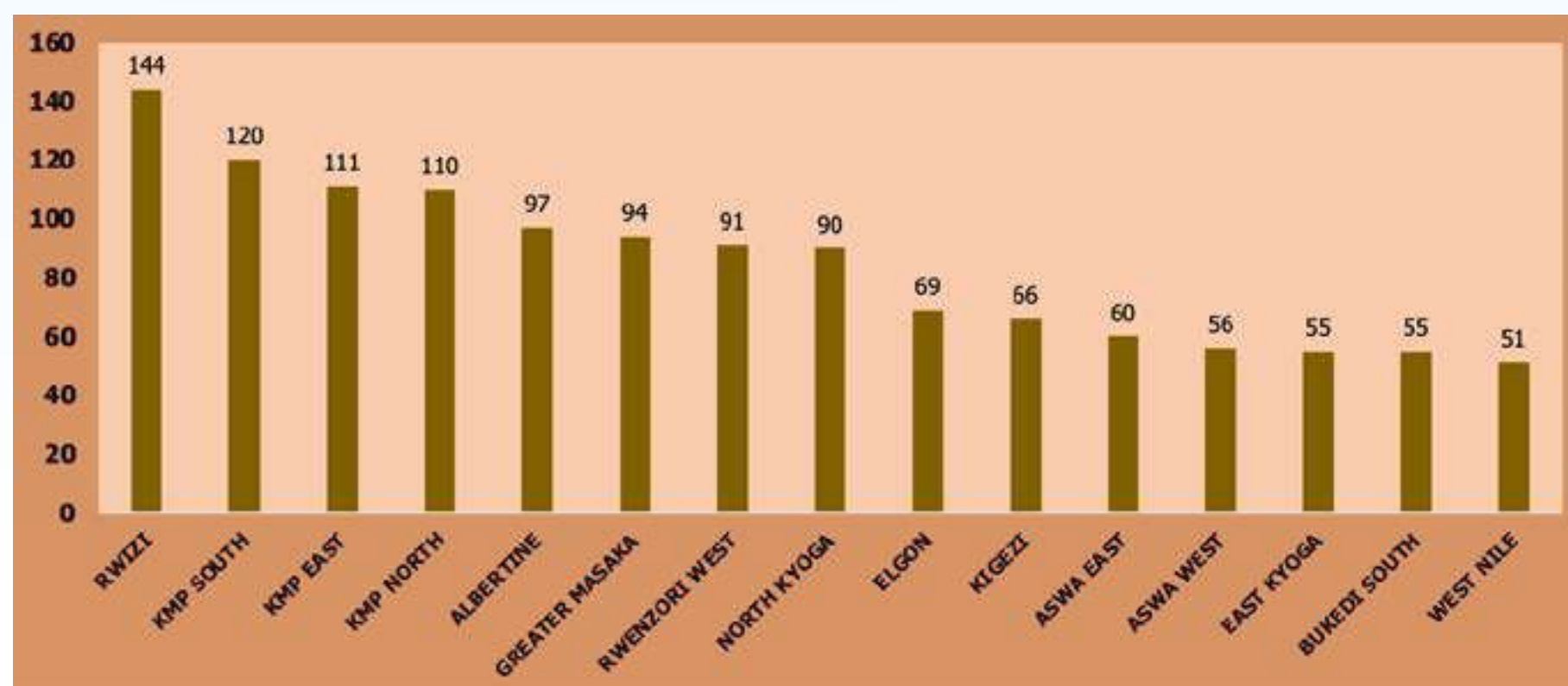

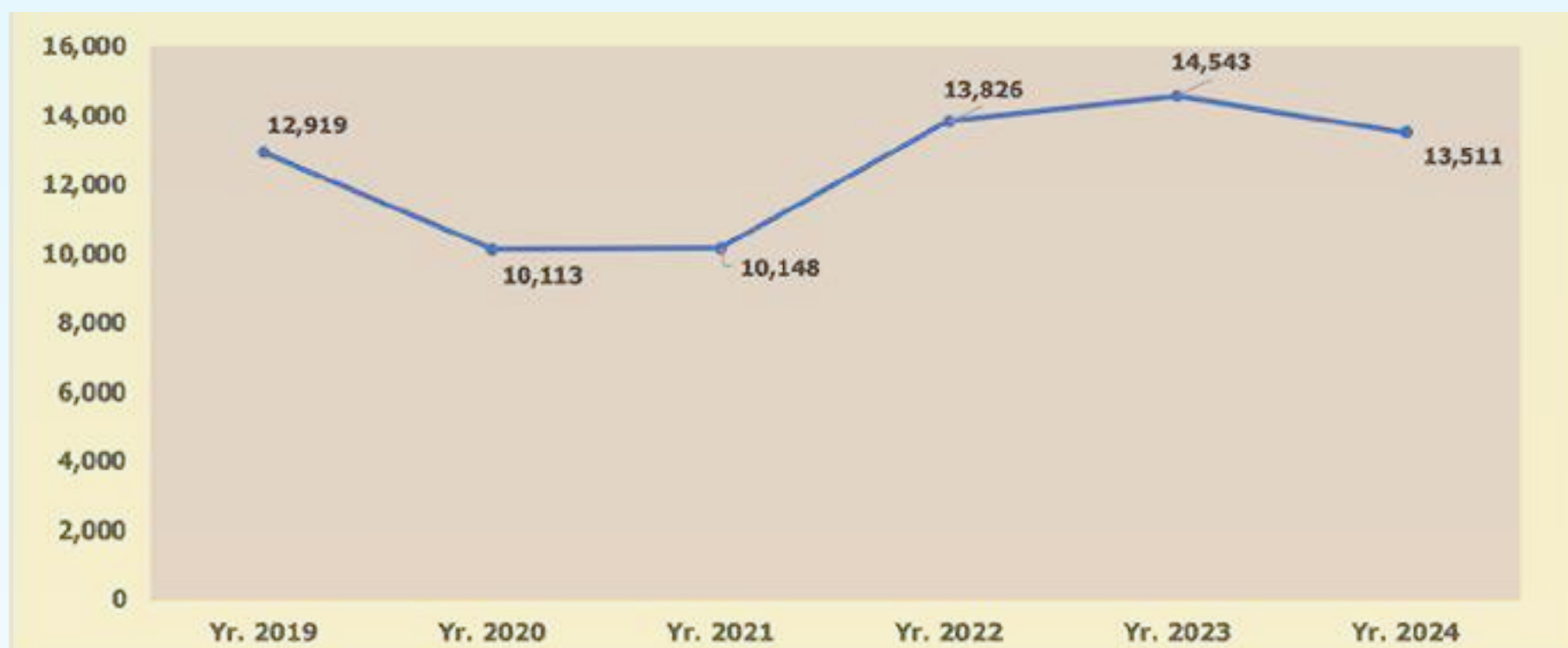

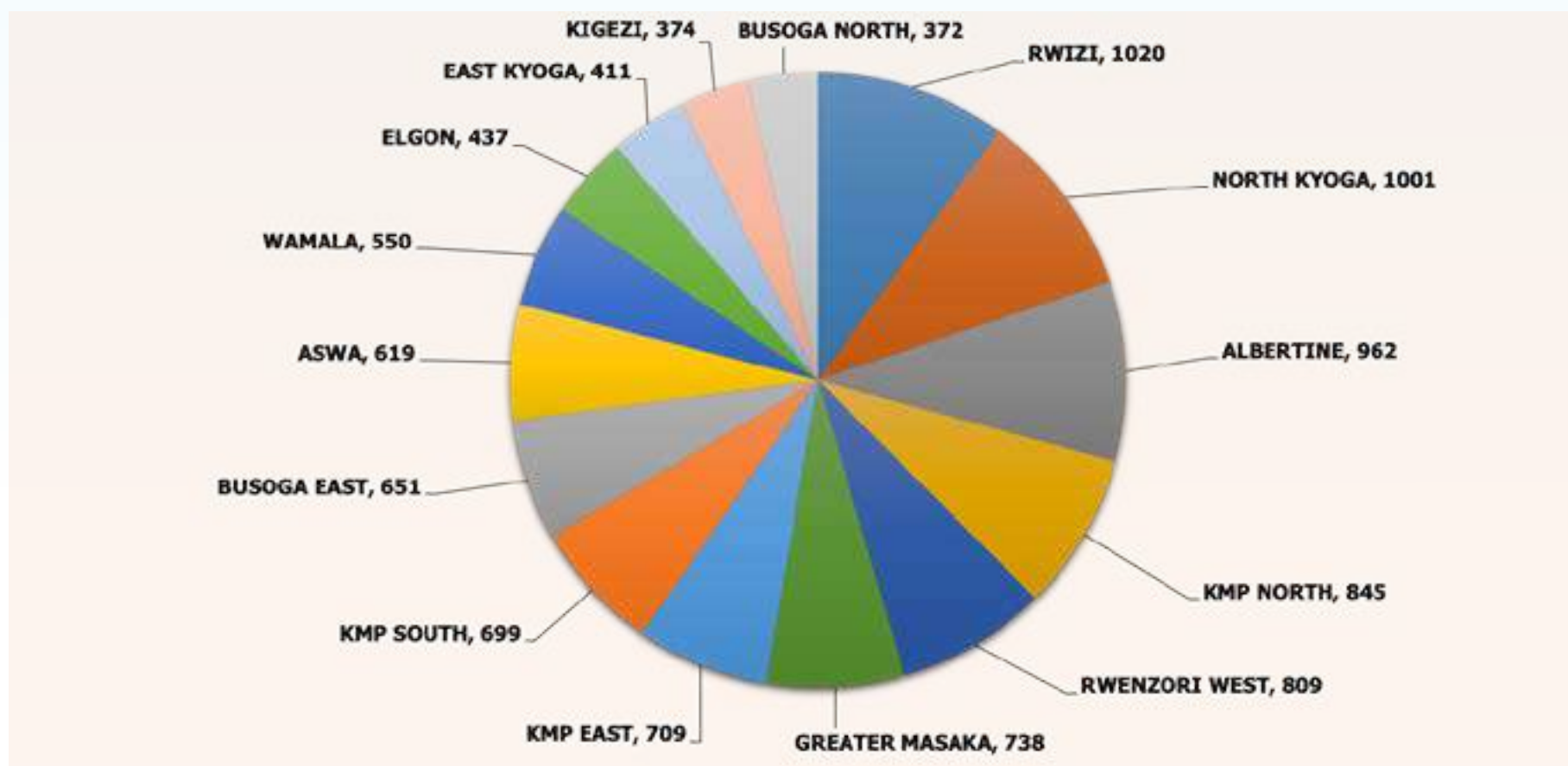
Figure 31: Comparison of Cases of Breakings from 2019 to 2024

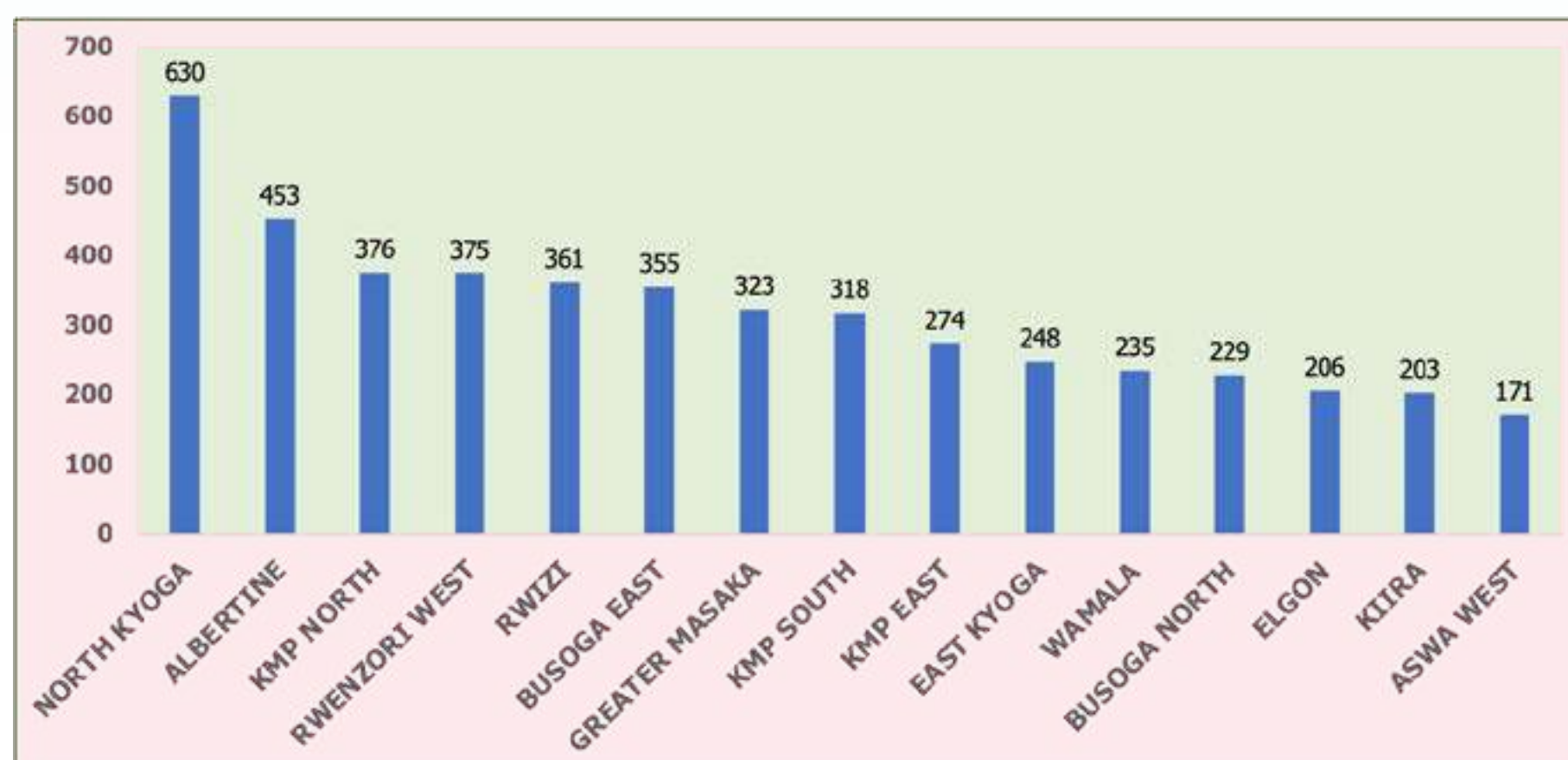

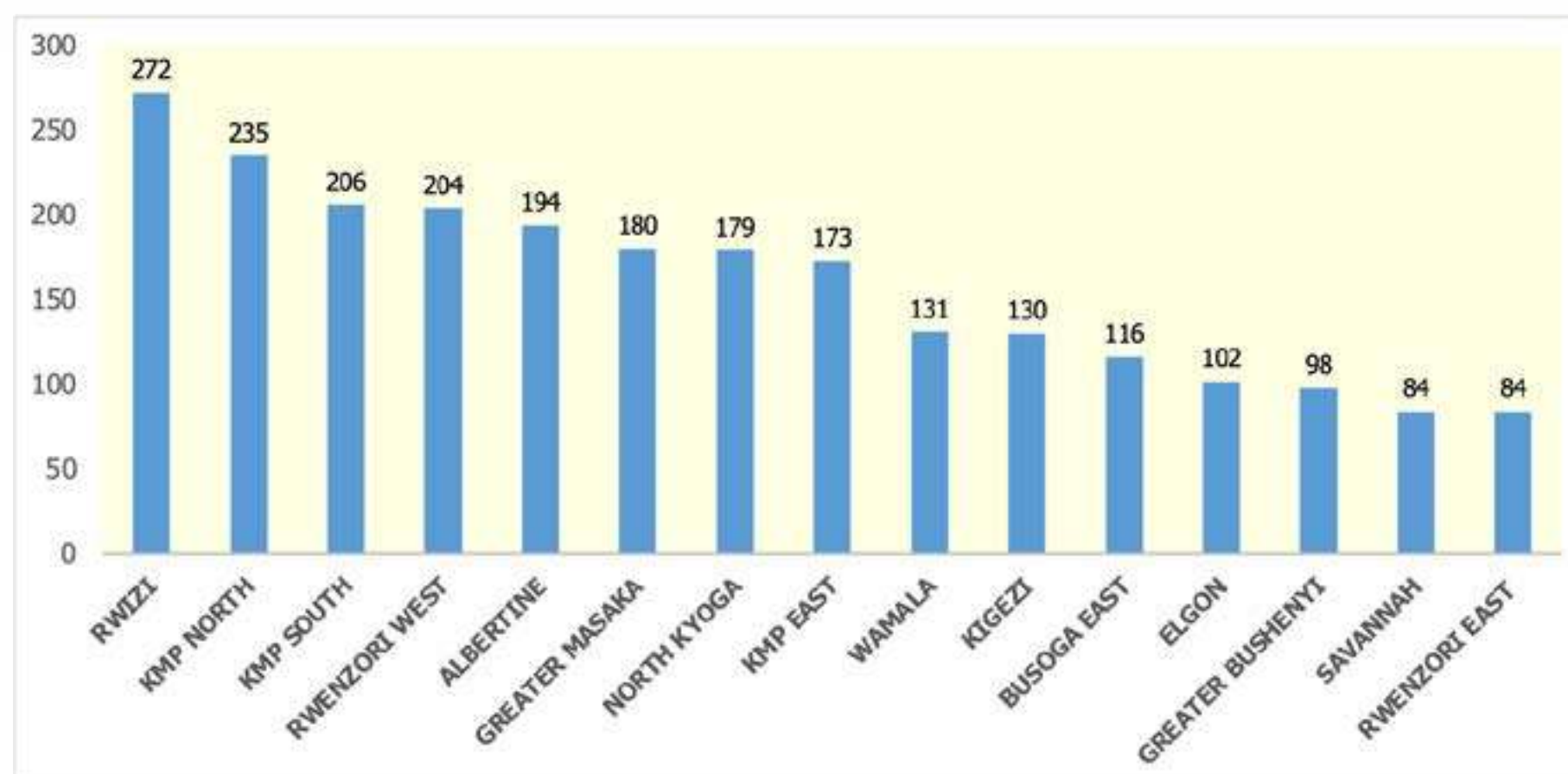

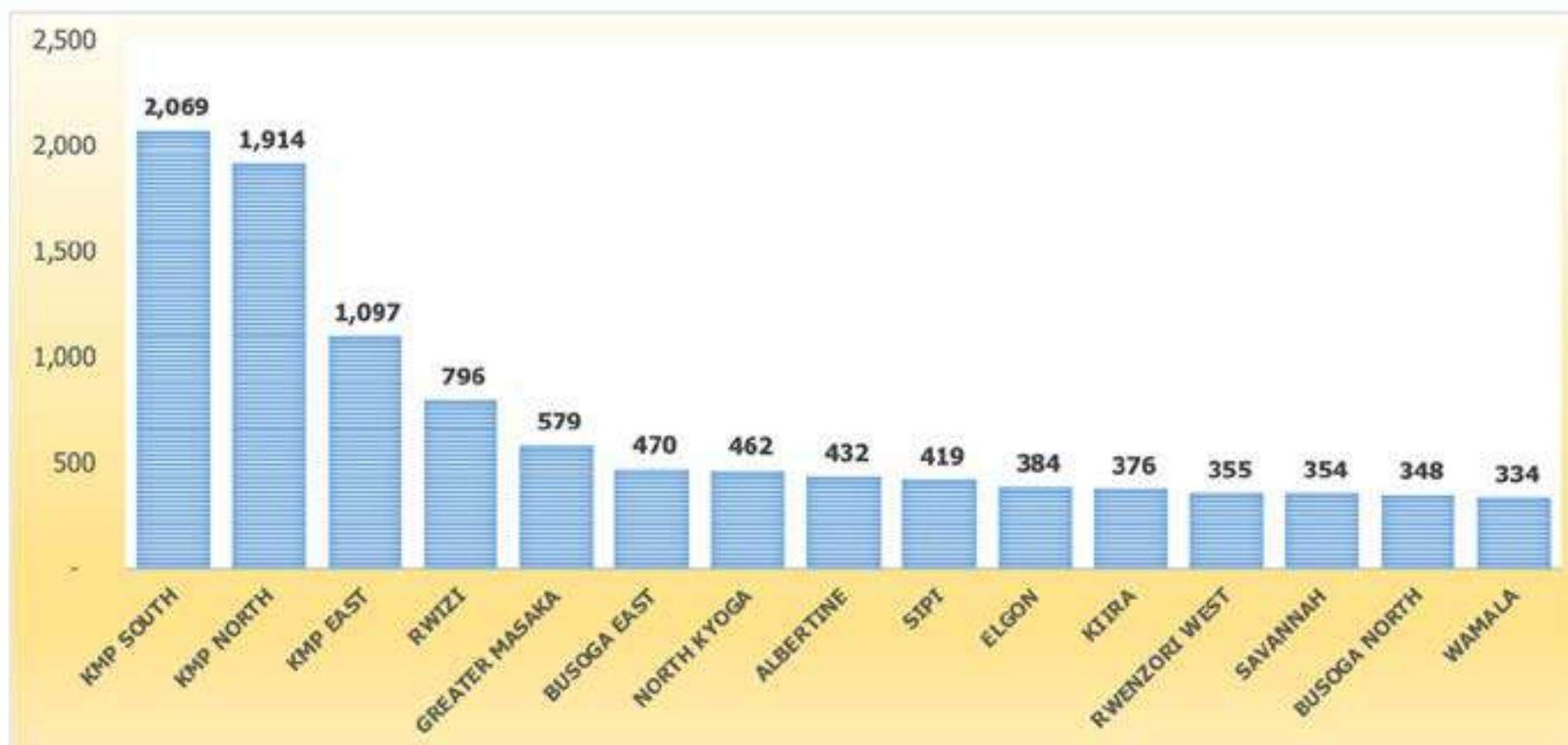
Figure 35: Comparison of cases of Economic & Corruption Crimes from 2019 to 2024

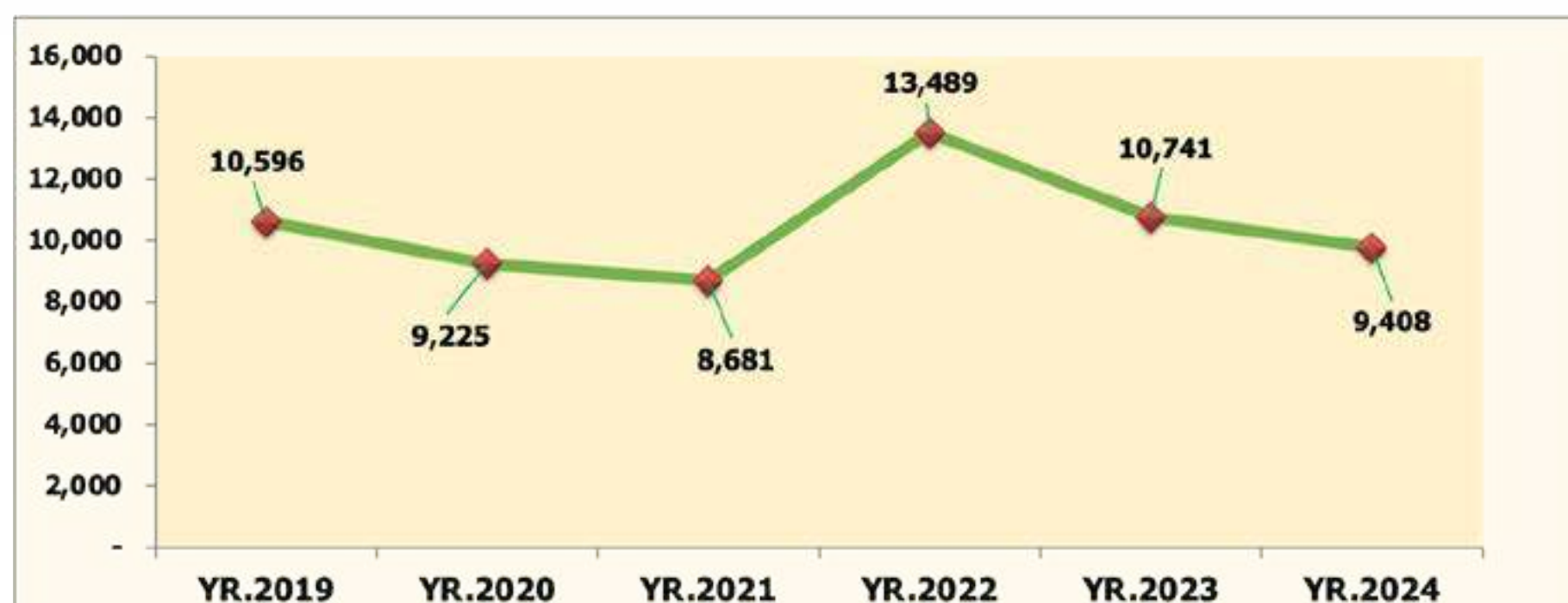

Figure 37: Comparison of Cases of Child-related Offences from 2019 to 2024

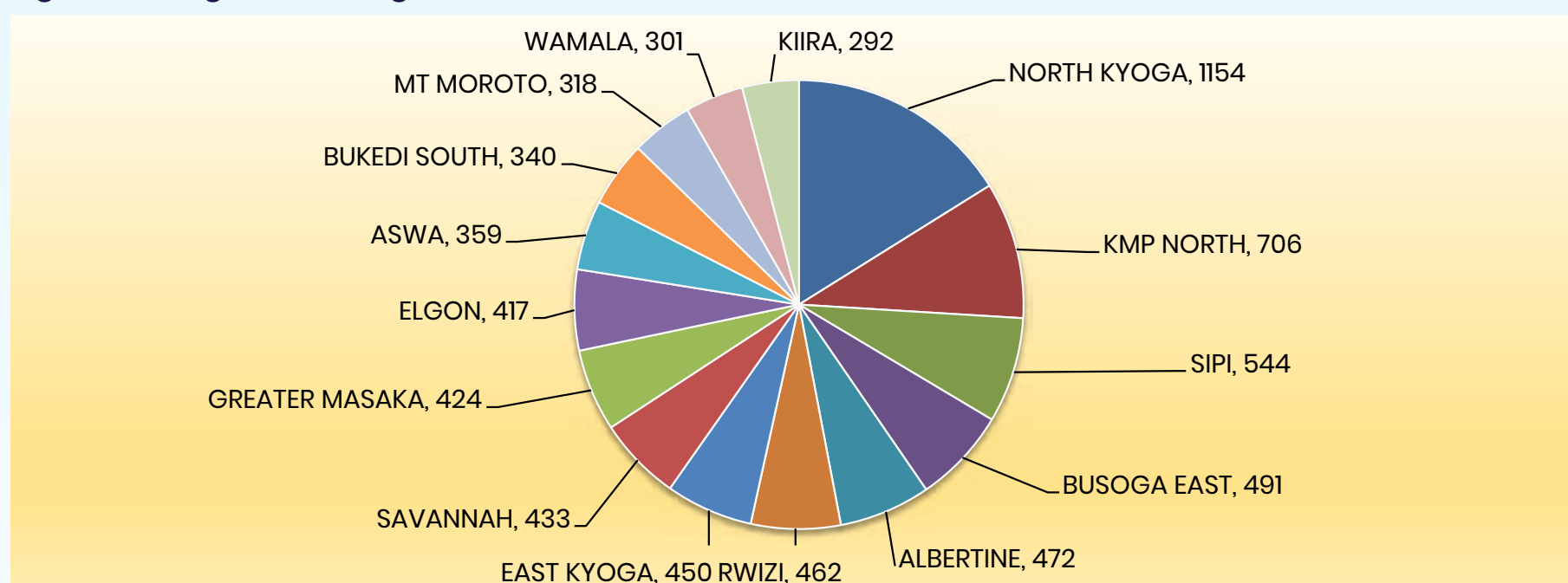

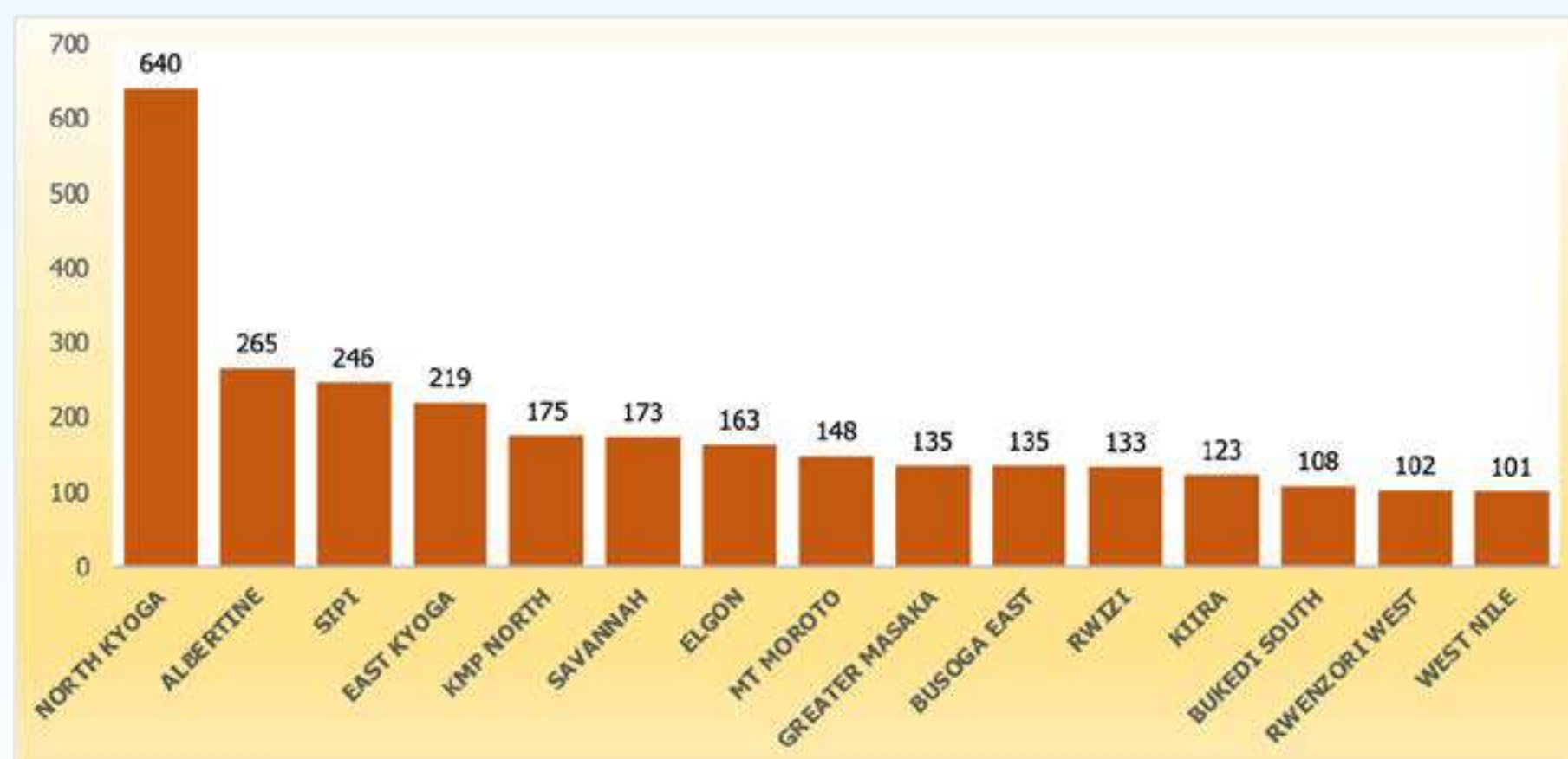

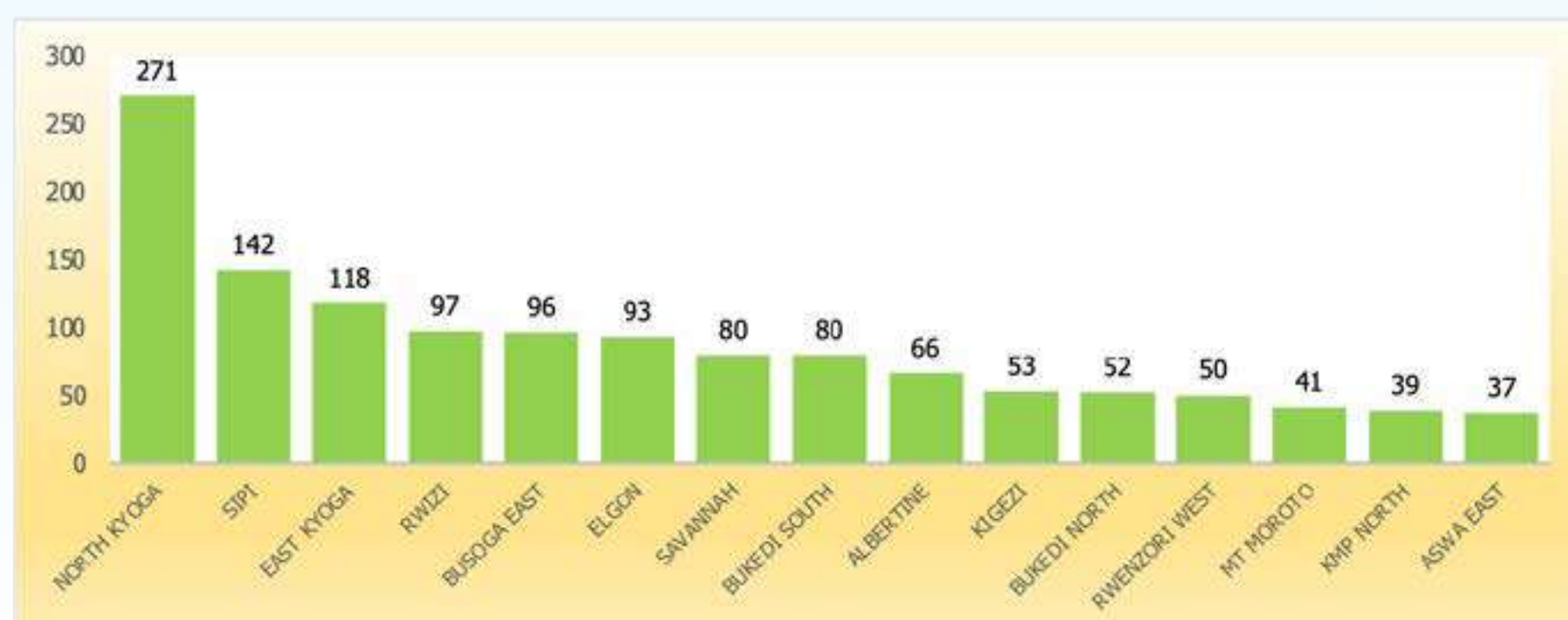

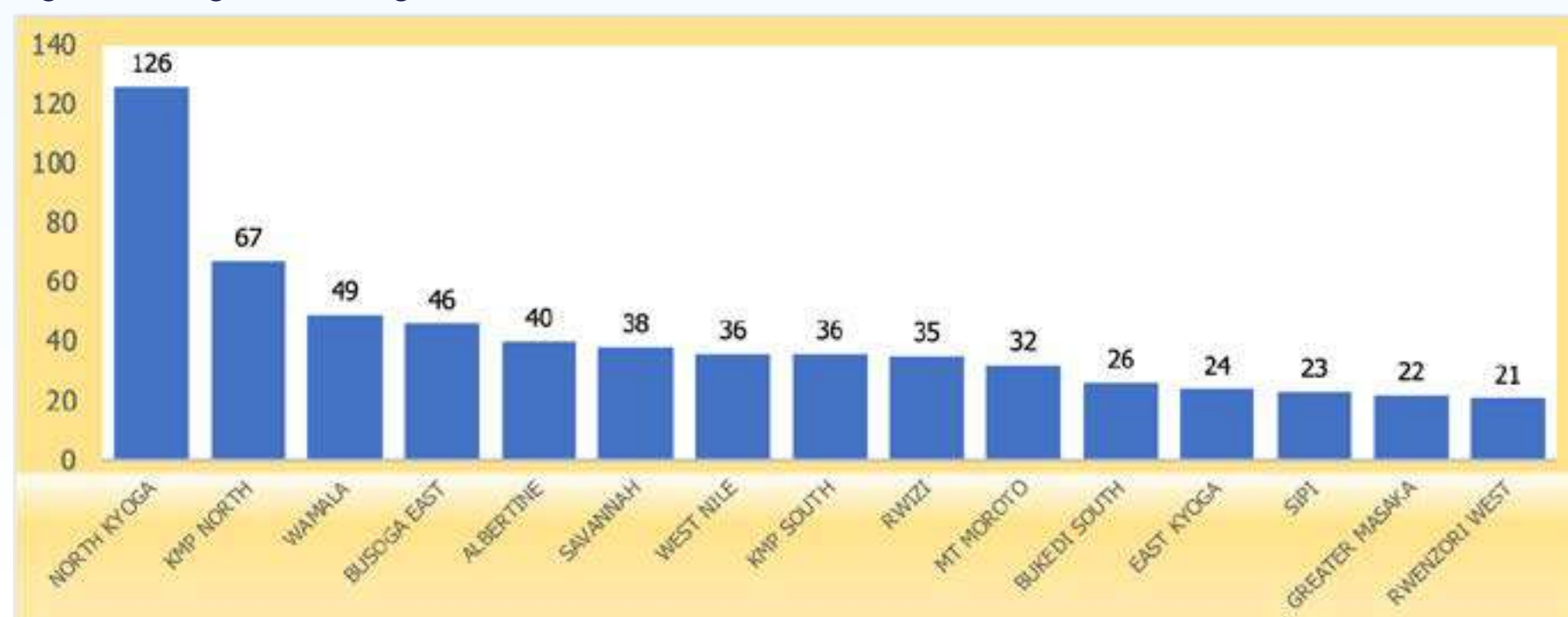

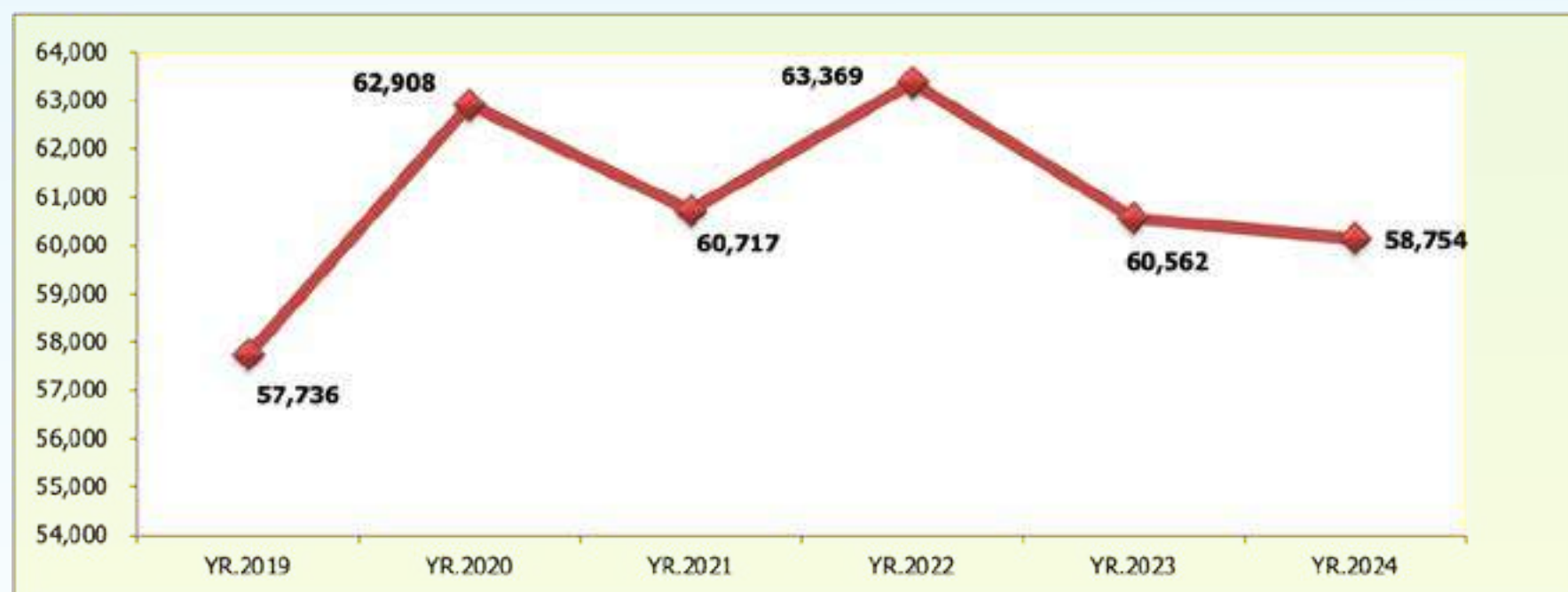

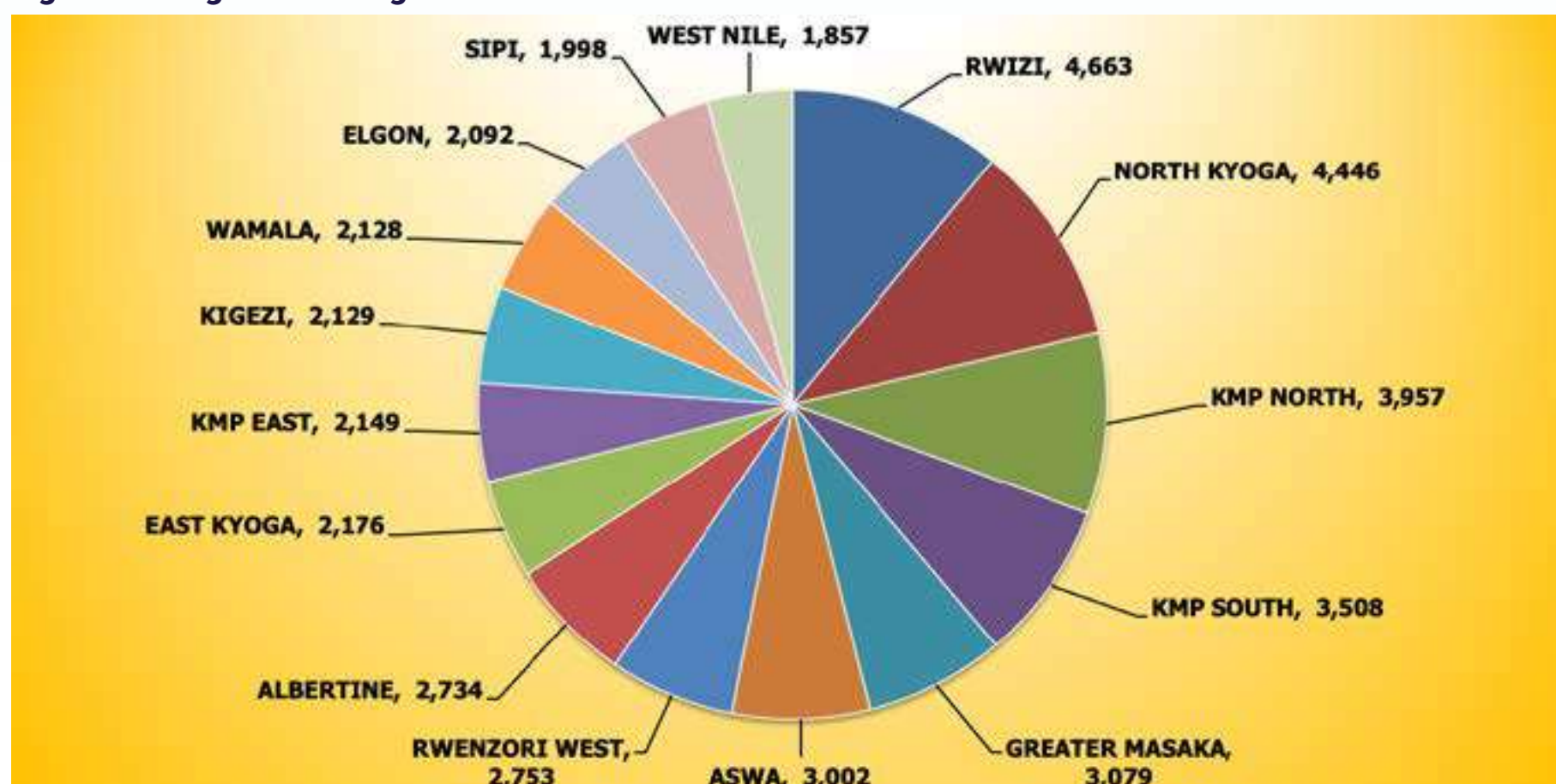
Figure 42: Comparison of cases of Other Crimes in General from 2019 to 2024

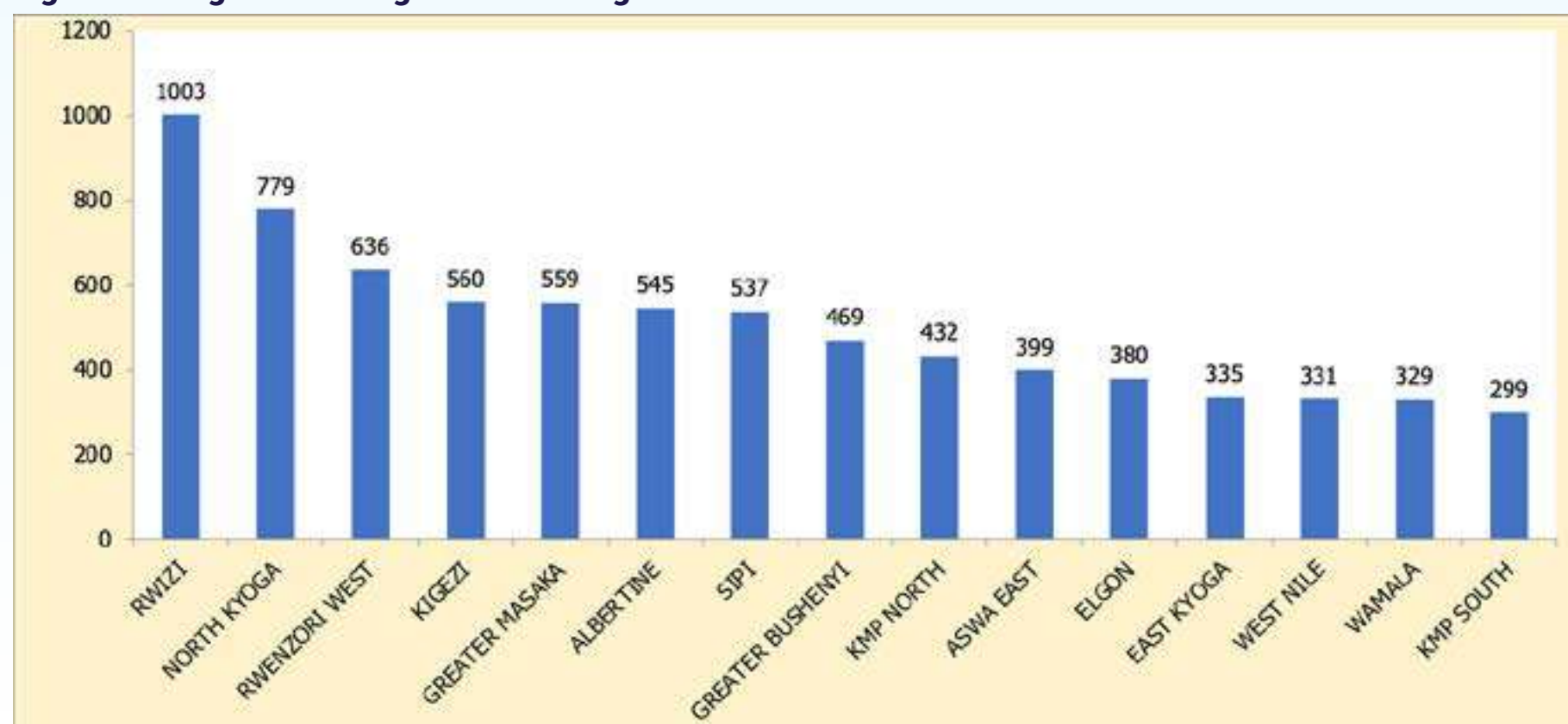

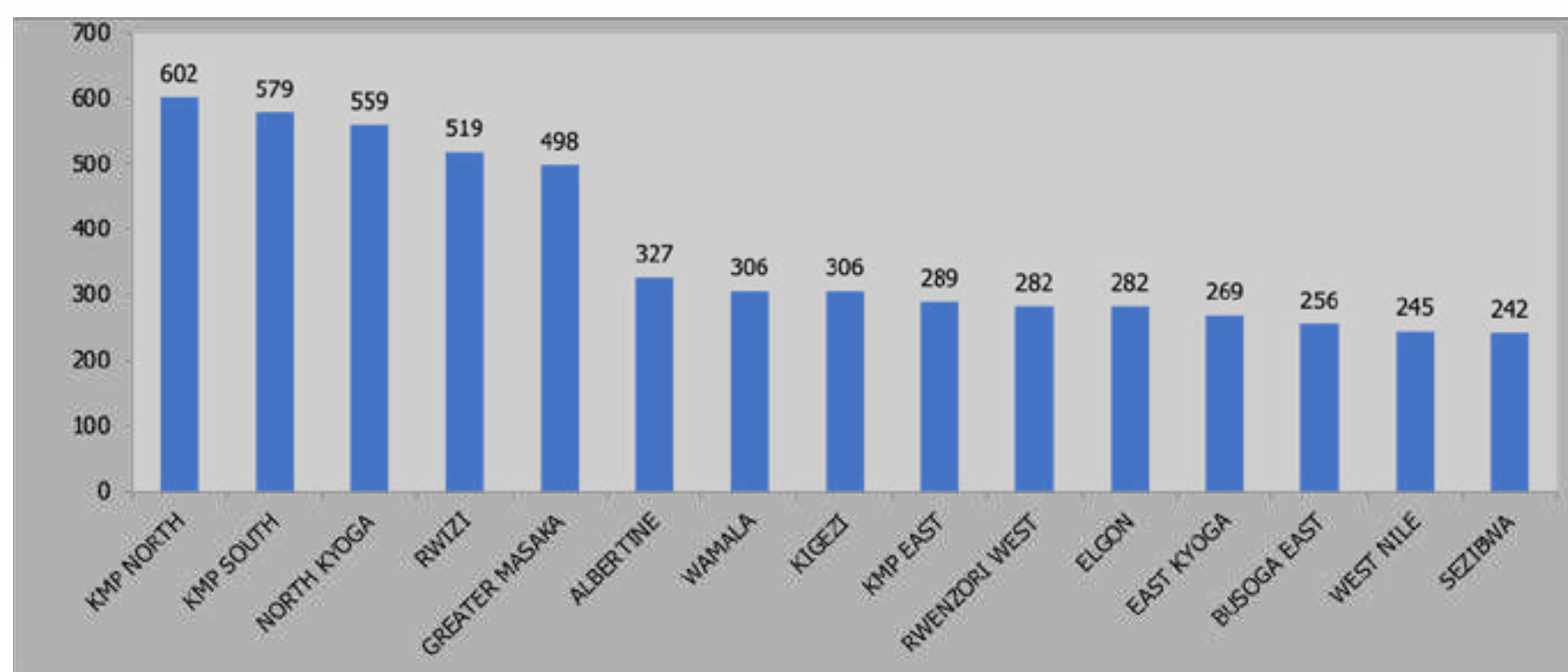

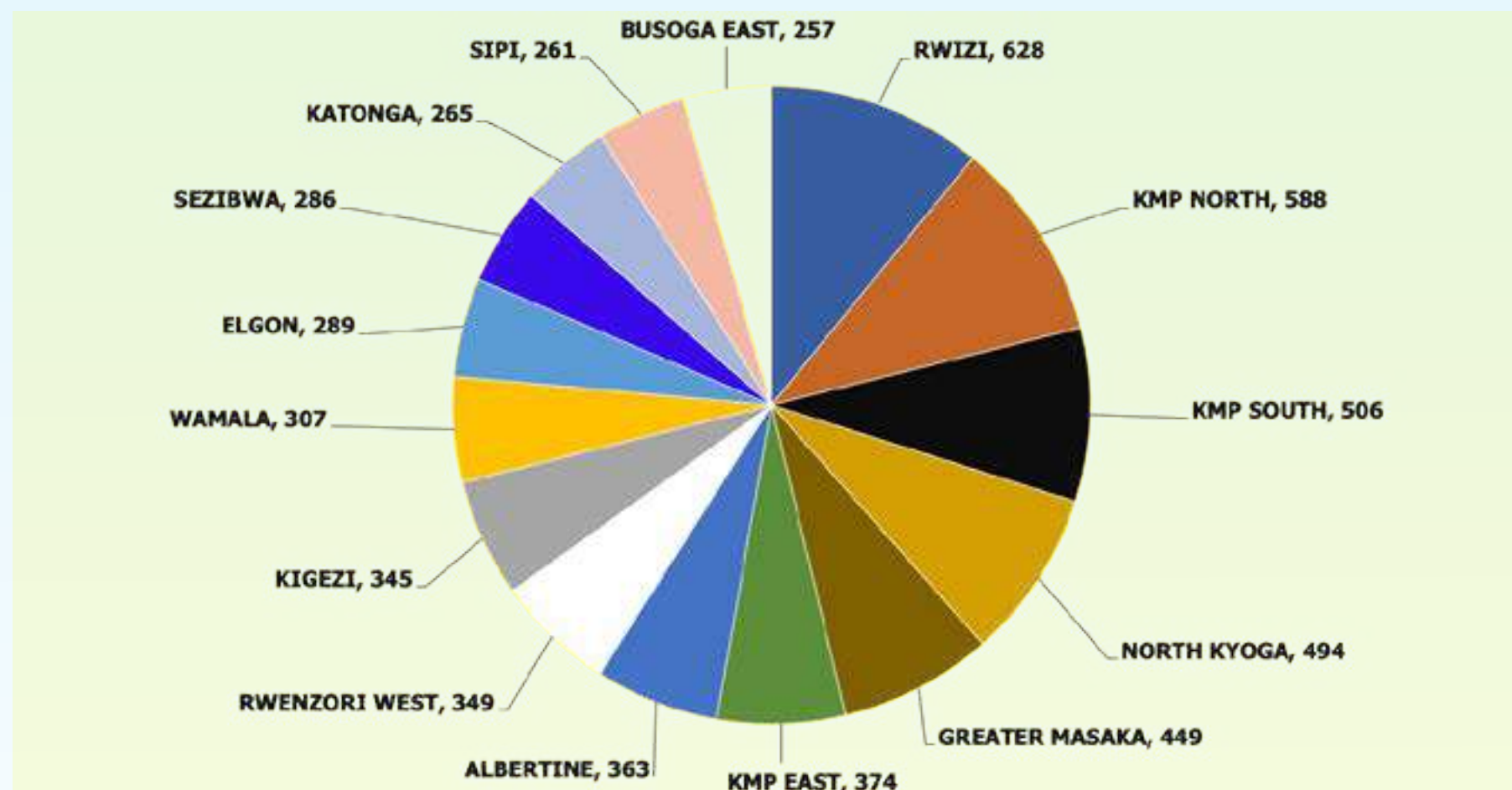

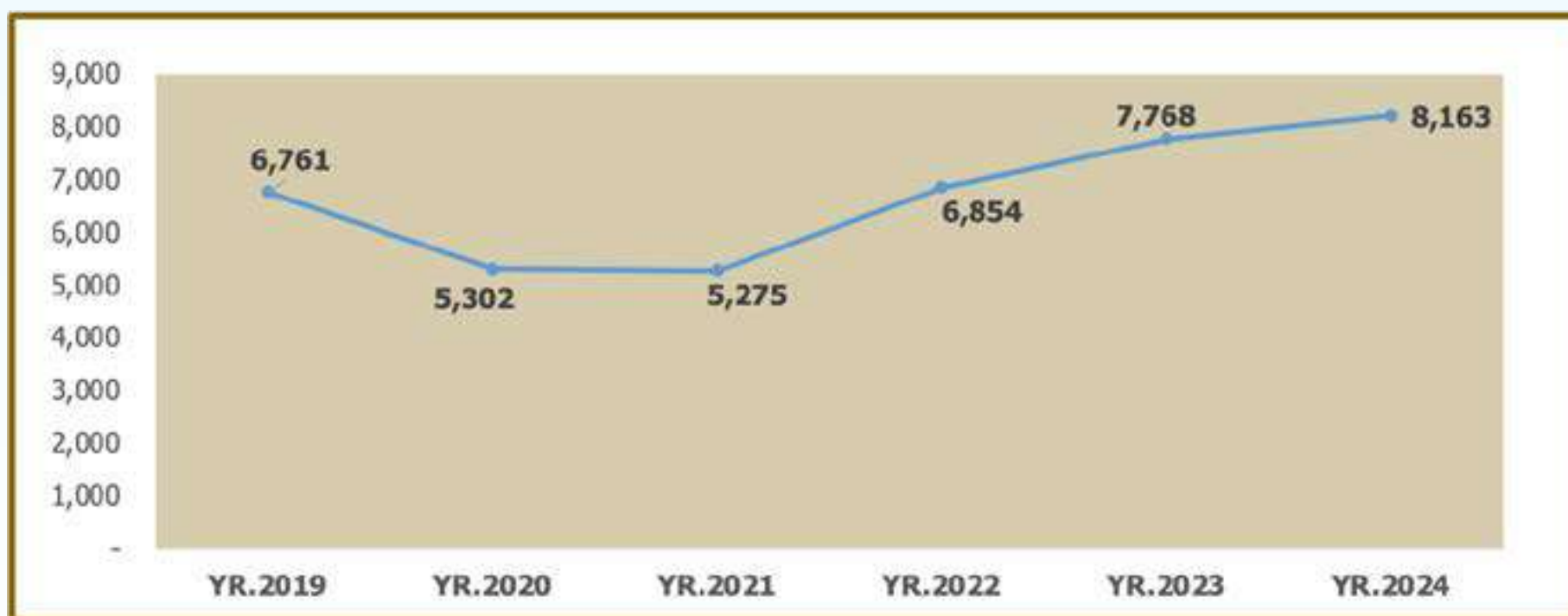

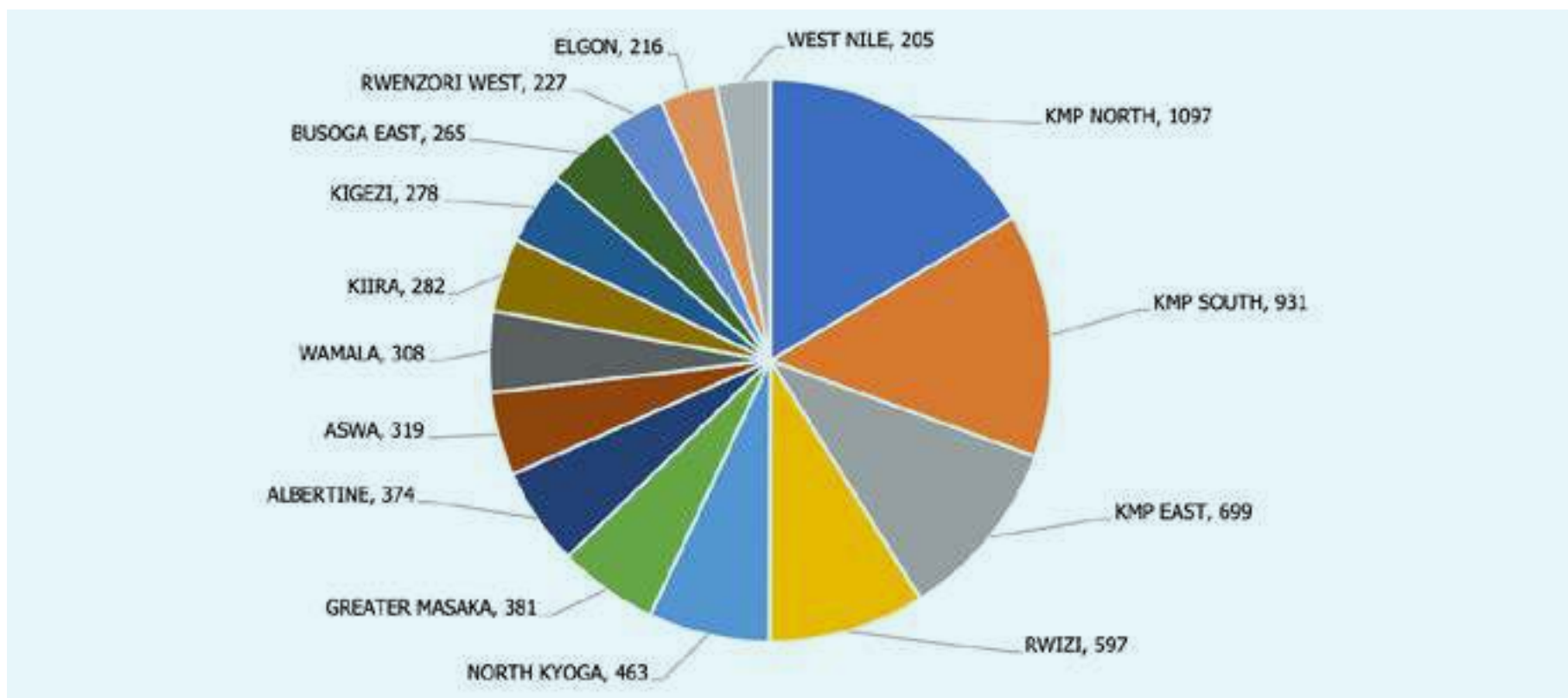
Figure 50: Comparison of Cases of Robberies from 2019 to 2024

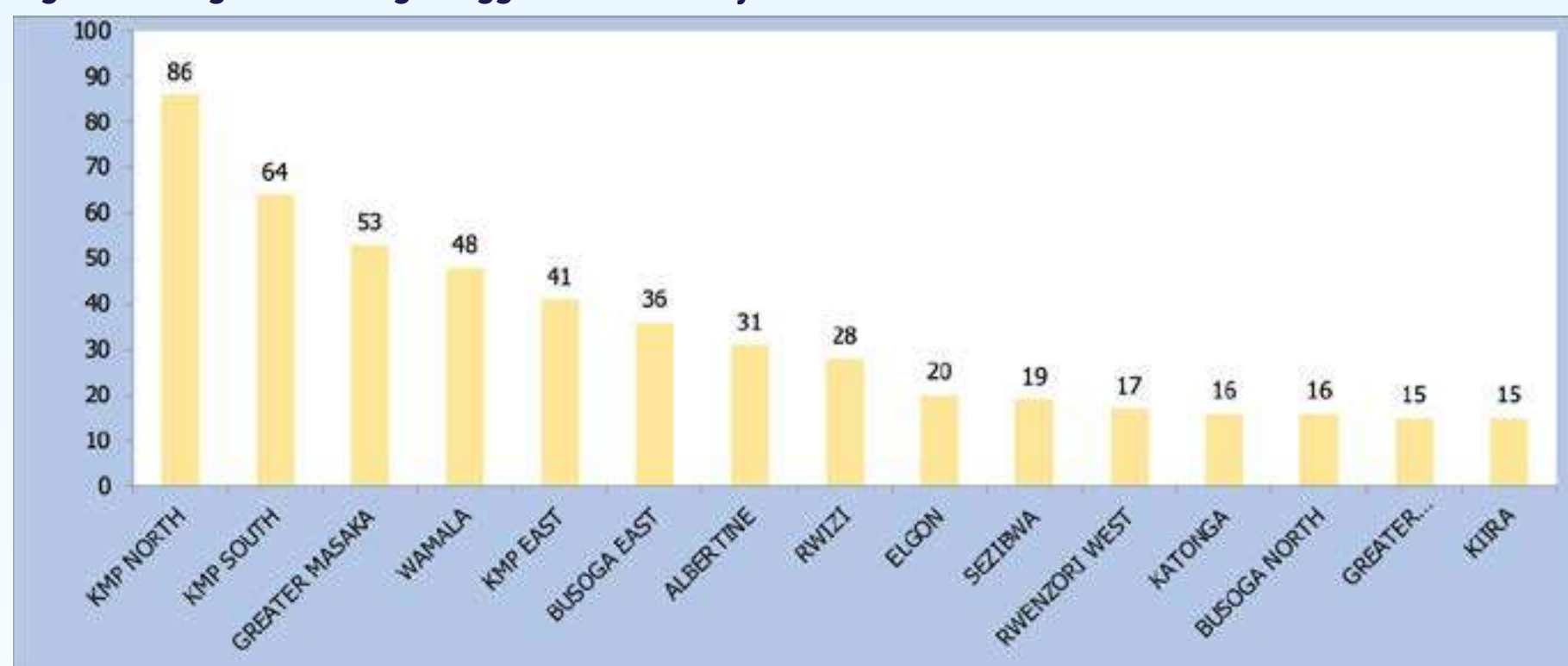

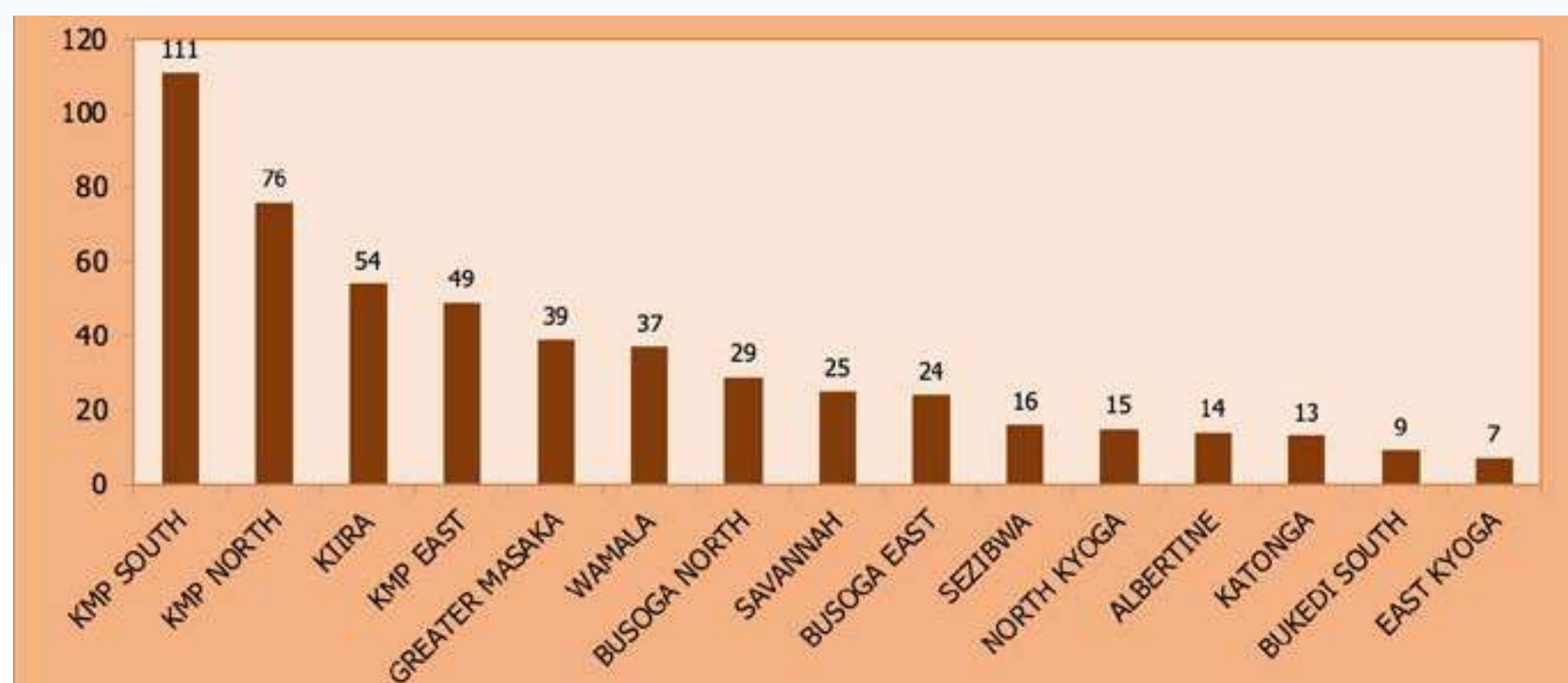
1.5.9.4 Aggravated Robbery of Motorcycles

A total of **510** cases of Aggravated Robbery of Motorcycles were reported to the Police in 2024 compared to **481** cases reported in 2023 giving a **6%** increase of the reported cases in this crime category. A total of **94** cases were taken to Court, **05** cases secured a conviction, **05** cases were dismissed, while **84** are still pending in Court. A total of **820** Motorcycle were reported robbed, out of which, **405** were recovered, **141** were found abandoned, while **274** were not recovered.

1.5.9.5 Cattle Rustling

A total of **05** cases of Cattle Rustling were registered by Police in 2024 compared to **48** cases registered in 2023 giving a **89%** decrease of the reported cases in this crime category. 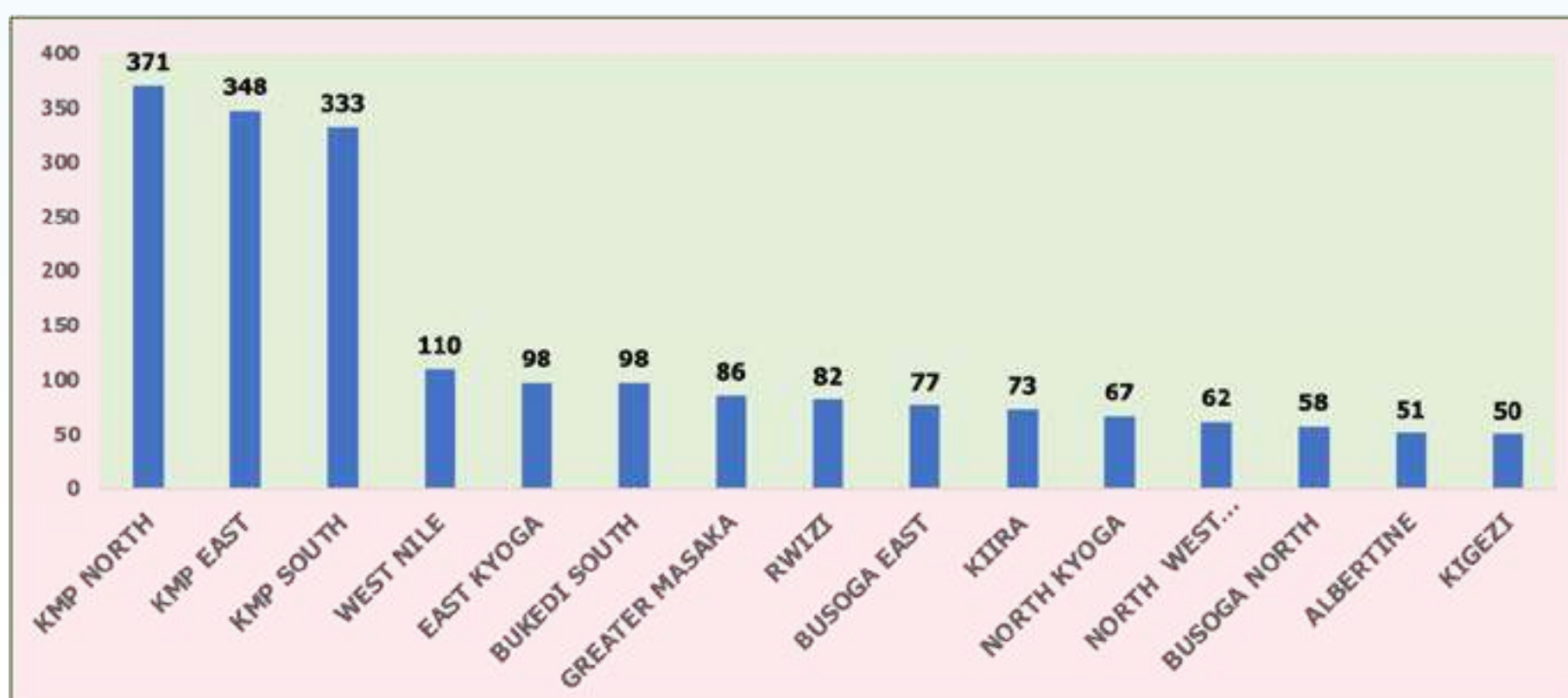
Figure 55: Comparison of Cases of Narcotics Registered at Police Between 2019 and 2024

Figure 58: Comparison of cases of Electoral/Political and Media Offences from 2020



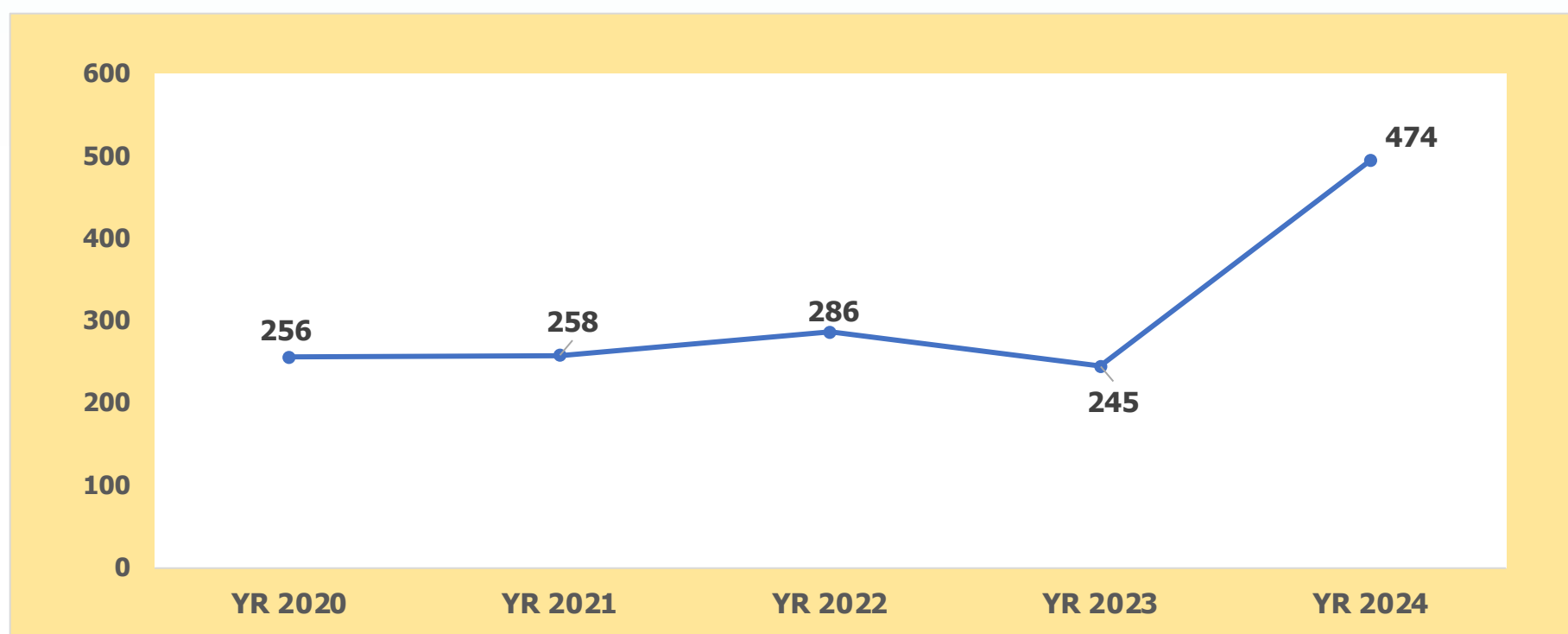
1.5.12 Cybercrimes

A total of **474** cases of Cybercrimes were reported to the Police countrywide, compared to **245** cases reported in 2023, giving a **93.5%** increase in this crime category. By the end of the year, **67** cases were taken to Court, **97** cases were not proceeded with while **310** cases were still under inquiry. Figure 61: Operations Against the Murder of the late Daniel Bbosa Kakeedo

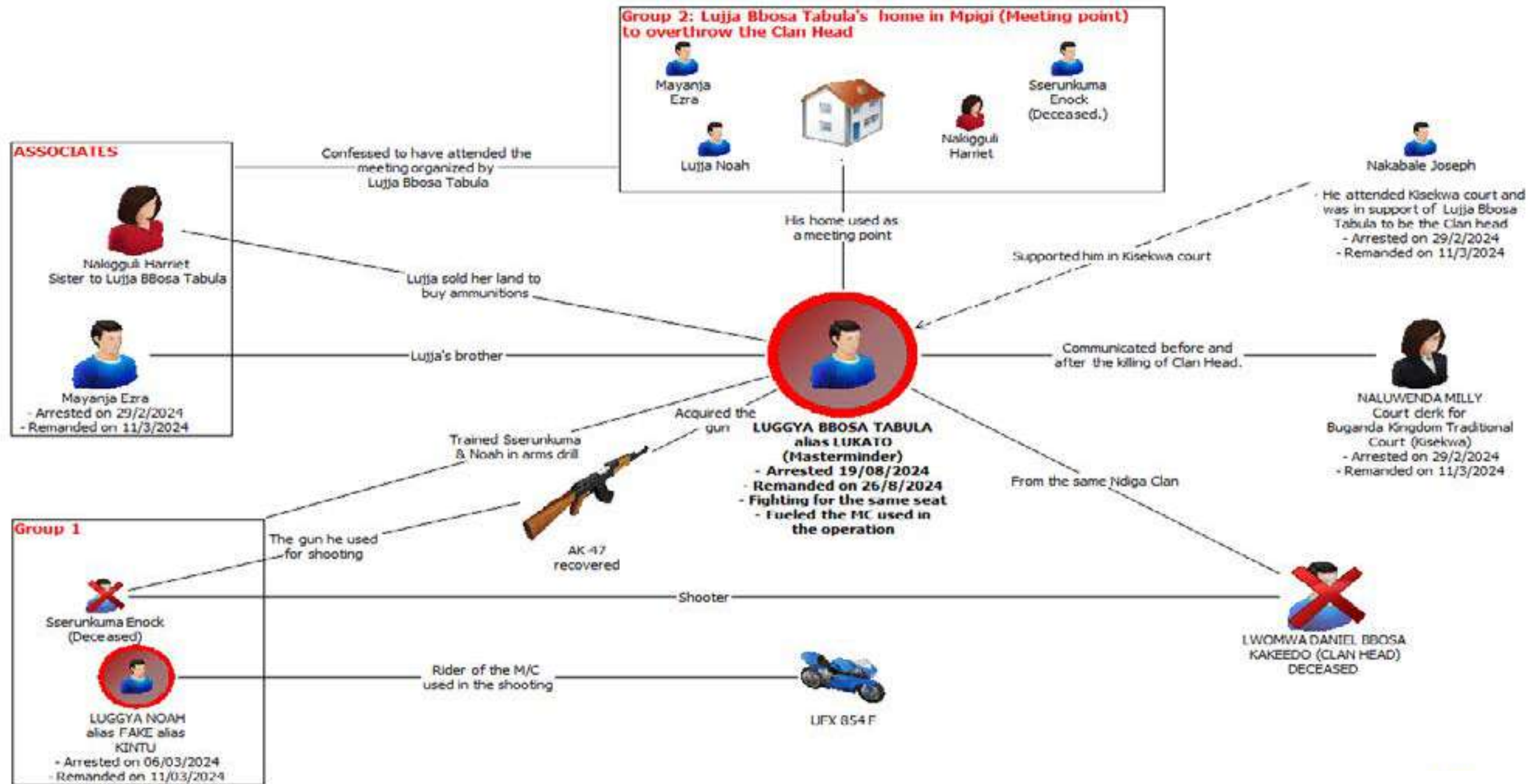


Figure 62: Operations Against the Aggravated Robbery in Jinja District

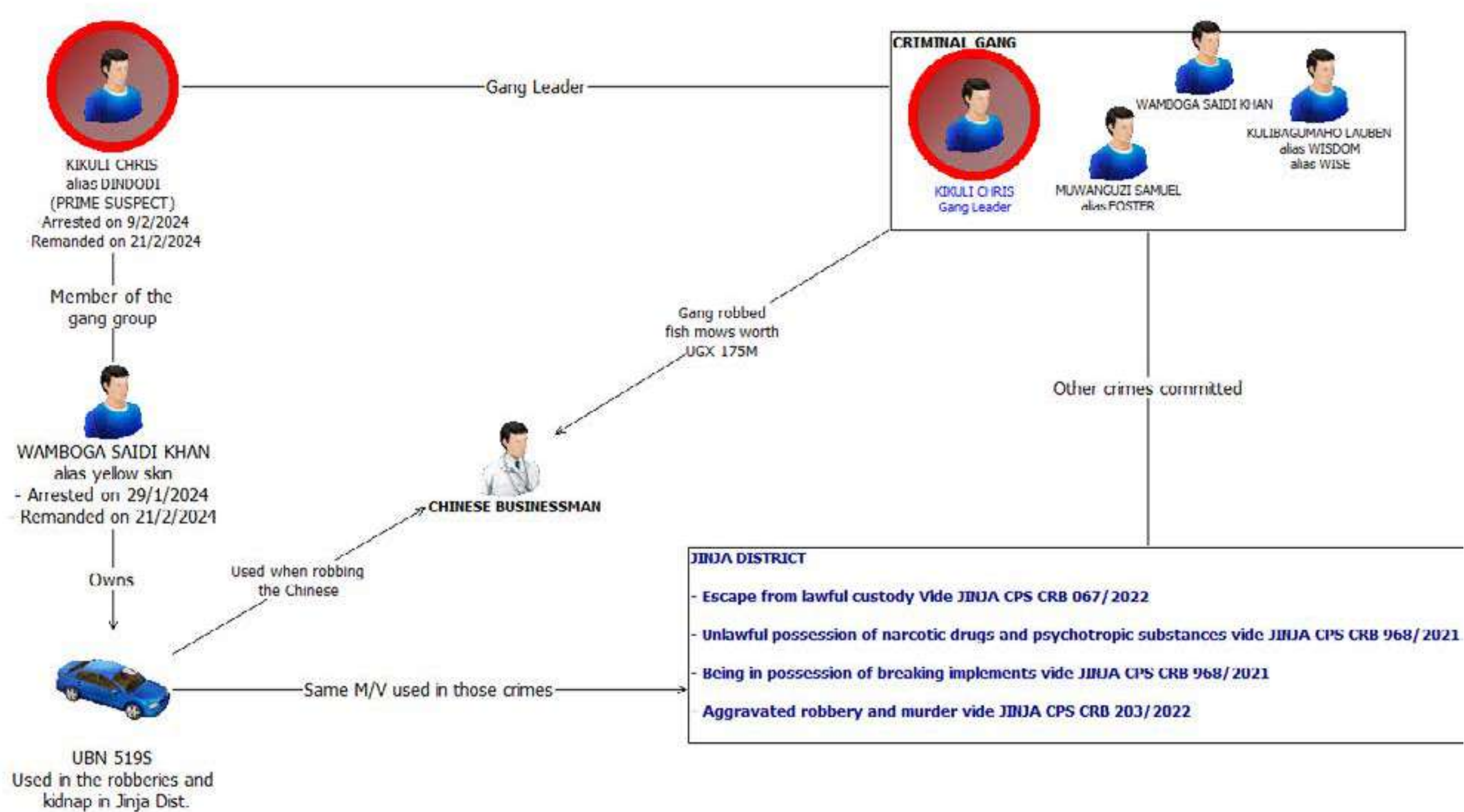


Figure 63: Operations Against the Murder of Dr. Abiriga Jino, the DHO Masindi

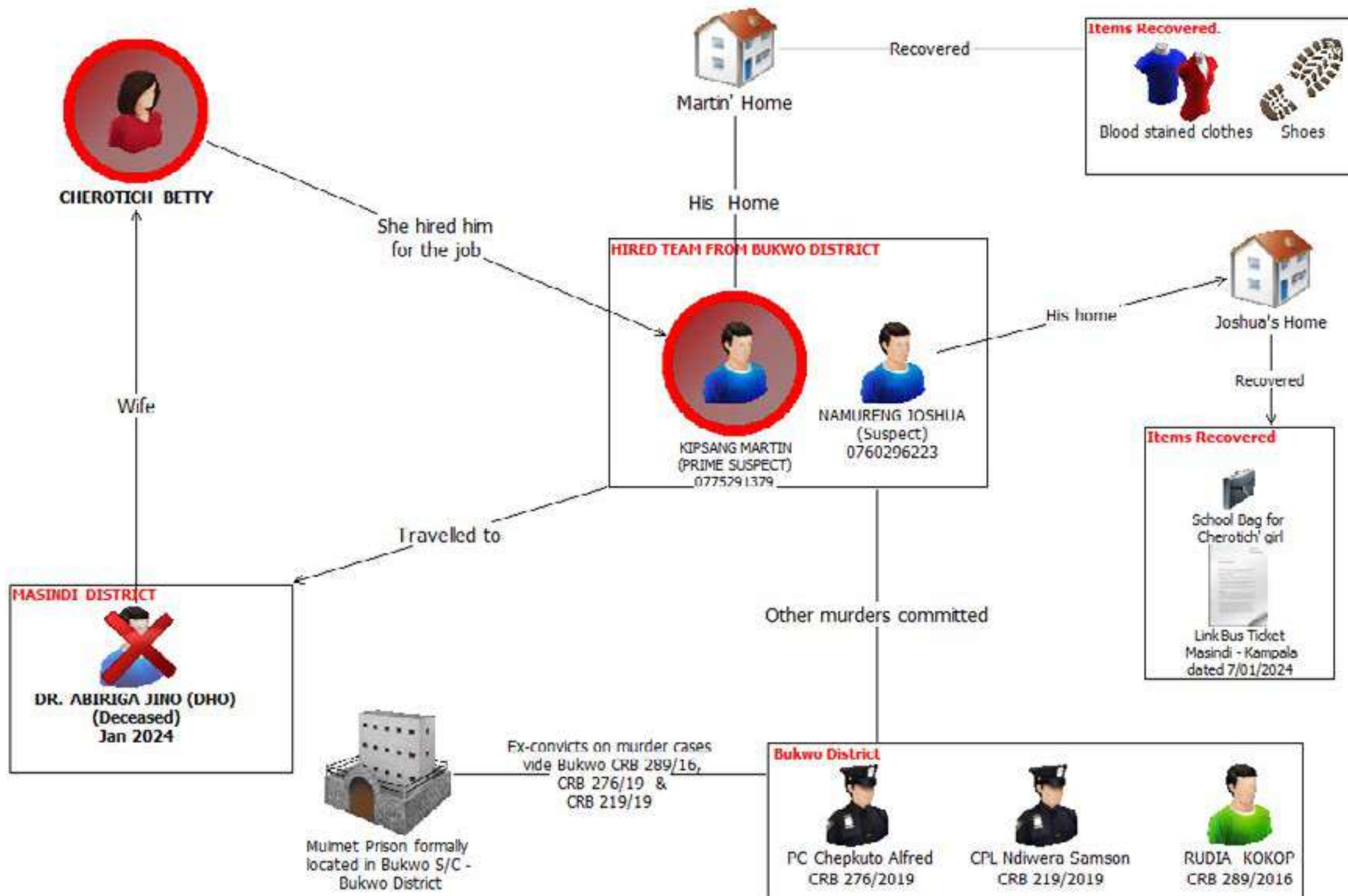


Figure 64: Operations Against the Murder of Nsamba Arafat in Kasangati Division

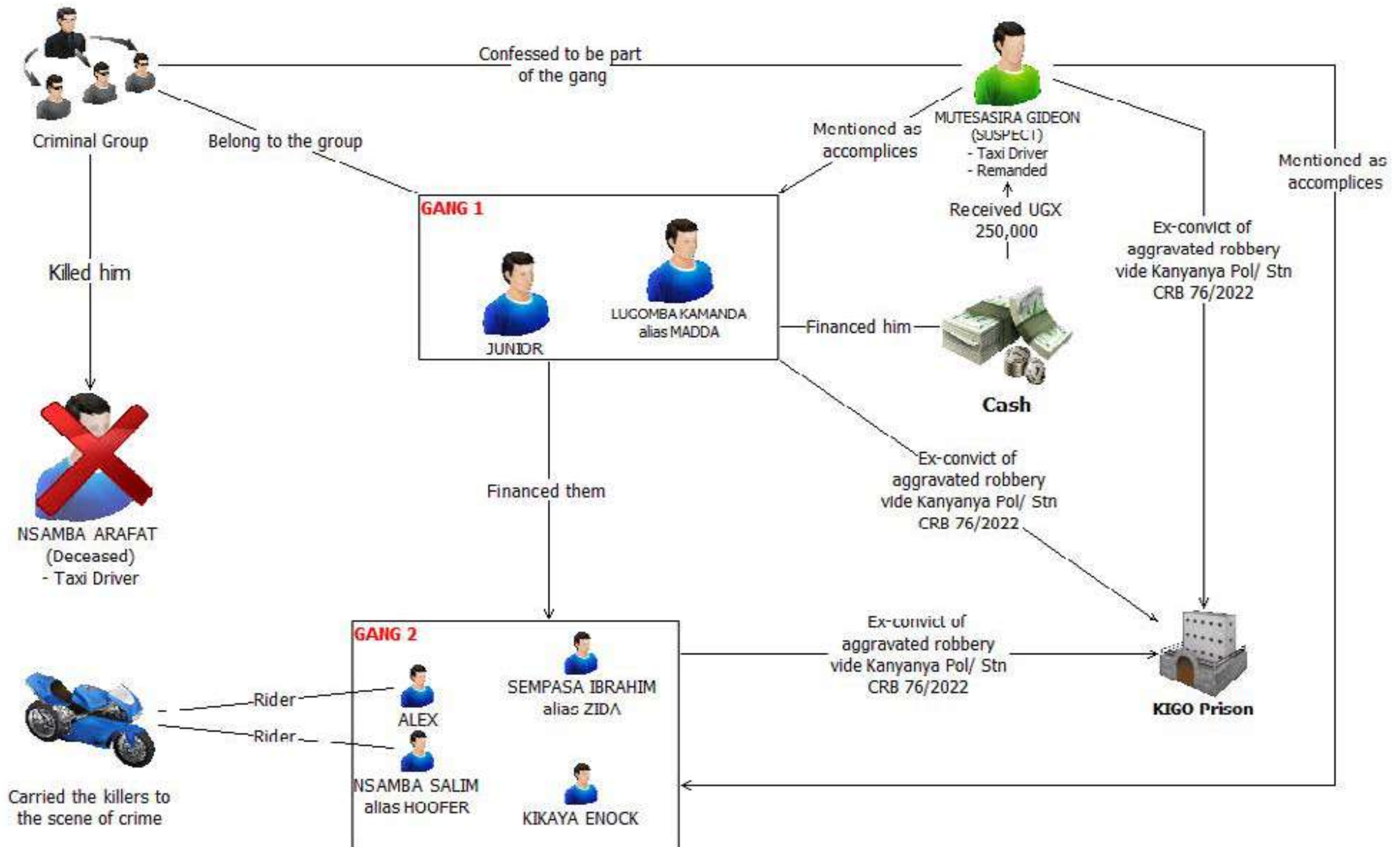


Figure 65: Operations Against the Murder of Females in Kajjansi Division

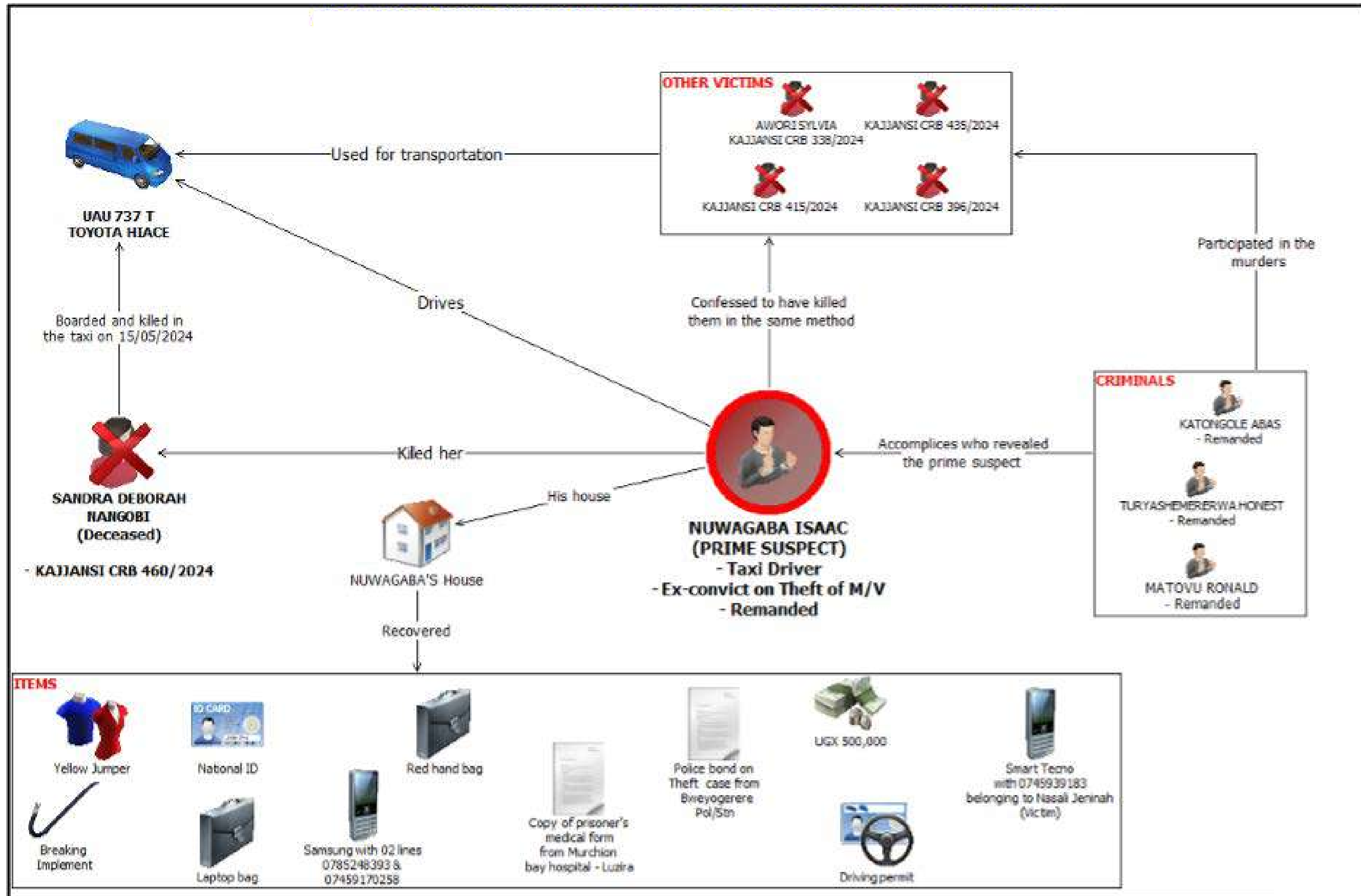
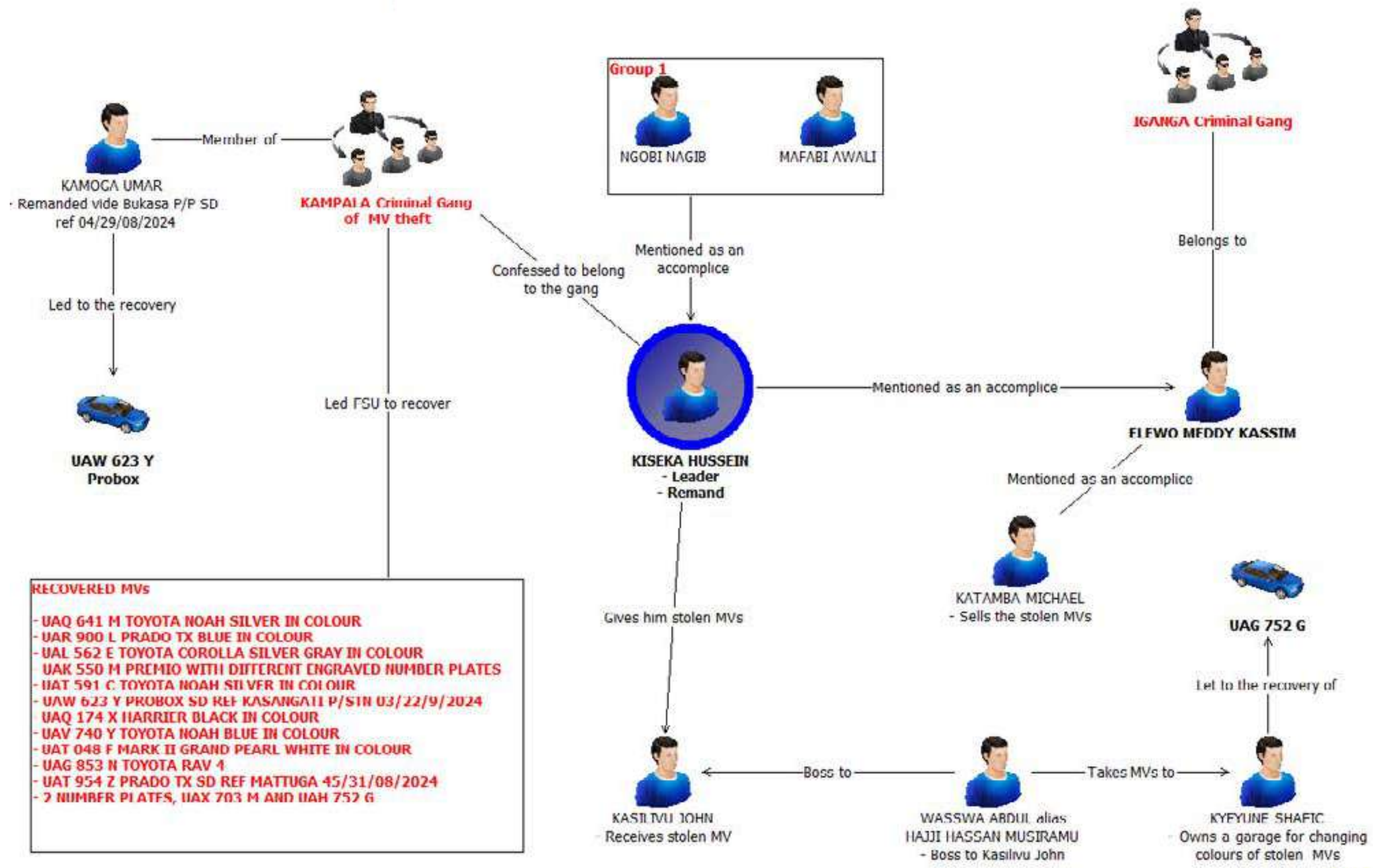
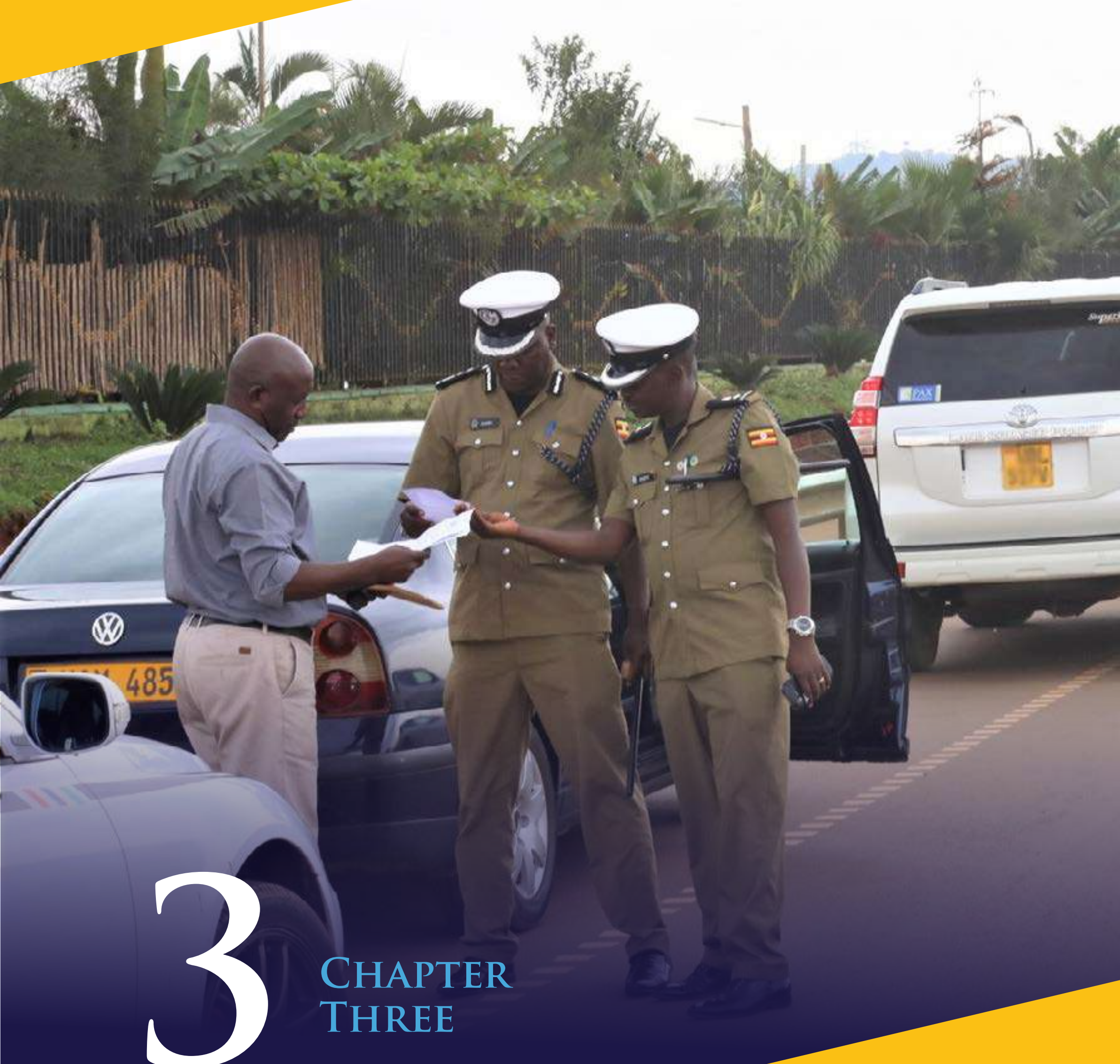


Figure 66: Operations Against Motor Vehicle Thefts

CHAPTER THREE

3.0 TRAFFIC AND ROAD SAFETY

3.1 Nature of Road Traffic Crashes

The number of reported road crashes increased by **6.4%** in 2024, from **23,608** in 2023 to **25,107** in 2024. The number of reported fatal crashes also increased by **6.1%**, from **4,179** in 2023 to **4,434** in 2024. The number of serious crashes increased by **5.2%**, from **12,487** in 2023 to **13,134** in 2024. The number of minor crashes increased by **8.6%** from **6,942** in 2023 to **7,539** in 2024.

3.2 Victims/Casualties of Road Crashes

There were **25,808** casualties from road crashes in 2024 compared to **24,728** in 2023, giving a **4.4%** increase in the number of casualties.

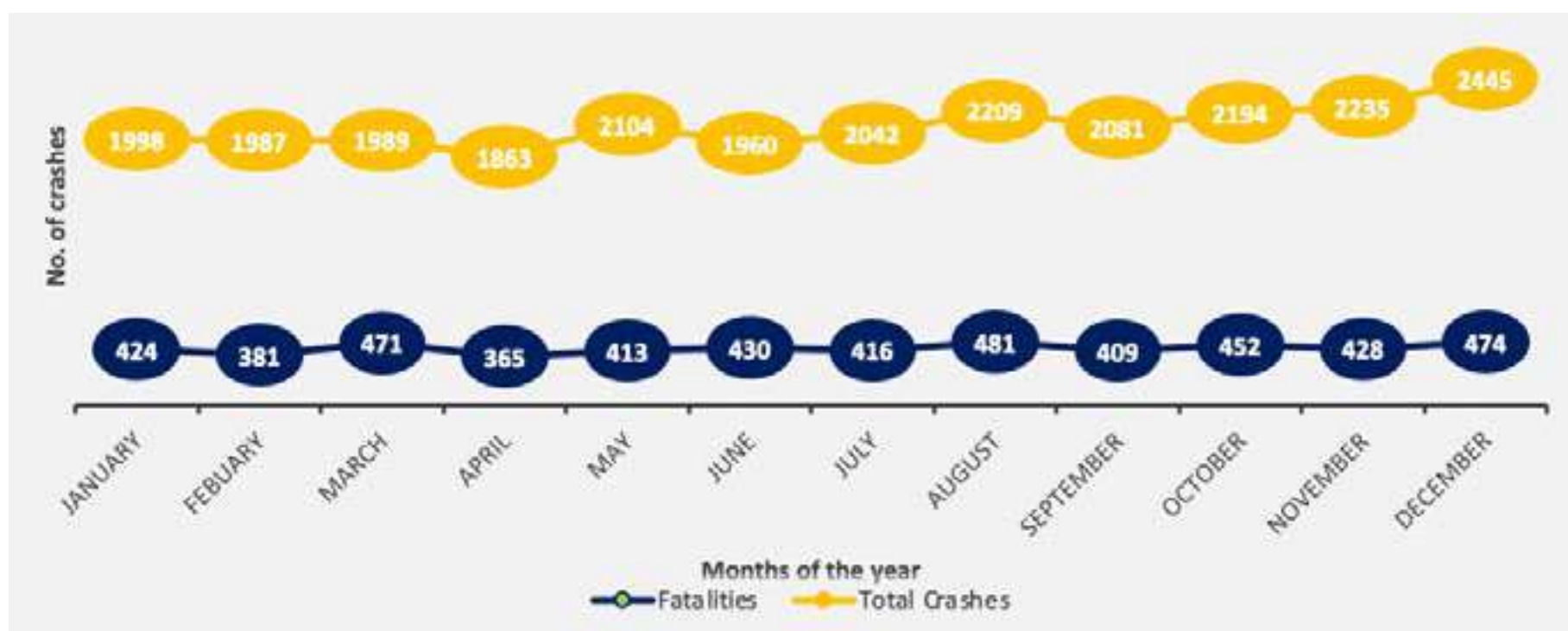

Figure 69: Crashes by Time of Day



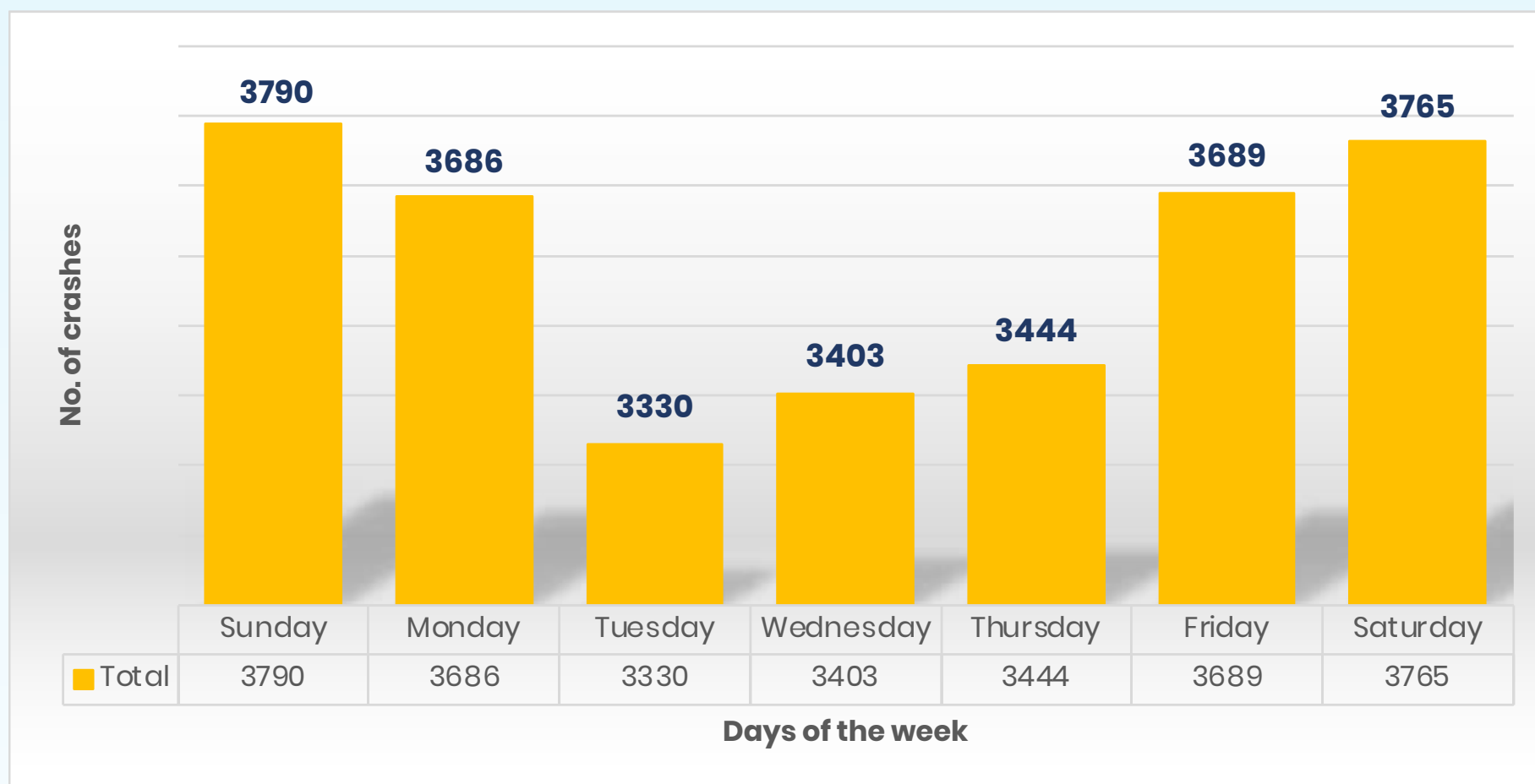
Figure 70: Fatal Crashes by Time of Day

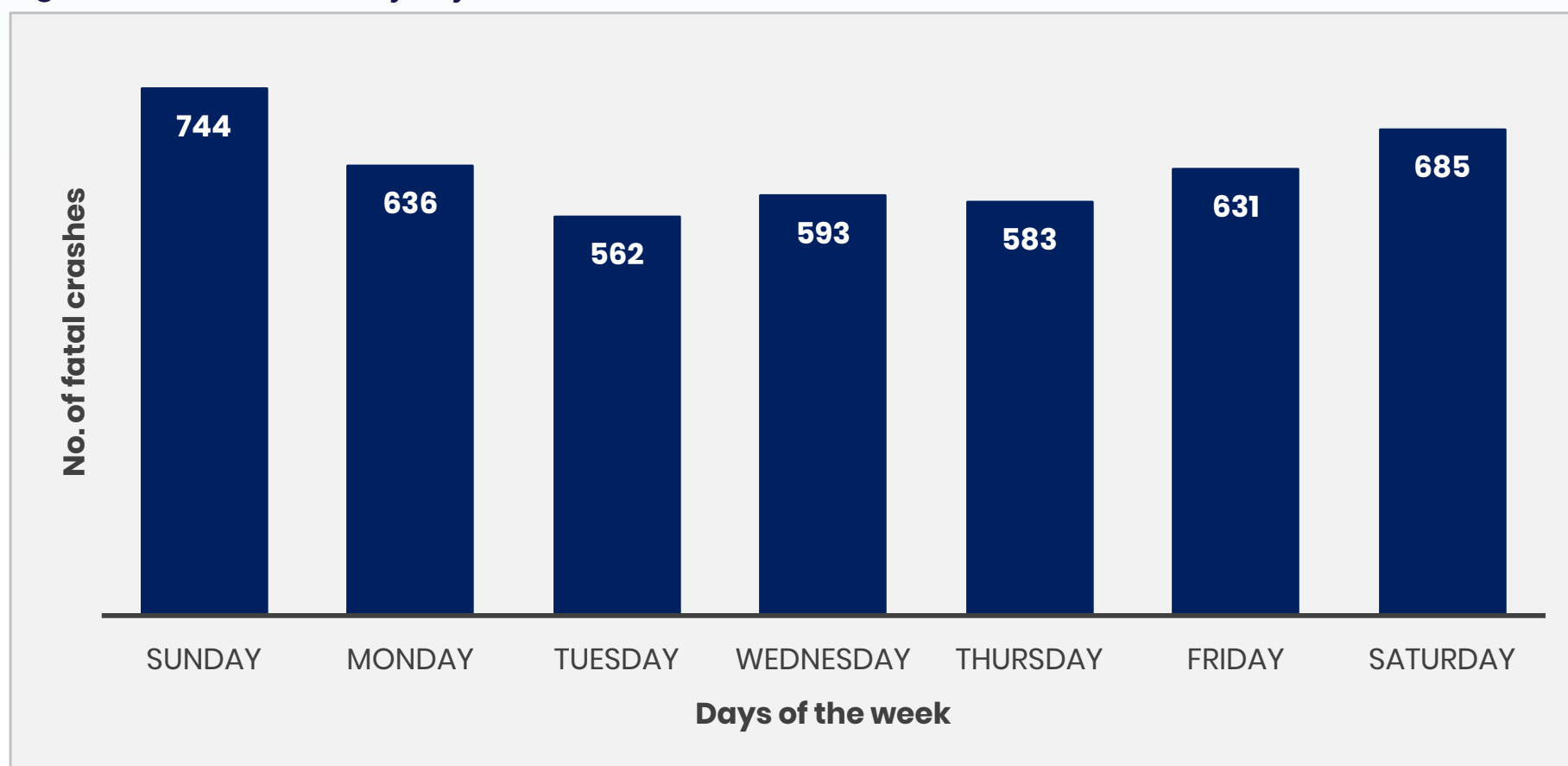
Figure 71: Crashes by Day of Week

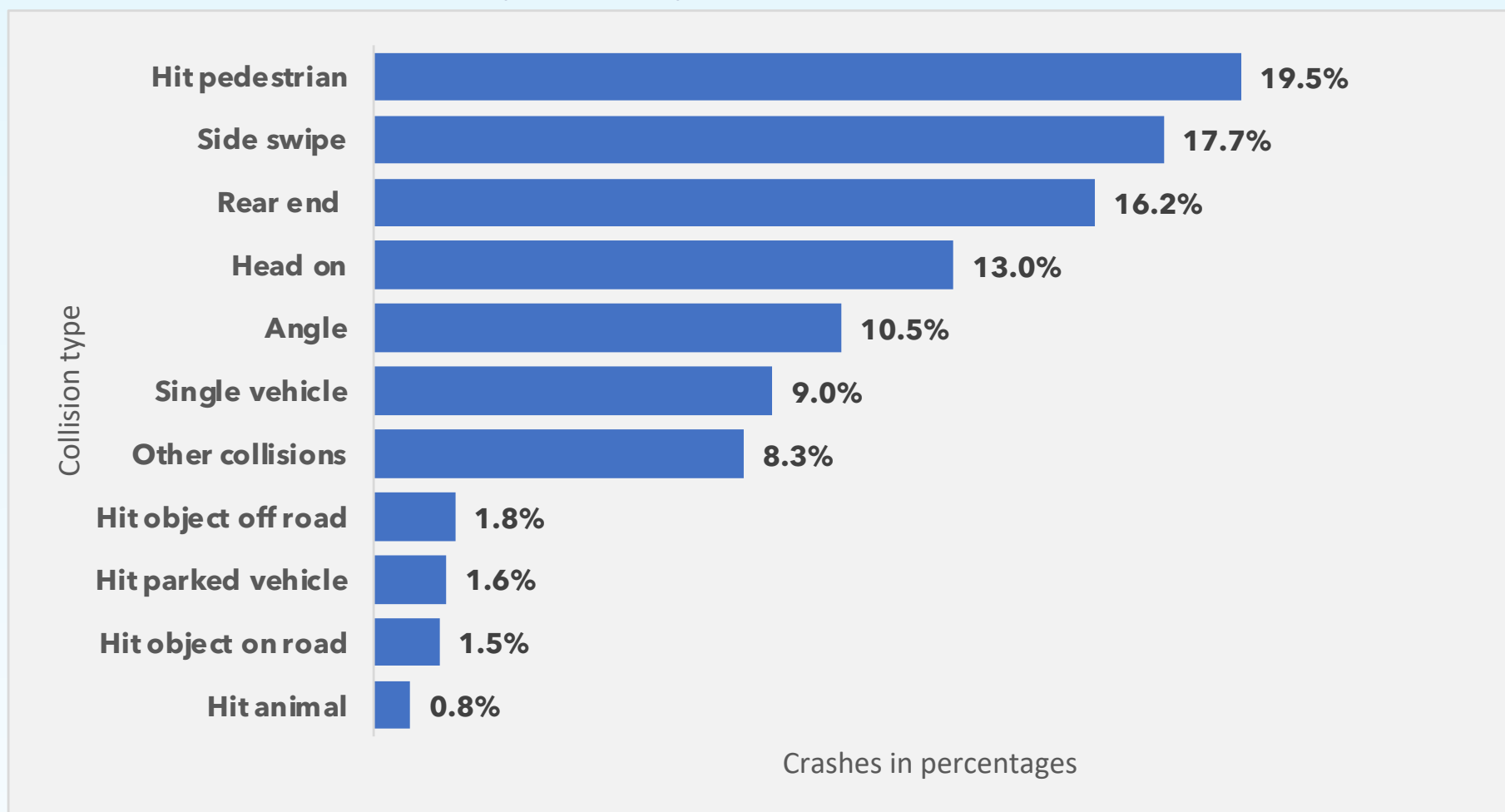
Figure 72: Fatal Crashes by Day of Week

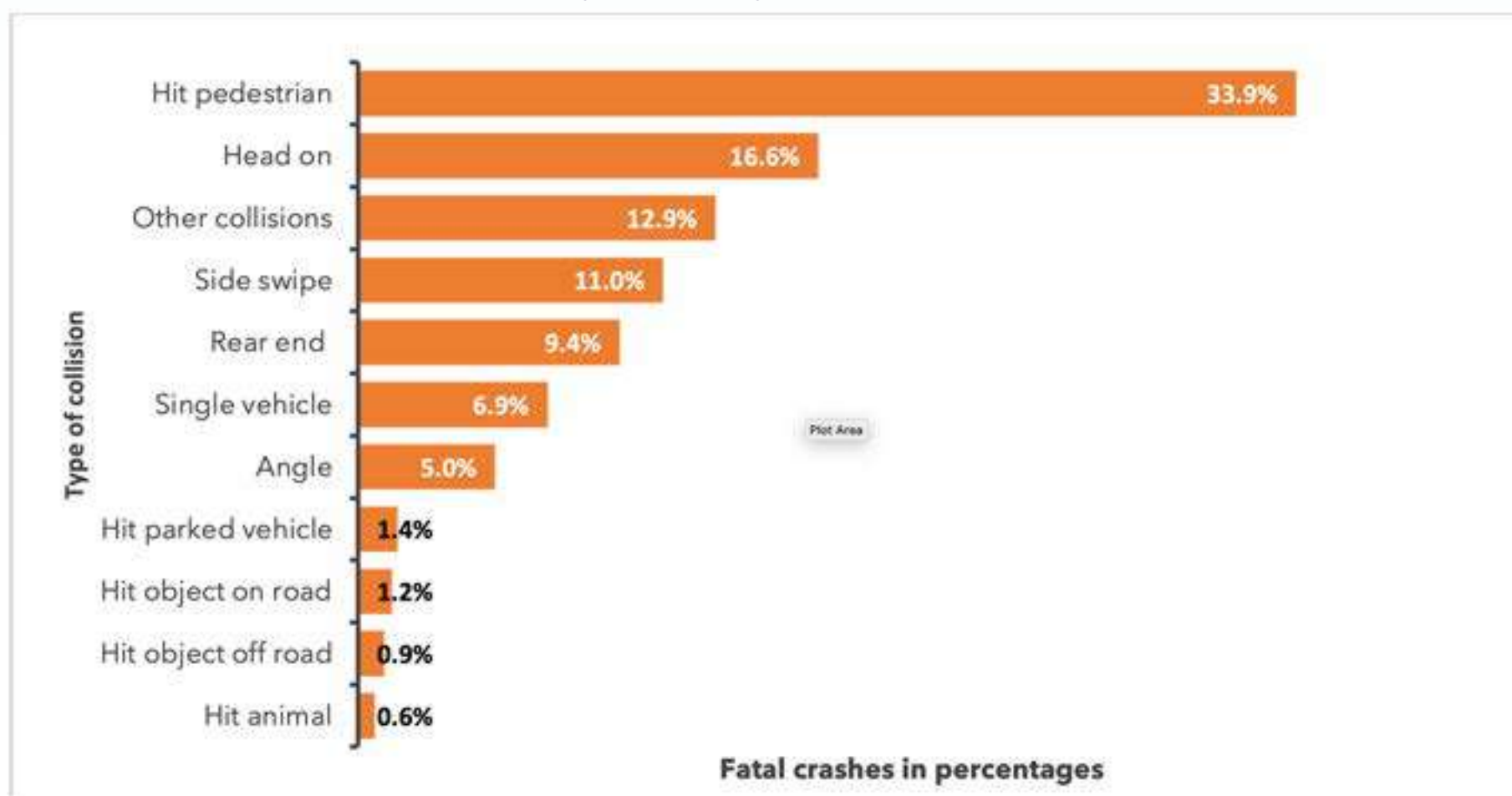
Figure 73: Percentage of Crashes by Collision Type



Collisions with pedestrians constituted **19.5%** of all crashes. Rear end collisions and side swipes accounted for **16.2%** and **17.7%** respectively. Head on collisions accounted for **13%** and angle collisions for **10.5%** of all crashes. **9%** of all crashes were single vehicle crashes. Collisions where vehicles hit other parked vehicles, hit objects on road, hit objects off road and hit animals accounted for **1.6%**, **1.5%**, **1.8%** and **0.8%** respectively.

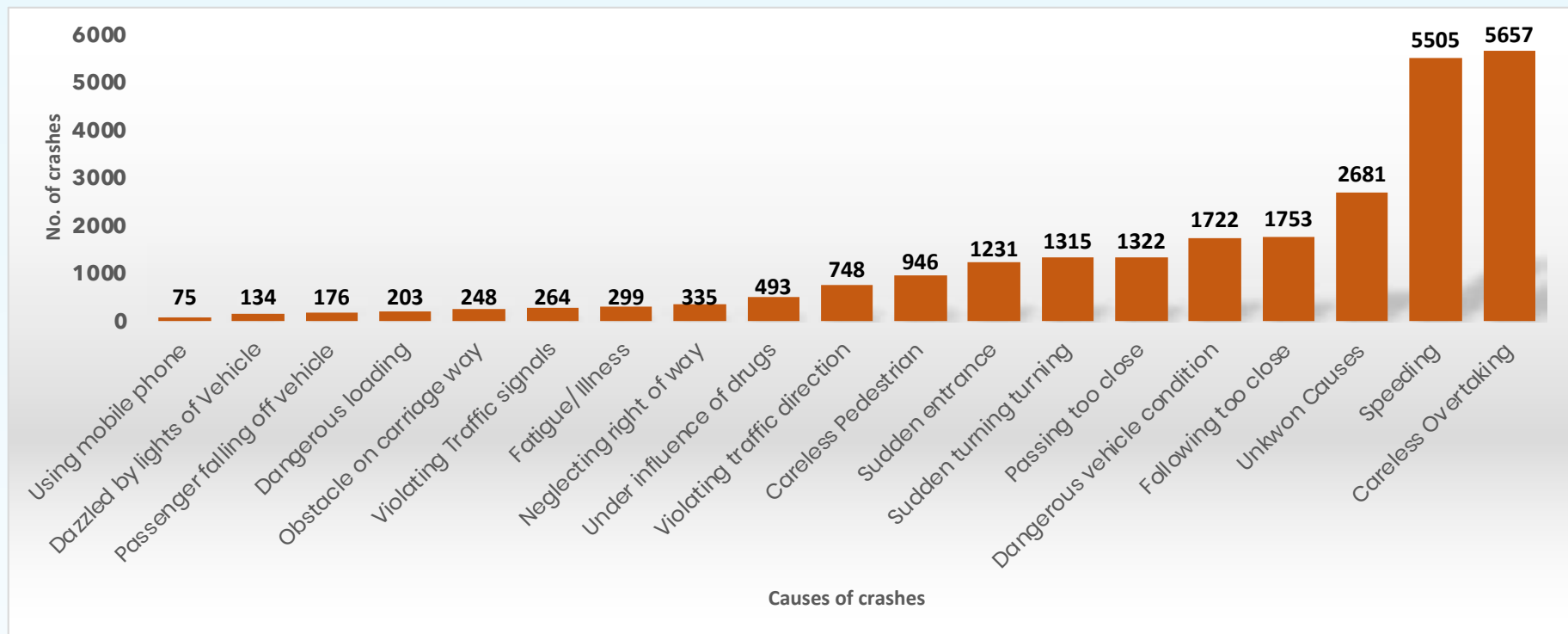
Figure 74: Percentage of Fatal Crashes by Collision Type



Collisions with pedestrians made up **33.9%** of all fatal crashes. Head on collisions constituted **16.6%** of fatal crashes. This means half of all fatal collisions involved vehicles hitting pedestrians and vehicles crashing head on. The percentages of fatal crashes involving side swipes and rear end collisions were **11%** and **9.4%** respectively. Angle collisions accounted for **5%** whereas single vehicle crashes were **6.9%**.

Careless Overtaking and Speeding were the leading causes of road crashes in the year 2024 accounting for close to almost half (**44.5%**) of all crashes.

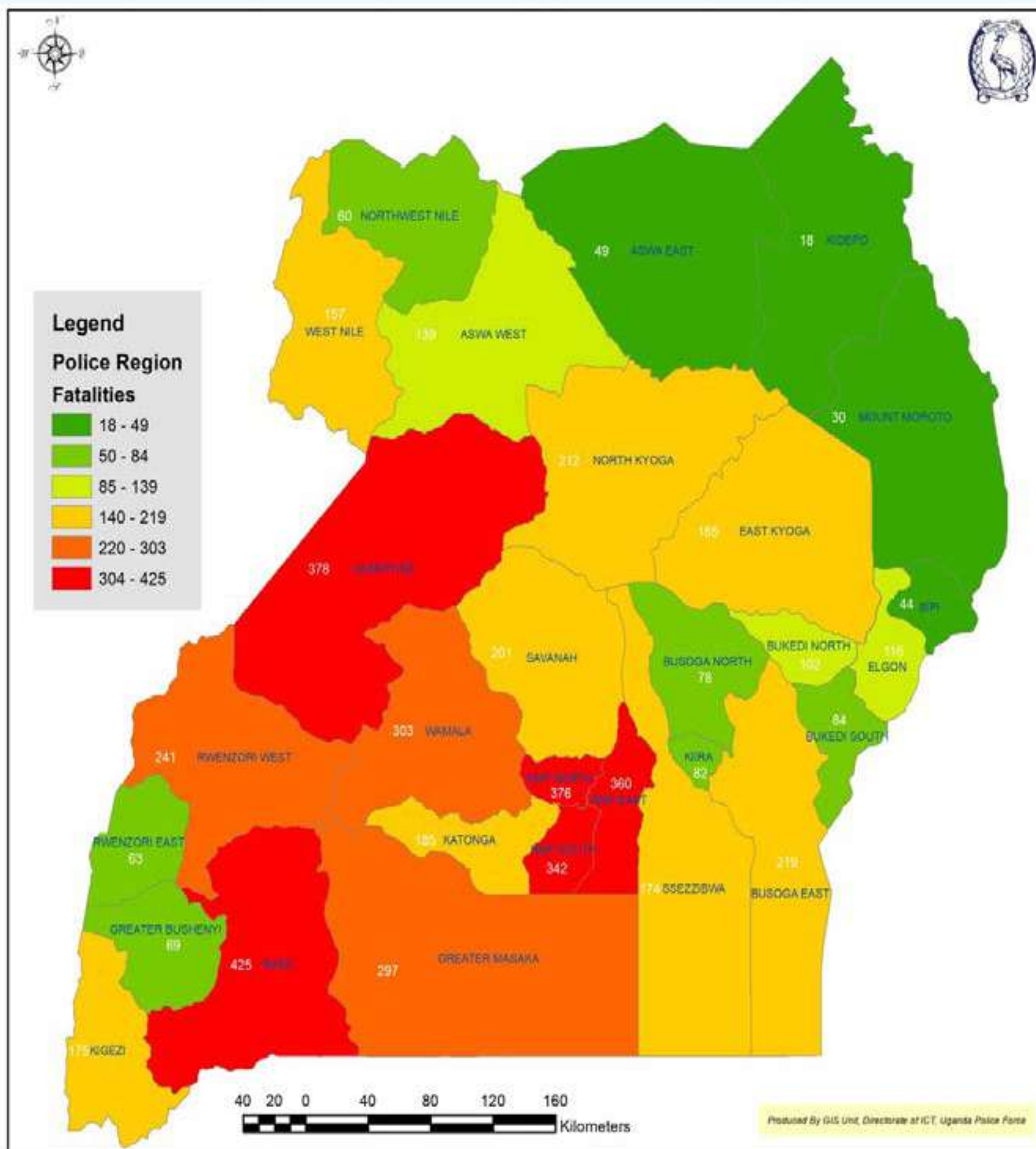


Distribution of Road Traffic Crashes by Police Region

3.9 Distribution of Fatalities by Police Region

The regions of Rwizi, KMP North, KMP East, KMP South, Albertine and Wamala recorded high number of fatal crashes between **303** and **425**. The Regions of Greater Masaka, Rwenzori West, Busoga East, North Kyoga and Savanna had fatal crashes ranging between **201** and **297**. The Regions of Katonga, Kigezi, Sezibwa, East Kyoga, Aswa West, West Nile, Elgon and Bukedi North recorded fatal crashes between **102** and **185**. The Regions of Kiira, Bukedi South, Busoga North, G/Bushenyi, Rwenzori East, North West Nile, Aswa East, Siipi, Mt. Moroto, and Kidepo registered the lowest number of fatal crashes between **18** and **84** as highlighted below.

Figure 76: Crash Fatalities by Police Region

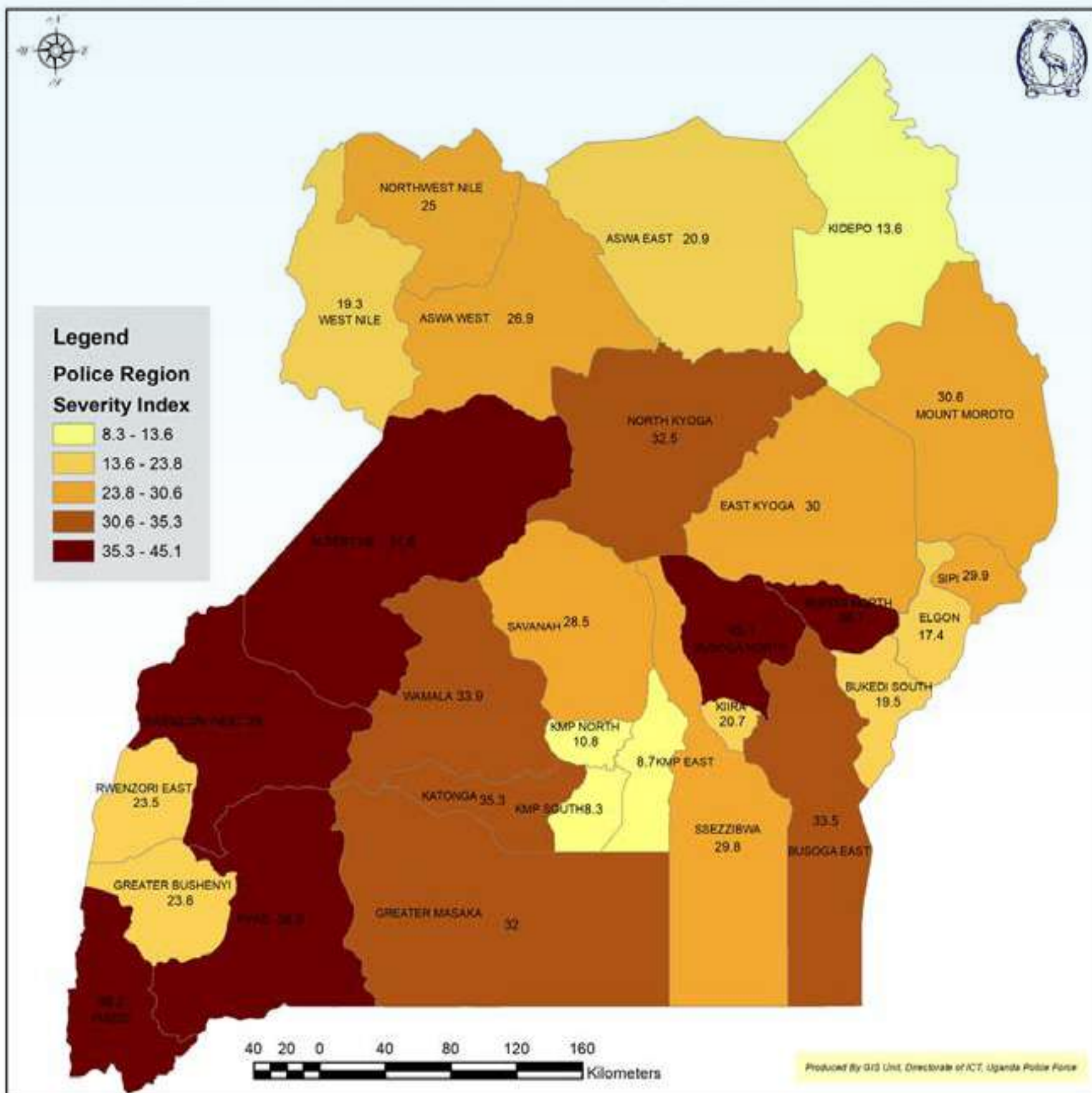




3.10 Crash Severity Index by Police Region

The Crash Severity Index measures the likelihood of having fatality/fatalities in any event of a crash happening. It is defined as a number of people killed per 100 crashes. The Crash Severity Index was highest in the regions of Busoga North, Rwenzori West, Rwizi, Kigezi, Albertine, Bukedi North, Katonga, Wamala, Busoga East, North Kyoga, G/Masaka, Mt. Moroto and East Kyoga where between **30-45** people died in every **100** road crashes. These were followed by the Regions of Sipi, Sezibwa, Savanna, Aswa West, North West Nile, G/Bushenyi, Rwenzori East, Aswa East and Kiira where **20-29** people died in every **100** road crashes. The Regions of Bukedi South, Elgon, Kidepo and West Nile had a crash severity index between **13-19**. The Regions of KMP had the lowest crash severity index of **8-10**.

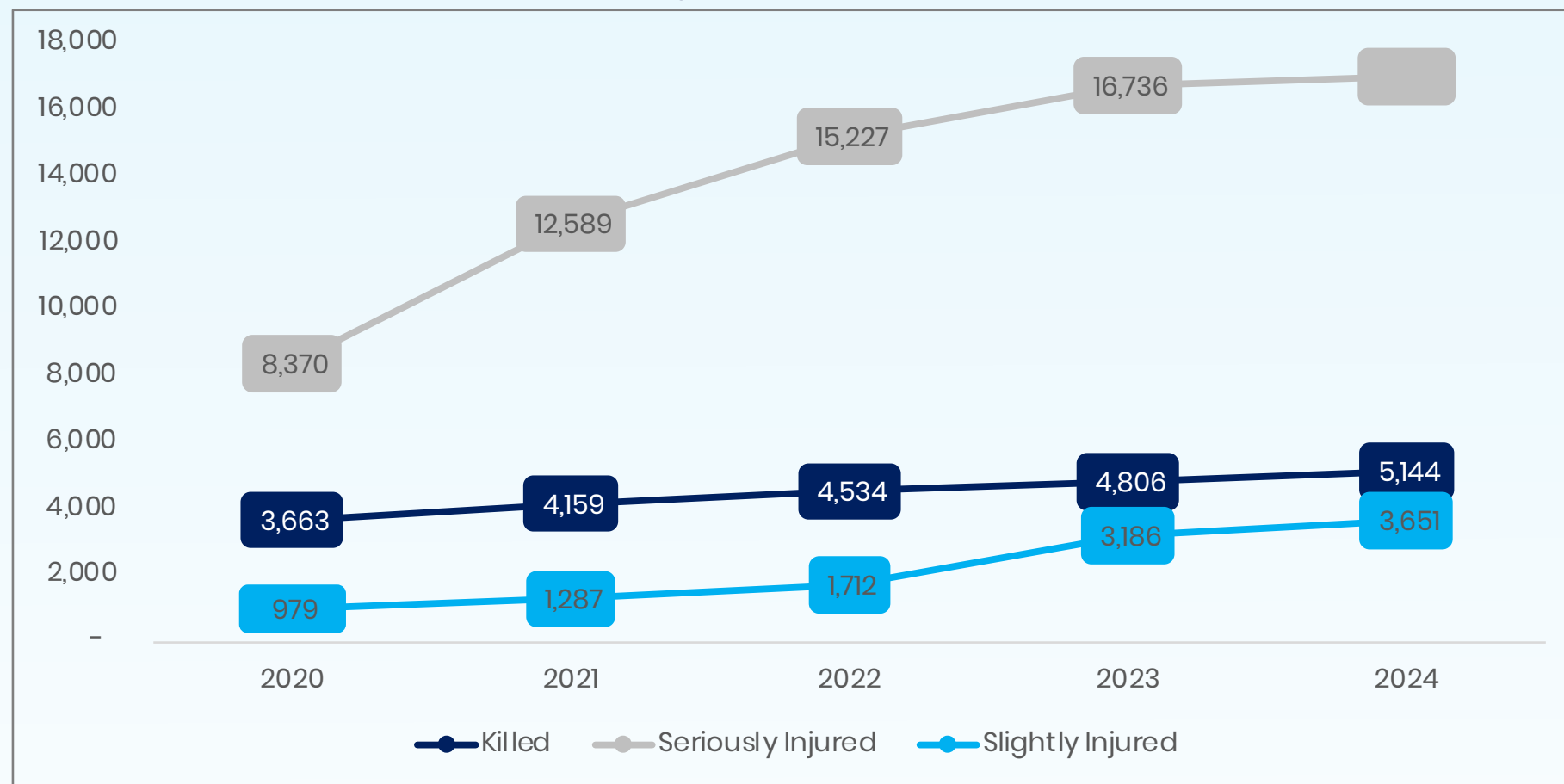
Figure 77: Crash Severity Index by Police Region



3.11 Road Traffic Deaths and Injuries

The number of reported fatalities in Uganda in the year 2024 increased by **7%**, from **4,806** in 2023 to **5,144** in 2024. The number of serious injuries decreased by **1.7%** from **16,736** in 2023 to **17,013** in 2024 and those that sustained minor injuries increased by **14.6%**, from **3,186** in 2023 to **3,651** in 2024.

3.12 Deaths and Serious Injuries by Road User Category

There was a **7%** increase in the number of people who died from **4,806** in 2023 to **5,144** in 2024. The fatalities in motorcyclists increased by **13.2%** from **1,520** in 2023 to **1,720** in 2024. Passengers on motorcycle who died in road traffic crashes increased by **10%** from **614** in 2023 to **676** in 2024. Passengers in Light Omnibuses who died in crashes increased by **55%** from 93 in 2023 to **144** in 2024. Also the passengers in other categories of vehicles that died in crashes increased by **35%** from **324** in 2023 to **438** in 2024.

However, the fatalities in passengers in heavy omnibus reduced by **38.9%** from **54** passengers in 2023 to **33** passengers in 2024 which is attributed to the step up in the enforcement of bus driver badges thus taming bus driver behaviour on roads. Relatedly, fatalities in passengers in medium omnibus, passengers on tricycles, drivers, pedal cyclists and pedestrians.

Vulnerable road users: motorcyclists, pedestrians, and pedal cyclists - made up **84%** of the reported deaths in the year 2024. Motorcyclists together with their passengers alone accounted for **47%** of these deaths, while pedestrians accounted for **34%**. Vehicle occupants accounted for **16%** of all road traffic deaths while pedal cyclists accounted for **3%** in 2024.

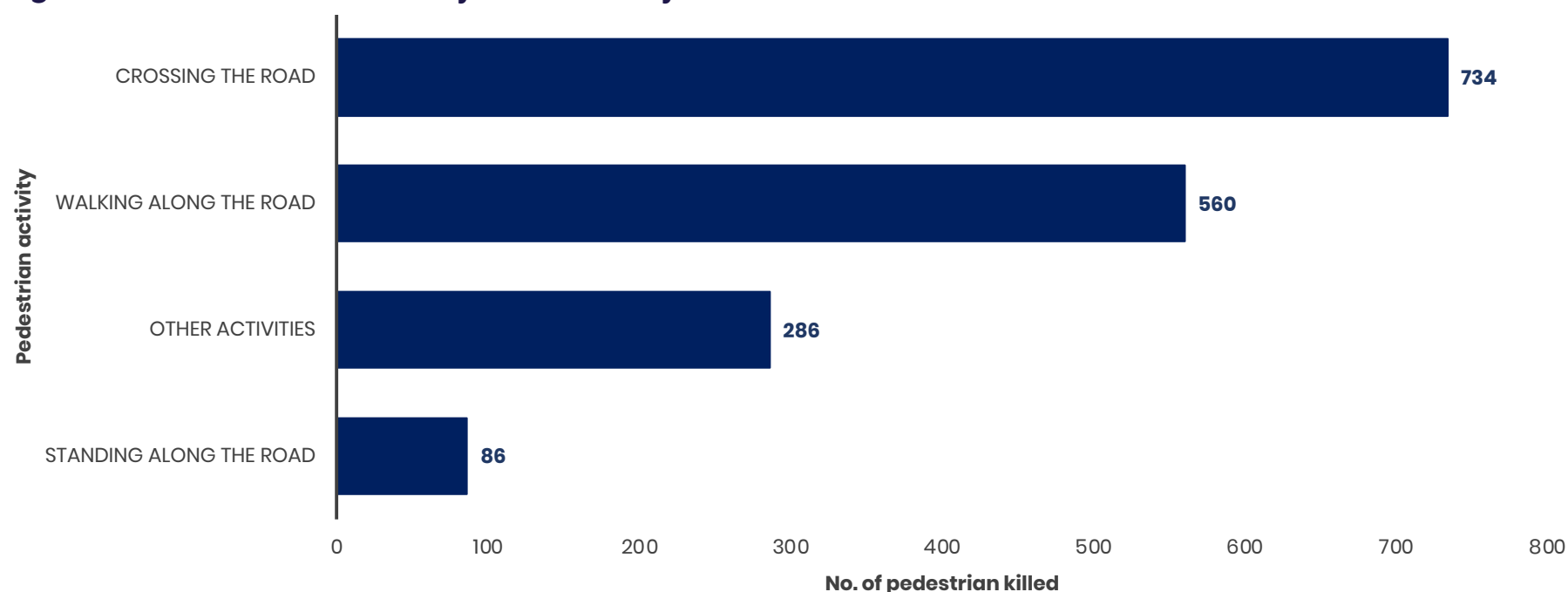
Figure 79: Percentage Distribution of Deaths by Road User Category, 2024



3.12.1 Pedestrian Fatalities by Road Activity

734 pedestrians (representing **44%**) were knocked while crossing the road. In addition, **560** pedestrians died (**33.6%**) while walking along the road. **86** pedestrians were fatally knocked down while standing along the road.

Figure 80: Pedestrian Deaths by Road Activity

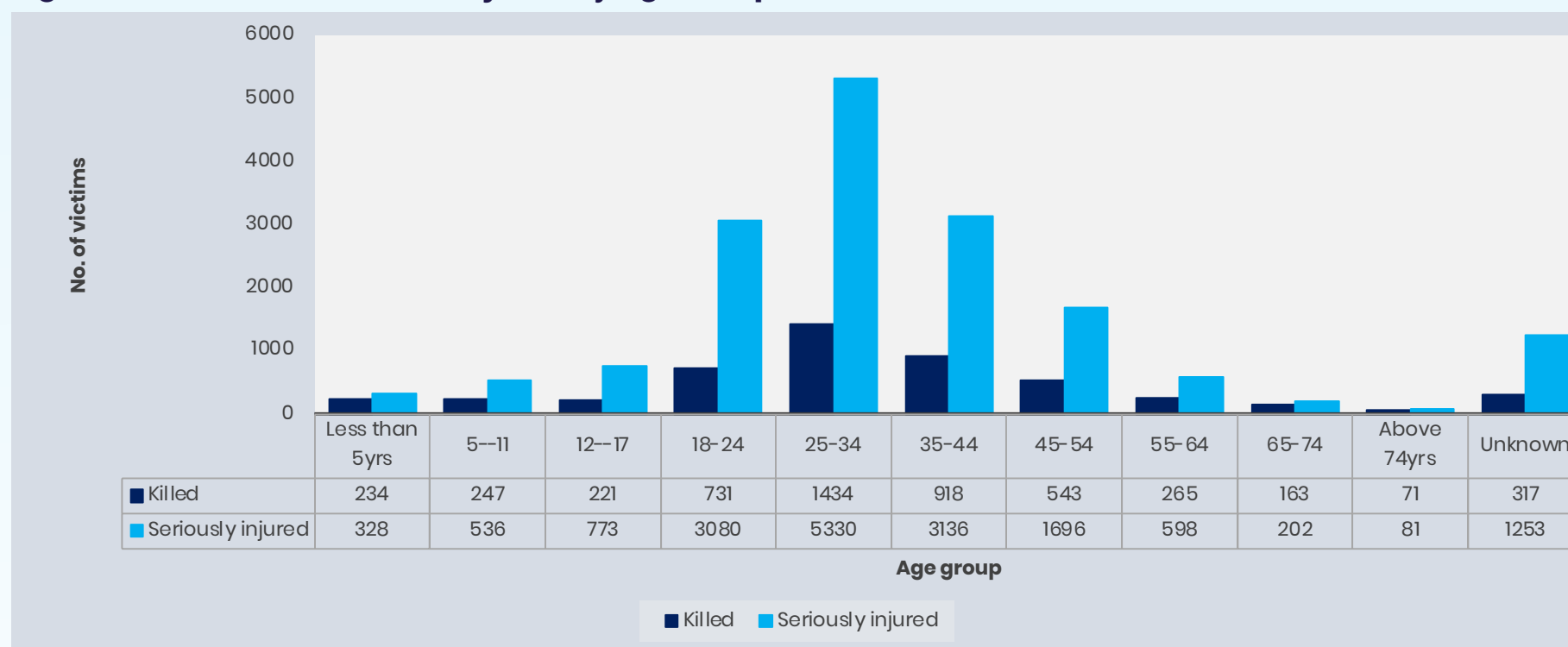


286 (17.2%) pedestrian deaths happened while they were other activities like cleaning, jogging and exercising.

3.12.2 Deaths and Serious Injuries by Age Group

More fatalities were recorded for persons below the age of 35 years – accounting for **55.7% (2,867)** of all fatalities. **1.4%** of fatalities were recorded for persons aged over 75 years. The age for **317** victims was unknown. There were more victims seriously injured below the age of 35 years at **59% (10,047)** and other age groups constituted **41%**.

3.13 Common Traffic & Road Safety Offences and Number of Offenders Handled

A total of **426,432** traffic offenders were arrested for various offences compared to **528,025** offenders in 2023, giving a **19.2%** decrease in the number of Traffic & Road Safety offenders.

Among the leading offences, Using a motor vehicle which is not in good condition on the road had the highest number of offenders with **84,156** followed by Careless or Inconsiderate Use of a Motor Vehicle with **67,418** offenders, Riding a motorcycle without a valid driving permit with **41,643** offenders, Driving without a valid driving permit with **38,935** offenders while, Using or permitting use on the road a motor vehicle, trailer or engineering plant without any insurance law for that use had **35,313** offenders as illustrated below.

3.14 Strategies to Reduce Road Crashes

Enforcement of traffic laws and regulations through targeted operations mainly focusing on speeding, boda-boda riders to wear crash helmets and reflective jackets, operations against drivers especially of government vehicles who use one way and have installed swiveling lights on their vehicles, speed enforcement operations and inspection of vehicles suspected to be in a dangerous mechanical condition

Capacity Building of Traffic Personnel

The Directorate of Traffic and Road Safety with support from Bloomberg Philanthropies for Global Road Safety together and Global Road Safety Partnership (GRSP) carried out a number of trainings to build capacity of the officers in the various areas.

Road Safety Awareness

The Directorate has carried out a number of sensitisation activities with particular focus to vulnerable road users who include riders, pedestrians, school children and market vendors.

A total number of **34** television talk shows, **320** radio talk shows and **830** physical engagements have been carried out during this period.

Digitisation of the Road Crash Database System

The Directorate carried out digitisation of the Road Crash Data using the survey 123 software tool. Officers from nine Police Stations within Kampala Metropolitan were trained on using the tool for data collection and entry. This application will help the directorate to know the exact location where crashes are happening in order to deploy its resources appropriately and also carry out targeted enforcement.

Community Engagements

The regions all over the country conducted community engagements to bring the public closer to traffic police. This engagement involved Local Council Leaders, Religious Leaders, Community-based Organisation in a bid to take Road Safety to the grassroots.

CHAPTER FOUR

4.0 FIRE PREVENTION AND RESCUE SERVICES

There was a **13.8%** increase in the number of fires reported from **1,104** in 2023 to **1,280** in 2024. Out of the cases reported, **1,150** were successfully handled, **120** were handled before arrival and **10** were false fictitious fires. **67%** of the fires were reported between 0600hrs and 1200hrs and **33%** were reported between 0001hrs to 0600hrs.

Majority of fires were registered in residential buildings followed by makeshift structures with a total number of **300** and **250** respectively. There was a **9%** increase in school fires from **50** cases in 2023 to **55** cases in 2024.

The major cause of most fires was electricity-related ranging from electrical short circuits (**270**), to electrical appliances left unattended totalling to (**111**) followed by negligence and misuse of wax candles (**217**) among others. Majority of fire occurrences were in Kampala Metropolitan Region with **993** cases.

Fuel fires drastically reduced from **13** cases in 2023 to **03** cases in 2024. Of the **03** cases. The Kigoogwa fuel tank fire that happened on 22nd October 2024 claimed **38** lives.

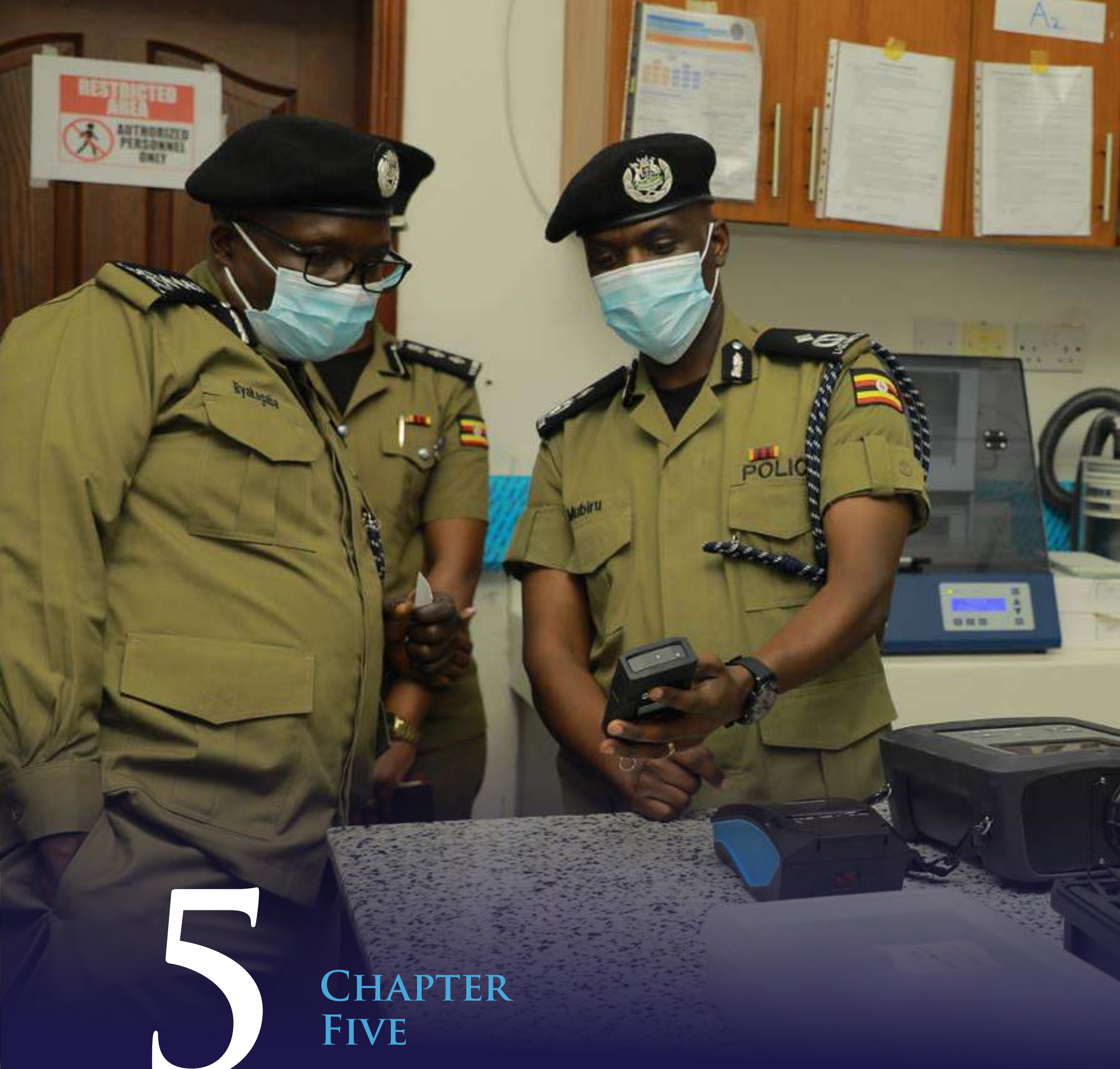

CHAPTER FIVE

5.0 FORENSIC SERVICES

A total of **2,994** requests were received for forensic assistance in 2024. The Directorate released **1,805** expert reports and issued **151,352** Police clearance certificates. **42,416** crime scenes were processed marking an increase of **3,375** from the **39,041** crime scenes processed in 2023. The laboratory had an overall clearance rate of approximately **60.3%** down from **60.8%** in 2023.

The Department of Questioned Documents issued the most forensic reports with a total of **627** (**463** criminal and **164** civil) reports, followed by Digital forensics with **446** (**431** criminal and **15** civil) reports issued. The department that issued the least reports was CBRNE-A with **256** reports issued.

5.1 Forensic Reports

The Department of Questioned Documents issued the most forensic reports with a total of **627** reports followed by the Cyber Crime Department with **446**. The CBRNE-A Department issued the fewest number of reports (**256**) as shown in the figure below.

Figure 82: Forensic Reports Issued per Department Following Requests for Forensic Analysis

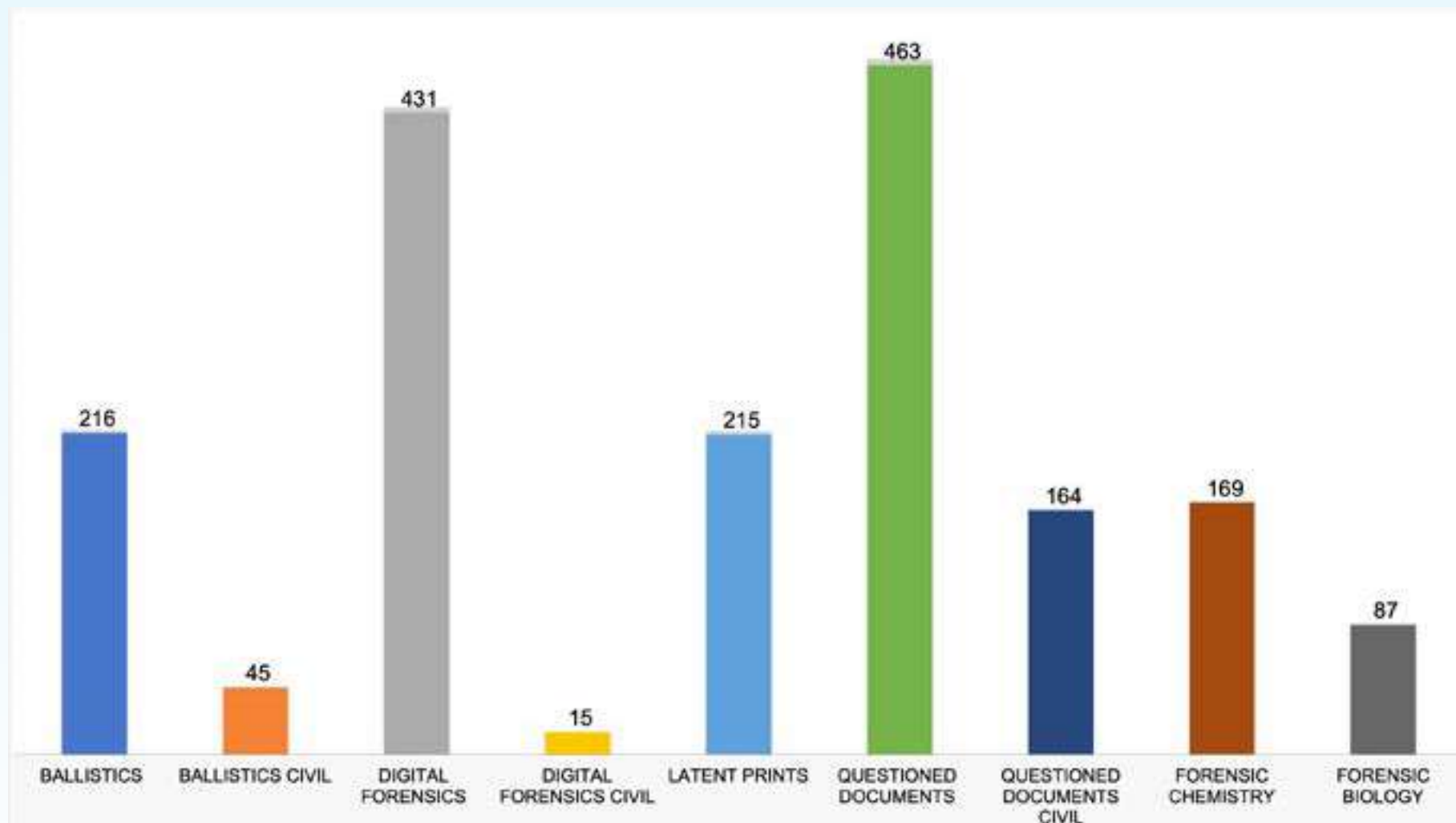
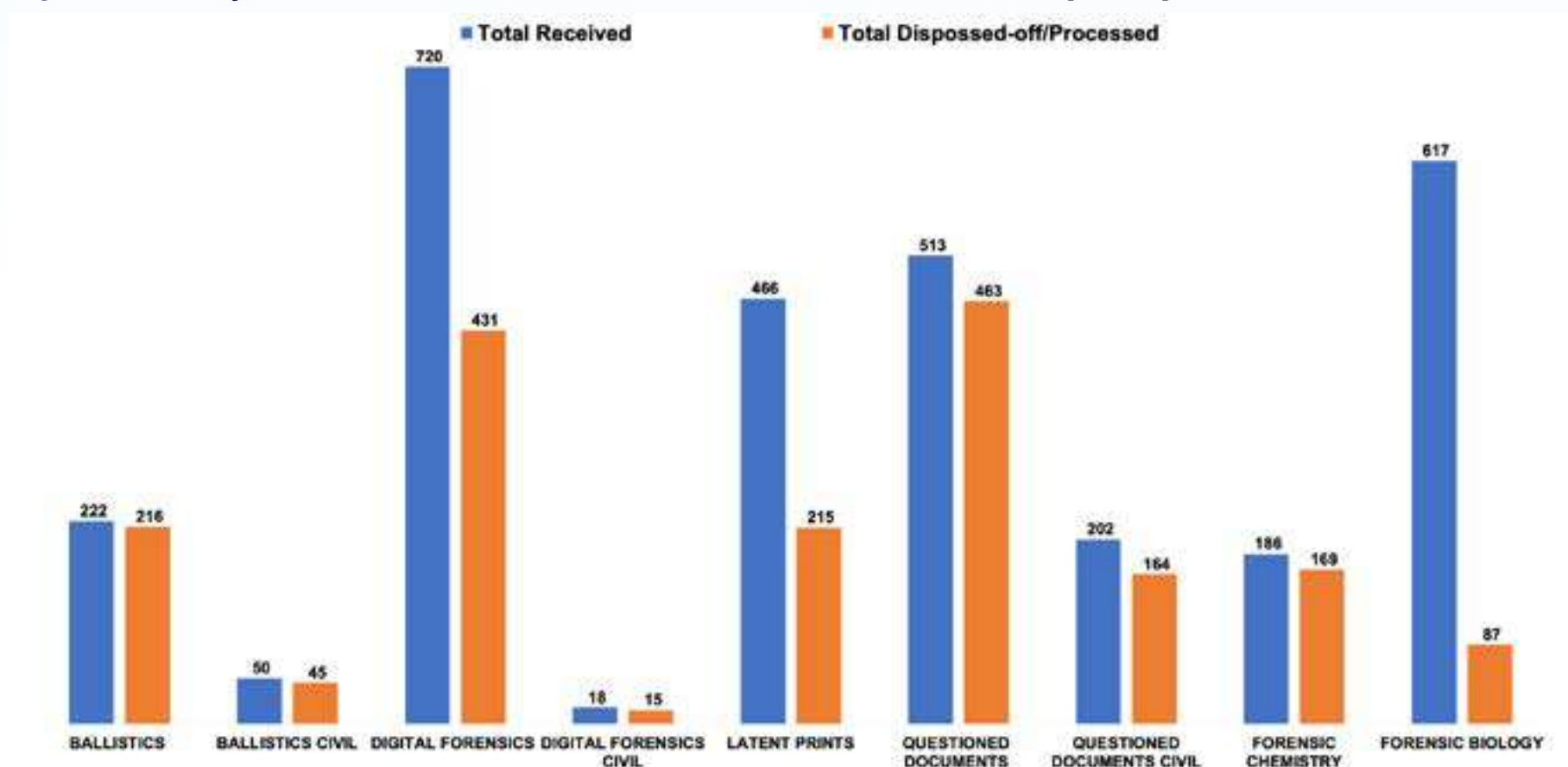


Figure 83: Analysis of Cumulative Cases Received and Cases Processed per Department

Figure 84: Crime Scenes Processed per Month

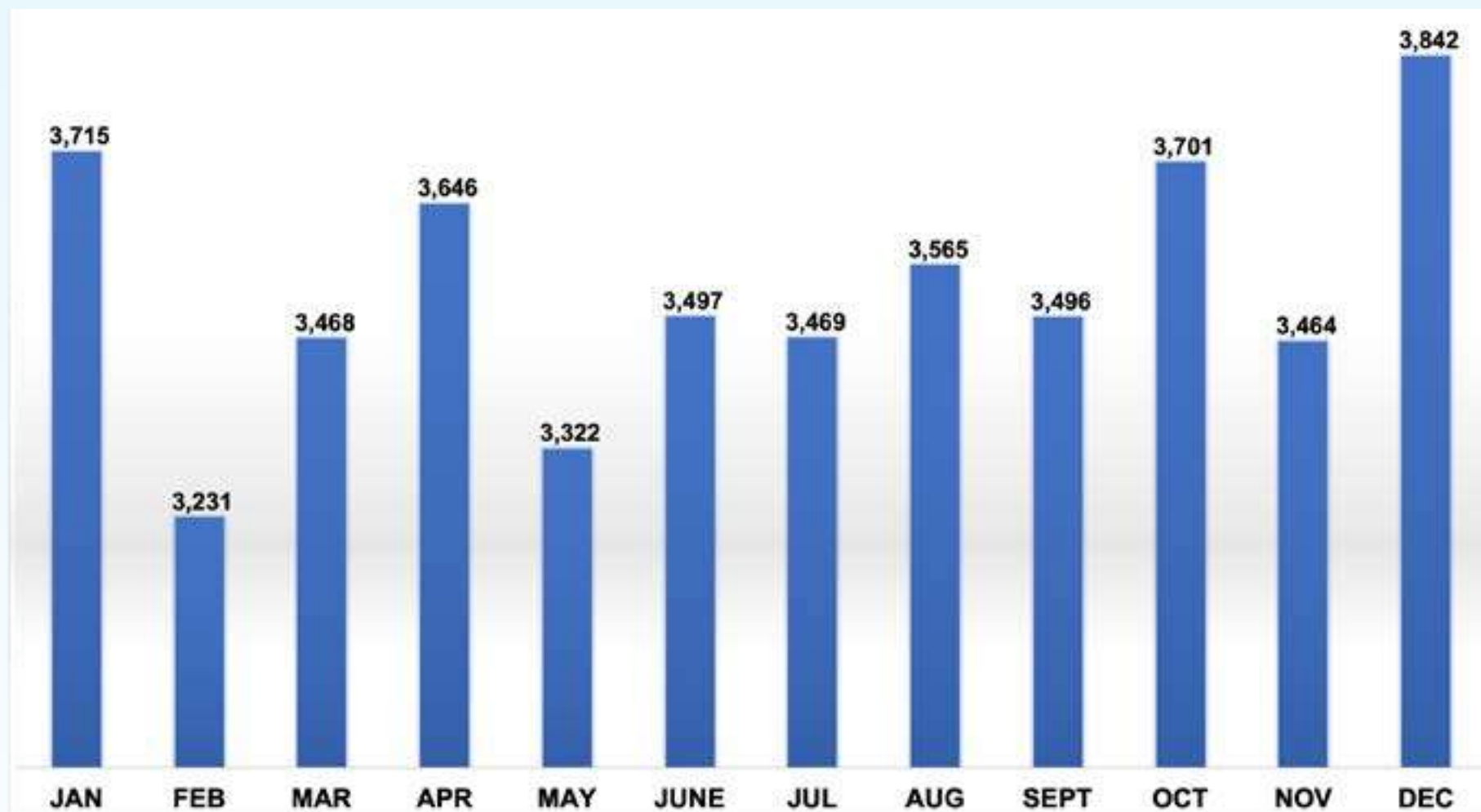
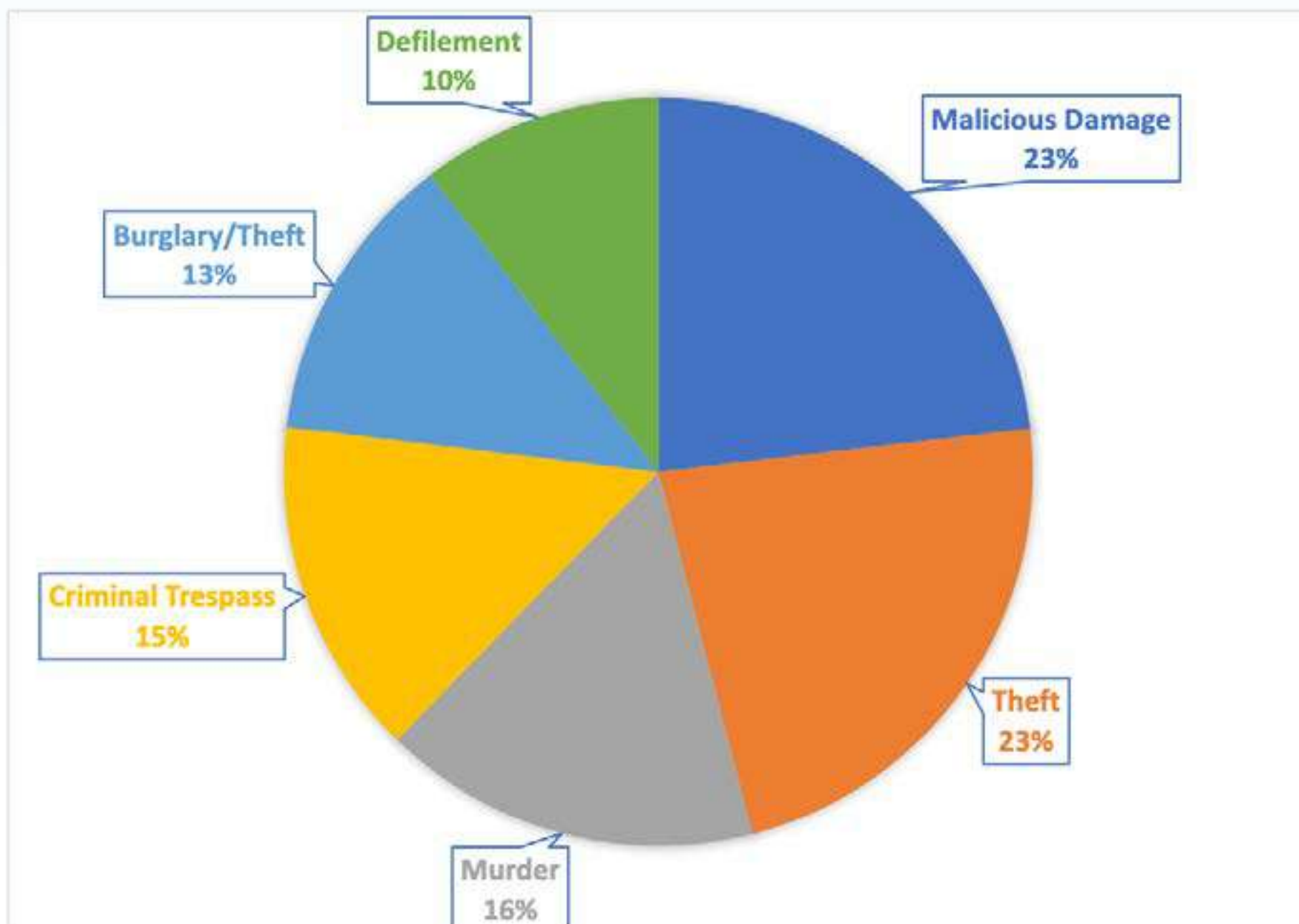


Figure 85: Most Processed Crime Scenes

Figure 86: Forensic Case Backlog per Department

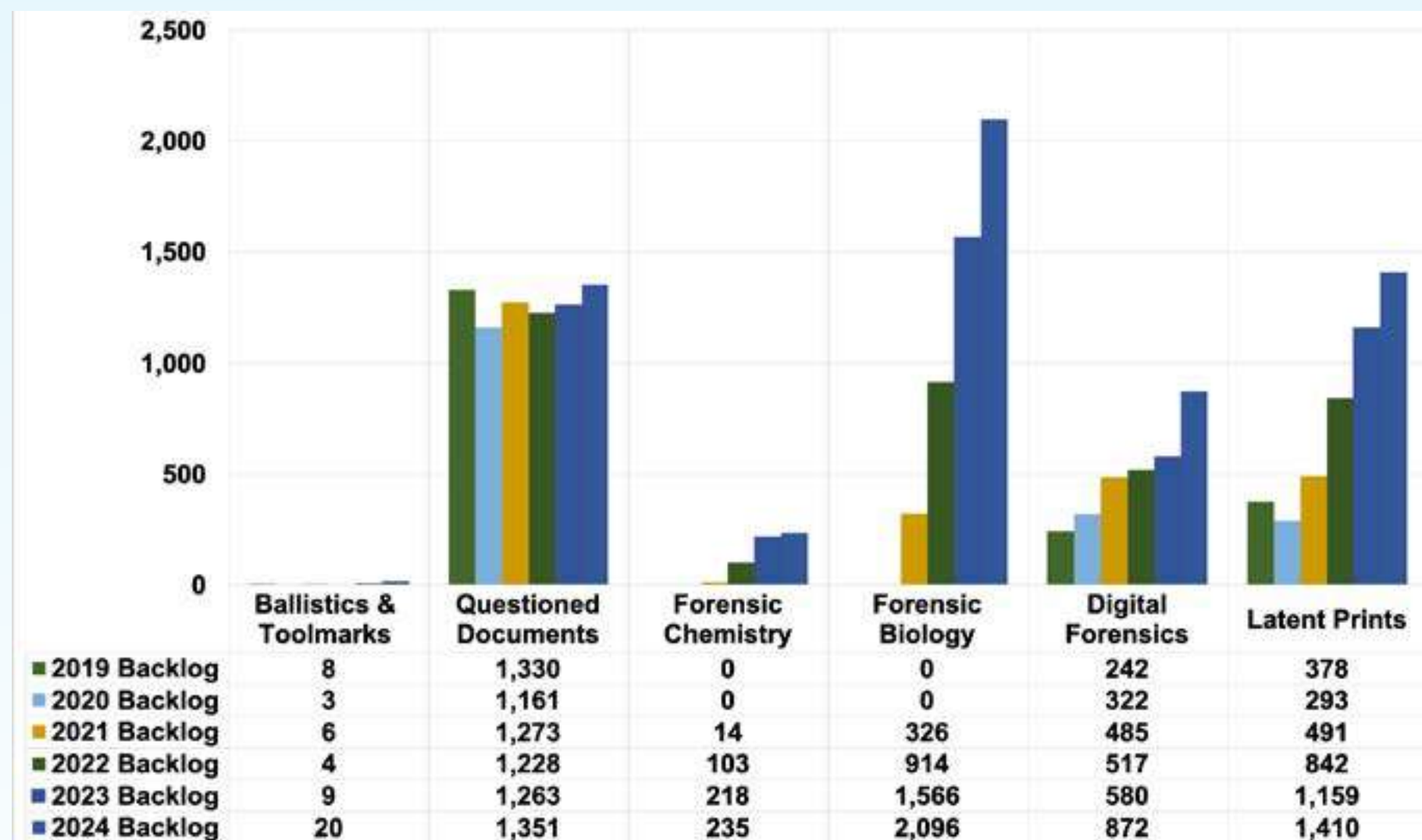
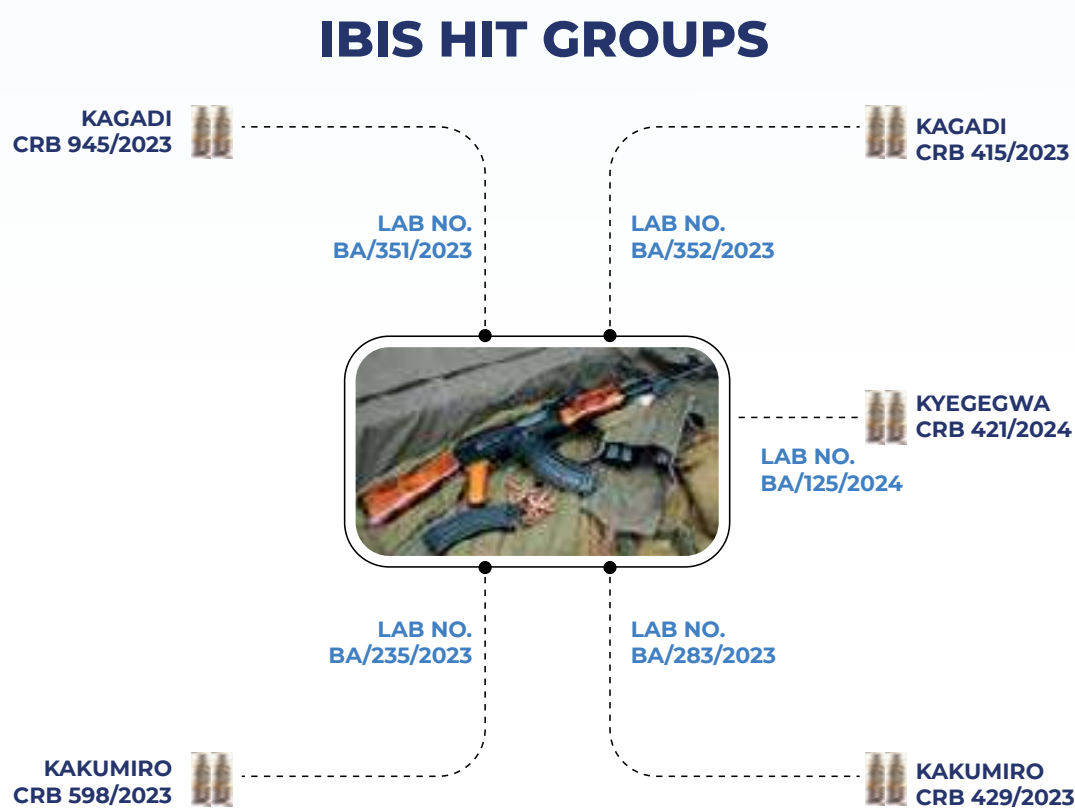


Figure 87: Schematic Representation of the Several Firearm Crimes in Kyegegwa, Kagadi and Kakumiro Linked to a Rifle Recovered in Kagadi

CHAPTER SEVEN

7.0 CANINE

Uganda Police Canine Unit is a specialised Unit of Force that works hand in hand with other Departments of Police to prevent, Detect and Investigate crime. The Unit also gives support functions to the anti-narcotics Department by providing narcotics detection dogs at Entebbe International Airport and other border points with Explosive Detection Dogs to the Directorate of Counter Terrorism. Since 2010, the Unit undertook an ambitious expansion program to ensure that every Police Station around the Country has at least two (02) Sniffer Dogs. This expansion was achieved through Operationalisation of a Breeding and Training programme at Nagalama.

8.1 Cross Border Drug Trafficking

INTERPOL intercepted drug traffickers in **07** occasions in 2024. This included **02** cases of cocaine, **02** Methamphetamine, and **01** case of Opium. **08** suspects (**05** males and **03** females) were arrested, charged to Court where **04** suspects were sentenced to a fine between **10–20** million, **01** case was put away while **01** case is still pending in court.



8.2 Cross Border Motor Vehicle Theft

54 cases of cross border Motor Vehicle theft were handled. This involved theft of **48** motor vehicles, **05** Motorcycles and **01** tricycle. Out the stolen vehicles, **21** were recovered, all in Uganda.

CHAPTER NINE

9.0 COMMUNITY POLICING

Targeted community policing activities were conducted in some of the crime-prone regions of KMP North, KMP South, KMP East, Greater Masaka, North Kyoga, Rwizi, Aswa East, Busoga East, West Nile and North West Nile in the Districts/Divisions of Kalungu, Masaka, Lira, Oyam, Kole, Mbarara, Ntungamo, Bwizibwera District Ibanda, Kazo, Kitgum, Pader, Agago, Bugiri, and Bidi bidi, Rhino, Imvepi, Palorinya, Lobule and Panyadoli refugee settlements. The sensitisation programme was attended by **203,502** participants, including **91,312** females and **112,190** males.

Through the sub-county policing model, community liaison officers (CLOs) were recruited, trained and deployed at all sub-counties to conduct community policing at the local levels. The same approach will continuously be adopted and rolled out to all regions.

Police officers in various specialised units were guided and mentored on ideological clarity, conviction and police professional ethics in Entebbe, Nsambya, Fire Brigade, Naguru and Ntinda Barracks communities. **505** personnel were in attendance with **150** female and **356** male respectively. Ideological Baraza's were also rejuvenated in the specialised units of KMP specifically VIPPU CT and Marines. **556** police personnel were in attendance during these Barraza's.

Barracks Action Teams were established and oriented to handle all issues involving spouses and families of police officers resident in the barracks. These teams were established in Naguru, Kireka, Ntinda, Entebbe, Tororo, Busia, Bugiri, Iganga, Kamuli, Jinja, Hoima, Masindi and Mbale respectively. A total of **150** members of the team were established and oriented to enhance indigenous methods of conflict Management to promote cohesiveness in the Police personnel residences.

Alongside the Teams were psycho-social clinics conducted in Kwen, Kapchorwa, Busia, Mbale, Kamuli, Tororo and Naguru, Kireka and Ntinda Barracks targeting spouses of police personnel. **700** spouses of police officers were sensitised in Positive Parenting and Mobilised to form Income generating groups to contribute to household income.

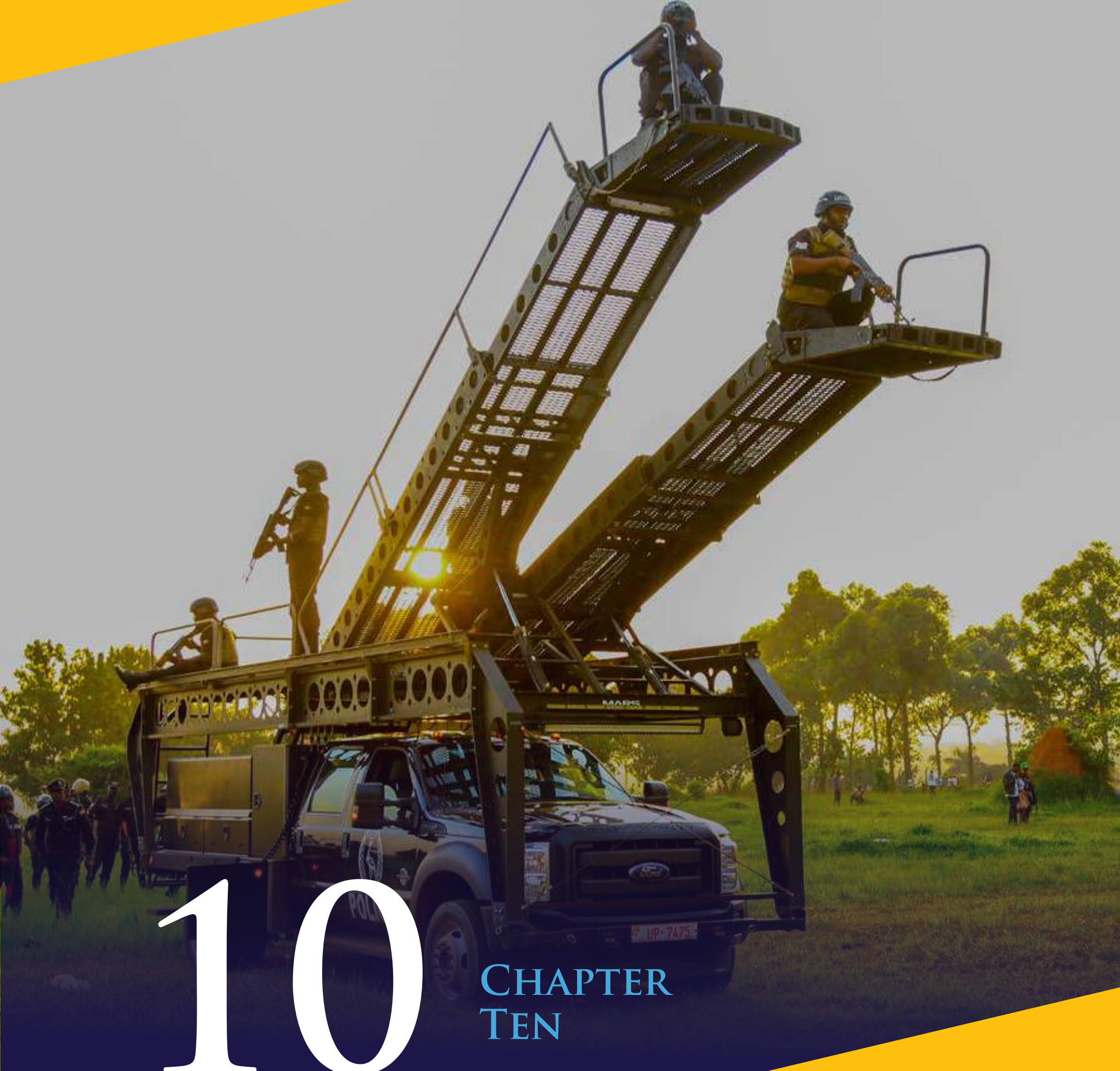


Child and Family Protection

CHAPTER TEN

10.0 STRATEGIES FOR ENHANCED IMPLEMENTATION & CRIME PREVENTION

10.1 Crime Prevention

Crime is a symptom of failures in society which manifest themselves through unemployment, moral decadence, juvenile/youth delinquency, institutional failures across society and feeling of exclusion. A sustainable reduction of crime in society shall therefore require effort by all stakeholders to address the identified systematic failures. The UPF is going to contribute towards the cause of reducing crime in society through the following broad strategies.



Implementation of the Police Sub-county Model

The Police Sub-County Model is a policing strategy that emphasises community-based policing, where police services are decentralised and tailored to meet the specific needs of each sub-county. Its aimed at; improving community engagement, enhancing crime prevention, enabling quick response to emergencies, increased accessibility to policing services, improved intelligence gathering geared towards reducing crime rates. In order to fulfil the directive by H.E. The President of The Republic of Uganda, deployment of Police Officers per Sub-County have so far been fulfilled in thirteen (13) Policing Regions of; North Western Region, Kiira Region, Rwizi, North Kyoga, Wamala, Rwenzori East, Kidepo, Savannah, Sipi and Aswa West were Police Officers have been deployed in all the sub-counties of these Regions. The major goal is to cover the entire country.

Ensuring institutional functionality

UPF is in the process of reviewing its doctrine, posture, practices, procedures to ensure that its level of functionality meets public expectation. Key among these reforms is the reorganisation of deployment of resources based on the sub-county policing model that shall ensure existence of basic capacity to counter crime in each of the sub-counties. This is to be accompanied by digitisation. An efficient and properly functioning Police force shall serve as a deterrence to crime in society since it increases the likelihood of getting caught.

Community Policing

This does not only enhance the functionality of the Police force but also empowers the community to identify and report criminal activity in addition to supporting and monitoring the work of law enforcement agencies leading to a reduction in crime.

Digitisation

Automation of processes will improve efficiency across the UPF. This is to start with the digitisation of the investigation process right from when a crime is reported to when a convict has completed service of a sentence. It shall ease reporting, detection, tracking, supervision, follow-up and analysis of crime which will improve both crime prevention and investigation besides saving institutional resources that can then be applied elsewhere.

Recruitment of more detectives

The detective case load stands at **1** detective to **43** cases which is high compared to the UN recommended ratio of **1** detective to **12** cases which affects both the quality and speed of investigations. To mitigate this, more detectives are to be recruited into the CID as the UPF strength grows. This recruitment shall also cover specialists such as pathologists, ballistics experts, handwriting experts and cyber analysts.

Gaps in other agencies in the justice chain

Gaps in the justice chain affect the successful and timely disposal of investigations. This mainly stems from inadequate numbers and inefficient systems and procedures. The UPF will continue to collaborate with key stakeholders in the justice chain to enhance prosecution-guided investigations.

Skilling

Crime is very dynamic. Training of detectives therefore needs to be continuous so as to stay ahead of the criminals. This should be in addition to the basic training required for all personnel involved in the management of crime. Detectives shall also be trained in the use and maintenance of scientific aids in addition to mindset and attitude change.



Tooling

The force is devising means to make available all the basic forms and books key to the conduct of inquiries. It also intends to provide specialised investigative equipment such as CARBIS and IBIS in addition to other basic equipment such as audio/video recorders, spy cameras, motor vehicles, computers and filing cabinets.

Review and documentation of procedures

In order to address the various gaps in the system and to accommodate many of the innovations adopted, the UPF will undertake a review of all practices and procedures to ensure compliance/compatibility. Good practices are to be documented in procedure manuals. This will facilitate our continued fight against corruption tendencies in the Force.

Better management of exhibits

The manner in which exhibits are presently managed adversely affects inquiries and the quality of evidence tendered in Court. In addition to development of manuals on exhibit management, the force is establishing exhibit yards at the regional level so as to ensure that the integrity of exhibits is not compromised.

Enhanced application of science in investigations

UPF is continually integrating the use of science in investigations to support traditional methods of relying on witnesses and confessions. The scientific tools include CCTV cameras, application of forensic science, canine, telephone tracking equipment etc. The plan is to have these widely available across the country fully manned by personnel who can exploit them maximumly.

Continued emphasis of Prosecution led investigations

Prosecution led investigations should result in more focused inquiries and hence efficiency and better evidence. Collaboration with the Office of the DPP, Auditor General, Attorney General, IGG, Judiciary, Prisons, and other key stakeholders in the justice sector shall be enhanced to improve performance.

Improvement of welfare

It goes without saying that good welfare arrangements motivate personnel, while a motivated officer is more productive. The UPF intends to provide a decent working environment, decent accommodation, reasonable remuneration, basic medical care, education for children of personnel, psycho – social support, enhancement of family income among others all aimed at raising personnel morale.

Budget

To be able to achieve all the above, financial resources are required. The finances presently provided to the UPF are inadequate. The UPF therefore is going to continue to engage and lobby all stakeholders both within and outside government to increase allocation of resources to the force.
